HSHS St. Clare Memorial Hospital officially marked its 100th anniversary in 2021, but due to the COVID-19 pandemic is celebrating the milestone with community events this year.

Formerly named Oconto Falls City Hospital and Community Memorial Hospital, HSHS St. Clare Memorial Hospital has been a part of Oconto Falls, Wis. history since 1921. The hospital was formed as a not-for-profit organization with a board of directors chosen from citizens of the community.

When the hospital opened its doors in 1921 at 125 S. Main Street it was Oconto Falls City Hospital. In

1954, the hospital was named Community Memorial Hospital in honor of military veterans and moved to the former City Hall which was remodeled to accommodate a larger facility with modernized services. In 1972, the current facility at 855 S. Main Street opened its doors, further expanding medical services available to Oconto Falls residents and surrounding communities. In 2014, Community Memorial Hospital joined Hospital Sisters Health System (HSHS) and became HSHS St. Clare Memorial Hospital.

A certified critical access rural health hospital, HSHS St. Clare Memorial Hospital offers 24-hour emergency care and a variety of other services at 855 S. Main St. in Oconto Falls. It also operates five rural health clinics in partnership with Prevea Health. This year, HSHS St. Clare Memorial Hospital was named a Top 100 Critical Access Hospital in the U.S. by The Chartis Center for Rural Health.

Greg and Kathy Jones named parade marshals

May 30 parade is climax of four-day Oconto Falls Memorial Day Celebration

Greg Jones says there's something special about Oconto Falls.

"I think we've seen the community at its hardest times but also at its best times," Jones said. "People in Oconto Falls for the most part are very good at attending funerals for others, especially after they've been touched by what a funeral means. Everybody shows up — it's good for the families to have that community support."

Now Greg and Kathy Jones are finding out that they are supported by the community, too. They have been named grand marshals of the 2022 Oconto Falls Memorial Day Parade and will ride the parade route in style on May 30.

"I never imagined we would be considered for something like this. It's just an unbelievable honor," said Greg Jones.

"We're touched," his wife added. "It's humbling."

"People have been coming up to us, very excited for us and happy for us," Greg Jones said. "I guess you never realize how many people you touch."

The couple grew up in Reedsville in Manitowoc County, where they were high school sweethearts. Greg went to mortuary school while Kathy was studying radiology at Bellin College of Nursing. Greg came to Oconto Falls in 1979 as perhaps the youngest funeral home manager in Wisconsin at age 22.

He took a job working for Bud Soulek, who also owned funeral homes in Suring, Lena and Sturgeon Bay. Kathy got a job with Bellin Health, and they were married a year later.

"The reason I came here was simply to get experience. I never imagined staying," Greg said. "But we fell in love with the community and the people here. For a small city, it's a very unique town. I don't think I've met anybody who's come through these doors who was born and raised here who wasn't proud to call Oconto Falls home. I don't know many towns that can say that."

Many Oconto Falls natives have gone on to do "incredible things in the world," he added.

They bought the Oconto Falls business from Soulek, and it became Jones Funeral Service on Jan. 1, 1985.

They lived upstairs at 107 S. Franklin St. for 17 years, raising three children until purchasing a home on

the outskirts of the city in 1999.

"The third child was a boy, though, and he was too loud to be upstairs anymore," Kathy laughed. "They just looked at this as a big house, that's really all that is."

With the added responsibilities of a second property, Kathy joined her husband in the business at that time, and she now is involved with every aspect of the service except for preparing the remains.

They are unusual in the mortuary business, where families often operate a funeral home for generations. They are the first in their families to feel called into the business, and their grown children — Sarah (Dan) Schuetz, Elizabeth (Ryan) Debauche and Philip Jones — are pursuing their own careers.

"They've seen the sacrifices that we've had to make. They saw that Mom went on a lot of things alone because Dad had to stay back and work," Greg said. "The most beautiful blessing in all of this is" — and he paused

to collect his emotions as he looked at Kathy — "Never once has this lady ever said, 'Why are you spending more time with that Smith family than you are with your own family?' Because she knew that I wanted to be with them, but if [the grieving family] needed me, that was OK. There's nobody else I know that would do that. That is a blessing that is immeasurable to me."

Kathy said she grew up on a dairy farm, where the work was 24/7. So being the wife of an always-on-call funeral director didn't seem such a stretch.

Did she realize what she was signing up for?

"I fell in love with him before any of that," she said.

Among other contributions to the community, the Joneses have a special relationship with local veterans groups, especially American Legion Post 302.

The group poured concrete and installed the flagpole for the funeral

home, and they have sponsoring flag holders at the Oconto Falls cemetery and provided the portable public address system used at the annual Memorial Day ceremony, where the names are read of veterans who have passed in the previous 12 months.

After more than 40 years, Greg said he is still moved by the military honors that are provided for veterans at their funerals.

"You see how much it means to the family, and it makes you proud to be an American," he said.

The 10 a.m. memorial ceremony at Woodlawn Cemetery and 12:30 p.m. parade are the centerpieces of the May 30 celebration, which culminates the traditional four-day festival May 27-30 in Oconto Falls. Other highlights include a Christman Amusements carnival and a softball tournament all weekend, the Dash O.F. Color run at 9 a.m. May 28, fireworks at dusk May 28 and a car show 9 a.m. to 3 p.m. May 29.

Sharon L. Schaal

So God made a caregiver...

How do you pay tribute to the best, most selfless mother, grandmother and great-grandmother in the world? These few words are hardly adequate, but we're limited, so here we go.

Sharon Lee Schaal, nee Page, born on July 19, 1944, went to meet Jesus on Saturday, May 7, 2022, at the age of 77.

Knowing Mom, she probably took a bag of candy with her to hand out, just as she often did at her grandkids' games.

Sharon was born in Green Bay to Oliver and Eyla (Mattox) Page. She and her siblings enjoyed playing in Duck Creek as youngsters. Their dad died while the kids were young, leaving their mom in dire straits, with few means to support herself and eight children. The county took the kids and placed them in various foster homes. Sharon and her sister closest in age, Sylvia, went to live with Chester and Irene Raaths in rural Cecil when Sharon was about 11 years old. Chester and Irene were loving foster parents to the girls.

Sharon graduated from Gillett High School, and then went on to Bellin College of Nursing, where she discovered her true calling, which was caring for others.

While attending Bellin College, Sharon began dating and then eloped with David Schaal, a farmer from Gillett. After returning to college and signing a test with her married name, Sharon was called into the dean's office, where she was asked why she had signed her test with the last name of "Schaal." She told the dean she had gotten married, and her last name was now Schaal.

This was a real dilemma for the college, as they had a strict policy against allowing married students to attend the school, but Sharon was a good student, and the school didn't really want to kick her out of college simply for being married. So, the school changed the rule, and that is how Sharon Schaal became the first ever married student to



graduate from Bellin College of Nursing.

Sharon worked as a nurse until she and Dave started a family at their farm in Spruce. After the barn burned

down, they moved to the family farm in Gillett, where they spent the rest of their lives. Sharon supported Dave in his farming endeavors by holding down the fort at home, faithfully and uncomplainingly, as he worked long hours to grow the farm and support the family.

Holding and caring for babies came so naturally to Sharon it must have seemed like breathing to her. Never was there a woman more nurturing, loving, patient and steadfast than Mom. She spent her entire life putting others before herself. Humility and selflessness were the essence of Mom. Her home was a welcome place for generations of kids. She was never happier than when her home was filled with kids, grandkids, great-grandkids, nieces, nephews and other family and friends.

Upon entering her home, Sharon's guests would immediately be offered something to eat. Even if the offer was politely declined, she would often ignore that and proceed to heat up a dish of food or place some sort of food or sweets in front of them. She was what we lovingly referred to as a "food pusher." It was just one way she demonstrated her love.

As much as she loved feeding her loved ones, she had her limits. One time, after feeding the whole family and farm hands breakfast, Dad said it was time to get back outside and get some work done. One of the boys said he hadn't even gotten his second waffle yet. Mom, thinking he had just dropped the F-bomb, very uncharacteristically smacked him so hard he flew off his chair. With the rest of us looking on

in shock, and our brother holding up two fingers to indicate he had only said the word "second," Mom realized her mistake. She felt terrible. We enjoyed ribbing Mom for years about the incident.

If a baby came into Mom's view, it didn't matter who that baby belonged to, or whether or not she knew the parents, she usually made a beeline straight to the baby. To our knowledge, Mom never actually wrestled a baby from its mother's arms, but we can't say with 100% certainty that she did not. It became a running joke in the family that if you wanted to hold a new baby, you had to get to it before Mom did. She just couldn't help herself when it came to babies.

That love for babies was a literal blessing to hundreds, if not thousands, of babies born in Northeast Wisconsin, for Sharon worked as a labor and delivery nurse for 30-plus years in area hospitals. The majority of her career was spent at Oconto Falls, Shawano and Green Bay (St. Mary's) hospitals.

Being a true night owl, Sharon was happy to work nights, which is what she did for her entire career, so that her days could be spent attending her kids' and grandkids' sporting and other extracurricular events. She never missed a sporting event, no matter how exhausted she might have been from working the night before.

Sharon and Dave made a great team raising their five kids. So great, in fact, that it only seemed natural for them to take in their nephew, Dallas, after his mom, Sharon's sister, Sylvia, passed away when Dallas was 9. They treated Dallas as their own, and when asked how many children they had, they always said they had six.

Sharon was also a loving aunt to her nieces and nephews, especially to Ben and Patti's seven kids, who grew up right next door on the farm. Aunt Sharon's door was always open to them, and she truly loved them as part of her immediate, nuclear family.

Mom not only nurtured babies, she nurtured her siblings, caring for many as they suffered through bouts of cancer. Notably, she nursed her sister, Shirley, back to health, feeding her literally with a baby spoon until she could start taking more food after a particularly close call. She also cared for Shirley until her death this past January, despite her own health concerns, after Shirley suffered a stroke and became incapacitated.

Left behind to try to fill her impossibly big shoes are her children, Brad (Julie), Tom (Janelle), Tammy (Pete), Bret (Lisa), Ben (Michelle) and Dallas (Michelle).

The void left in the hearts of her grandchildren may never be filled, though each of them knows how much their grandma loved them. Those adoring grandkids are Justin (Angela), Jeremy, Stephanie (Jake), Shannon (Cameron), Sammy (Tyler), Brett (Cindy), Kyla (Jordan), Nicole, Caleb, Colton, Baldwin, Elijah, Kaitlyn (Taylor), Karissa (Brice), Jordyn, Jensyn (Tess), Sylvia, Kasey and Lily.

She also leaves behind several great-grandchildren, including Josalyn, Madalyn, Lextin, Tessalyn, Gracie, Oaklyn, Boone, Wylee, Lara, Conor, Kenley, Dean, Hannah and Raelynn.

In addition, Sharon is survived by her sister and brother-in-law, Lou and Mel Vandenberg; brother-in-law and sister-in-law, Ben and Patti Schaal; and numerous nieces and nephews.

Welcoming Sharon in heaven were her husband of nearly 55 years, Dave; grandson, Wyatt; and great-granddaughter, Jalyn.

Also preceding her in death were her parents, foster parents and her siblings and siblings-in-law, Barb and Mel Nylund, Shirley Martin, Sylvia Page, LaDonna Knapstein, Allen Page and Myron Page.

Wilber gets 5.5 years for hurting father, nephew

Keshena man expected to leave reservation after prison term finished

A Keshena man, sentenced Friday to 5½ years in prison for severely injuring his father and a nephew with a utility knife, said he will leave the Menominee Reservation after completing his prison term.

It was Darin K. Wilber Jr.'s second conviction in about 10 years for assault with a dangerous weapon which had left his victims seriously injured.

"This is a serious offense, but one of most tragic things about it, you attacked your own father and a nephew. You called (your father) your best friend, who taught you

to hunt and fish, and you attacked him with a box knife and cut him up pretty badly," District Judge William Griesbach said during the Zoom sentencing hearing. "When a nephew comes to help him, he gets cut up, too."

In 2011, Wilber was sentenced to five years in prison for beating a man with a baton and stabbing him with a steak knife after "drinking a significant amount of alcohol," according to court records.

After prison, Wilber was employed at a casino as a housekeeper and received awards for his work, but he returned to substance abuse — this time methamphetamine and alcohol, his attorney, Krista Halla-Valdes, wrote the court.

Last November, Wilber argued with his father about having to pay rent and left to go drinking and use methamphetamines. He returned drunk and high to his father's house, on Lyons Road in Keshena, and fought with his father when he saw that his things were packed up and some items were missing.

The fight became physical, and Wilber slashed his father with a utility knife. When his nephew intervened and hit Wilber with a wooden table leg, Wilber slashed him, too, according to court documents.

Wilber was arrested and taken into custody. His father and nephew were transported to ThedaCare Medical Center in Shawano. Wilber's nephew received 63 stitches to close wounds that exposed tendon and nerve fiber in his upper arm. He was referred to a shoulder specialist in Appleton for further treatment.

Wilber's father received 60 sutures to close deep laceration un-

der his right rib cage, left arm and shoulder and his right hand.

Wilber pleaded guilty in February to assault with a dangerous weapon and faced a sentence from an advisory guideline range of 41 to 51 months in prison.

Halla-Valdes didn't oppose a sentence within the guideline range, saying that Wilber knows he will serve some prison time and, afterward, leaving the reservation may be the best thing for him.

"He has struggled on the reservation with its lack of transportation and work. And, he's known there. He was always involved with people using alcohol and drugs. He needs to leave that area, and that's his plan," she said.

Wilber, 36, agreed that he would do better away from the reservation.

"I'm at the point in my life where I want to do better. I want to learn Spanish and sign language and become a productive member of society," he told the judge.

Griesbach said that time was running out for Wilber to grow up and stay away from drugs and alcohol, which he has proven that he can't handle.

Griesbach adopted Assistant U.S. Attorney Andrew Maier's recommendation of a sentence above the guidelines which arguably don't reflect the number of people injured and the seriousness of their injuries.

The judge said an even longer sentence could be imposed but was hopeful that the "fright or shame" of Wilber attacking his own father and nephew will matter to him.

Wilber is currently in custody in the Brown County Jail, awaiting a transfer to a federal prison.

Woman files writ against Shawano County

She claims board of adjustment setting poor precedent

One local woman has filed a writ of certiorari against the Shawano County Board of Adjustment.

A writ of certiorari is a request for a higher up board to review the judgement of a case.

Carney Garcia, who recently reported violations to Shawano County regarding shared property, said that the Shawano County Planning and Development committee has stopped putting their situation on the agenda for their meetings. Garcia's complaint came from the committee discussing the violations without letting them know that they were on the agenda. Her situation was discussed under "Discuss Any Operational Issues Within the Department As Needed." She said that was too vague.

Garcia has a cottage on Washington Lake and shares 200 feet of lake frontage with 15 other home owners. The initial violation was that two homeowners built into the shared lot without pulling permits and using 2-foot step backs, as opposed to 25-foot step backs.

"There are more violations that have come up since then," said Garcia. "One of our neighbors built two additions to his house without pulling permits. They are encroaching into our lot."

She also said that sheds were built across the street of the lot and the party who built them did not request a zoning change.

"Those sheds would not be allowed," said Garcia.

Garcia said that her neighbor who built a deck that encroaches on the lot would need to get an after-the-fact variance, for the deck to remain there.

"Not pulling a permit for the deck already disqualifies him from an after-the-fact variance because that was a self-imposed hardship," said Garcia.

She said eight of the homeowners on the shared lot showed up to the

Shawano County Board of Adjustment meeting on April 14 to voice their disapproval about the deck encroaching on their shared lot, as the homeowner was attempting to get an after-the-fact variance.

Garcia claimed that when they entered the meeting, board chairman Alan Beyer was aggressive toward the group.

"Right at the beginning of the meeting, he said, if you all talk, I am kicking you out of the meeting," said Garcia.

When her situation was brought up to the board, she said that the board quickly discussed the issue and passed a variance.

"They did not discuss this very much," said Garcia. "They just said that the deck was small and that people at the lake complain a lot. It only took them about three minutes to discuss."

Garcia noted that it was a 3-2 vote in favor of granting the variance.

"The two alternates said that they wanted it on the record that they did not agree with the decision," said Garcia. "Hearing that, I said we are going to appeal."

Even though the meeting ended, Garcia claimed that they were told to leave the meeting for talking.

She said with the writ of certiorari, she is hoping that a judge overturns the board of adjustment's ruling.

"One of my other neighbors pulled permits for an extension to their deck and were not allowed to extend their deck," said Garcia. "So they were saying that it is not fair to us to reward him for not pulling a permit."

Garcia said that allowing this situation to pass opens the county up for problems in the future.

"They set a precedent," said Garcia. "If you are going to punish who did pull permits, what is going to happen after that? We are going to have a lot of after-the-fact variances in the district. All we care about is that the law gets applied fairly."

NEW Media contacted the county's board of adjustment for comment and was told that Beyer would respond; however, a response was not provided by press time.

Shawano summer school has students on waitlist

Three more teachers needed to bring program to full capacity

The Shawano School District's summer school program is expected to bring in more than 600 students in 2022, but there's a question about whether there will be enough staff to provide extended learning from June to July.

A report from Thomas Dechant, Shawano Community Middle School associate principal, revealed that there

were 35 teachers in place for the summer session, but three more need to be found soon, or else the district might have to wait-list some students who signed up. Dechant revealed the information to the Shawano School Board on May 16.

"We appreciate what they do, and I appreciate what they do, because I can't do my job without their support," Dechant said. "The whole balance process is to see how many teachers want to teach, and then at that point, we can open the classes up."

Dechant said he initially had a full slate of teachers, but some had to drop out due to personal reasons, leaving him to try and fill the gaps.

"I am right now juggling, and I let

people know there is a wait," Dechant said. "You may or may not get in. I'm doing everything I can to make it happen."

Dechant said the number of students is split between Hillcrest Primary School and Shawano Community Middle School, which will host classes for grades 3-8. He noted there are about a dozen students on the waiting list.

The news of a waitlist was troubling to board member Mart Grams, a former teacher with the district who worked the summer school program for over 30 years.

"Summer school has always made us money, and quite frankly, we've used money there to pad our budget

elsewhere," Grams said. "We've never ever had a waitlist for kids, so something's not right. As long as there's seats, there's room."

Superintendent Randi Anderson noted that the district has been in the negative with summer school the last two years because of the COVID-19 pandemic.

Grams questioned how there wasn't enough staff to fill the needed positions.

"It used to be that people knocked each other over," he said. "I taught every course in that book, even drama, and I sucked at it. There should never be a limit on children, ever."

Johnson rallies GOP ahead of midterms

Senator wants to see Republicans on every line of ballots in November

U.S. Sen. Ron Johnson hit the Golden Sands Golf Course on May 15 to rally the Shawano County Republican Party during its Lincoln Reagan Day Dinner and encourage conservatives to be out in force for the mid-term elections.

Johnson told more than 200 people in attendance about how a cousin went through some family belongings and came across a piece of paper dated from January 1934. It was about the time that his grandfather had passed, and his grandmother went from farm to farm in Minnesota to raise enough money to bury her husband. In all, she received \$12.25, which would equate to about \$320 today, he said.

“To me, that letter — that piece of paper with those names and what those folks did in January 1934 at the depth of the Depression — epitomizes what America is and who Americans are,” Johnson said, generating applause. “Isn’t it true that, in any crisis, Americans come together and unite? Whether it’s a regional tragedy, like in Florida with the hurricanes or the Midwest with the floods and tornadoes or out west with the wildfires, we send truckloads of construction supplies and construction workers to help our fellow citizens rebuild.”

Coming together is what America needs to do again, said the senator, who is running for a third six-year term. Johnson looks at the pandemic that the country has endured for over two years and believes it is as fractured as it has ever been.

“That even includes the Vietnam War protests,” Johnson said. “This country is as divided as it has ever been in my lifetime.”

Johnson noted that President Joe Biden’s inaugural address included a vow to bring America together. A similar claim was made in 2009 by President Barack Obama.

“Then they go about and they do the exact opposite,” Johnson said. “They said they were going to fundamentally transform America. Now we see what fundamental transformation looks like. It’s open borders. It’s 20-year high inflation. It’s record gasoline and energy prices. It’s record crime. Fundamental transformation means they’re fundamentally destroying this country.”

Johnson went on to attack Demo-

crats for pushing a “socialist agenda,” something that he said was front and center during the coronavirus pandemic. He said it was up to Republicans, whom he claimed truly love the United States, to stop it by voting Republicans into every office available in the 2022 elections.

“The left is relentless in growing government and taking away our freedoms,” Johnson said. “During COVID, they couldn’t wait to strike. They think that a crisis is a terrible thing to waste, and they never do.”

Johnson noted that the people who were there at the dinner came because they feel a need to fight for freedom.

“That’s why you’re here on a beautiful day,” Johnson said. “You recognize that freedom is at risk. Freedom is on the ballot.”

The fight Johnson is fighting is the same one that he fought in 2010, he said, noting that the battle for freedom has been the same for over 240 years, whether it is on the battlefield or the ballot box.

“It’s not somebody else’s fight,” Johnson said. “It’s our fight. It is a fight

we absolutely must win.”

He touted his fiscal conservatism, claiming he’s only voted in favor of 10% of the appropriations brought before the Senate during his two terms in office, and most of that was military spending. He noted there have been times where he has objected to just letting freefall spending, one of which he described as a “trillion-dollar boondoggle,” go by.

“I had to go on the floor twice in one day during COVID — which wasn’t popular to do, by the way, but I was the only one to do that. We had a Republican senator, and then two hours later had Bernie Sanders offering a unanimous consent for another round — I think it was the fourth round — of \$1,200 checks,” Johnson said. “I was willing to go down there and object, but then I’m accused of not liking babies.”

Johnson also claimed support for Ukraine as it is fighting for its freedom against Russian invasion and believes that it is important for that support to not waiver.

“You see Russia on the run, and

the worst possible thing would be for Russians to see Americans equivocating in our support for Ukraine,” Johnson said.

Johnson pointed out that he has time to prepare for his campaign because he’s not facing anyone in the primary in August. However, there are several candidates who are, and a number of them — including two running for governor, two for county sheriff and six for the Sixth District Assembly seat being vacated by Gary Tauchen — were there making their pitches.

“We need to make sure we have a Republican on every line in the ballot, and then we have to support them,” Johnson said.

Richard Kucksdorf, county Republican Party chairman, described Johnson as the best senator in the United States for calling out the hypocrisy in Washington, D.C.

“He’s honest. He’s tenacious,” Kucksdorf said. “They just don’t like that.”

Shawano teen leading fight for abortion rights

Protest developed in response to leaked Supreme Court memo on overturning Roe v. Wade

The recently leaked opinion from the U.S. Supreme Court about the potential overturn of Roe v. Wade, the 1973 court decision that paved the way for legal abortion in the United States, has mobilized many in the country, with conservatives pushing to make abortions illegal and liberals seeking to codify the rights furnished by the historic court decision.

The pushback against the Supreme Court opinion had not been visible in the Shawano area. That changed over the weekend as Shawano teen Jaida Hill brought her new group, the Shawano She Devils, to Main Street on May 15 for a protest of the opinion and possible court decision, deciding that the time for being silent is over.

"I didn't see anyone else willing to put themselves out there for this cause and be open about their beliefs the way that I believe members of this group are," Hill said in an interview before the protest. "I personally think that any woman or man was capable of deciding to lead a charge regarding women's abortion's rights, but I think that as I have an interest in a political career path, I wanted to make it known that this is a matter I would intend to take seriously."

Hill, who donned a costume out of "The Handmaid's Tale" for the protest, said she was dismayed that it took so long to get local attention to the issue of abortion rights, noting that local reaction to the Black Lives Matter movement was fairly immediate.

"I saw the city of Shawano come together in regards to the wake of the Black Lives Matter Movement, but I fear people are not as willing to defend the women of Shawano as they were the vulnerable people of color," Hill said. "While those are two very different issues, these are groups of people entitled to their rights and medical safety and should not be vulnerable to any forms of discrimination because of personal decisions."

Overturning Roe v. Wade would not only impact abortion rights, in Hill's view. She feels it would be the first domino in the stripping of other rights, as well.

"I believe no matter your location or income, you deserve access to health care without all of the ill-advised political interference and opinions," Hill said. "Congress must take action to protect and increase abortion access. Lawmakers and medical providers must ensure people can make health care decisions of their own."

In Wisconsin, the overturning of Roe v. Wade would reignite an 1849 law the state has that bans all abortions except if needed to save the mother's life, and even then, two other people must sign off on the action. A final decision from the U.S. Supreme Court is not expected until next month, but Hill feels it's important to take action now to support women and their ability to choose.

"This opens a gateway to sexual assault survivors and parenting rules or standards," Hill said. "This is also extensive to the dehumanization of Planned Parenthood. They provide STD-testing, pregnancy testing, cancer screenings, birth control, family services, counseling, adoption and foster advising and much more. People opposing abortion are attack-

ing the preventive at the source, and it needs to end."

The name "Shawano She Devils" was something Hill came up with to grab people's attention and focus them on the issue. However, as a student at Wolf River Lutheran High School, she realizes the name and her cause are at odds with churches and other religious organizations.

"This is not an anti-Christian organization. We are not here to attack people or pick commentary fights," Hill said. "I do not want to offend anyone or make a target of myself. This issue is horribly divisive, and I am well aware of that. We want to widen perspectives and open the eyes of people in a small town. Shawano may not make a large difference, but there are thousands of Shawanos, thousands of small towns. Everyone is going to have to make a difference and play their part."

Hill said the "devil" portion of the name was meant to just show disagreement, not invoke it as a mascot for the cause.

"The devil portion of the name was just to show an opposing force that everyone views as despicable,"

she said. "We understand the controversy behind abortion is very widespread. We have no intention to lionize or embolden anti-religion or make religious groups feel uncomfortable."

The protest on May 15 only brought out two people, including Hill, but she said she planned to organize other rallies with more advanced notice and might choose another site besides Main Street. She noted that despite the smallness of the protest, some people came up and provided support.

Hill said she plans to continue protesting the issue in Shawano but also plans to protest with others in Appleton. She hopes the protests will make people see different views on the abortion issue and understand what it means to people.

"Women will feel so emboldened speaking about this issue, they would no longer fear walking alone in the dead of the night, if it were to raise awareness to this issue, which emphasizes how scary this must be to some women," Hill said.

Johnson rallies GOP ahead of midterms

Senator wants to see Republicans on every line of ballots in November

U.S. Sen. Ron Johnson hit the Golden Sands Golf Course on May 15 to rally the Shawano County Republican Party during its Lincoln Reagan Day Dinner and encourage conservatives to be out in force for the mid-term elections.

Johnson told more than 200 people in attendance about how a cousin went through some family belongings and came across a piece of paper dated from January 1934. It was about the time that his grandfather had passed, and his grandmother went from farm to farm in Minnesota to raise enough money to bury her husband. In all, she received \$12.25, which would equate to about \$320 today, he said.

“To me, that letter — that piece of paper with those names and what those folks did in January 1934 at the depth of the Depression — epitomizes what America is and who Americans are,” Johnson said, generating applause. “Isn’t it true that, in any crisis, Americans come together and unite? Whether it’s a regional tragedy, like in Florida with the hurricanes or the Midwest with the floods and tornadoes or out west with the wildfires, we send truckloads of construction supplies and construction workers to help our fellow citizens rebuild.”

Coming together is what America needs to do again, said the senator, who is running for a third six-year term. Johnson looks at the pandemic that the country has endured for over two years and believes it is as fractured as it has ever been.

“That even includes the Vietnam War protests,” Johnson said. “This country is as divided as it has ever been in my lifetime.”

Johnson noted that President Joe Biden’s inaugural address included a vow to bring America together. A similar claim was made in 2009 by President Barack Obama.

“Then they go about and they do the exact opposite,” Johnson said. “They said they were going to fundamentally transform America. Now we see what fundamental transformation looks like. It’s open borders. It’s 20-year high inflation. It’s record gasoline and energy prices. It’s record crime. Fundamental transformation means they’re fundamentally destroying this country.”

Johnson went on to attack Demo-

crats for pushing a “socialist agenda,” something that he said was front and center during the coronavirus pandemic. He said it was up to Republicans, whom he claimed truly love the United States, to stop it by voting Republicans into every office available in the 2022 elections.

“The left is relentless in growing government and taking away our freedoms,” Johnson said. “During COVID, they couldn’t wait to strike. They think that a crisis is a terrible thing to waste, and they never do.”

Johnson noted that the people who were there at the dinner came because they feel a need to fight for freedom.

“That’s why you’re here on a beautiful day,” Johnson said. “You recognize that freedom is at risk. Freedom is on the ballot.”

The fight Johnson is fighting is the same one that he fought in 2010, he said, noting that the battle for freedom has been the same for over 240 years, whether it is on the battlefield or the ballot box.

“It’s not somebody else’s fight,” Johnson said. “It’s our fight. It is a fight

we absolutely must win.”

He touted his fiscal conservatism, claiming he’s only voted in favor of 10% of the appropriations brought before the Senate during his two terms in office, and most of that was military spending. He noted there have been times where he has objected to just letting freefall spending, one of which he described as a “trillion-dollar boondoggle,” go by.

“I had to go on the floor twice in one day during COVID — which wasn’t popular to do, by the way, but I was the only one to do that. We had a Republican senator, and then two hours later had Bernie Sanders offering a unanimous consent for another round — I think it was the fourth round — of \$1,200 checks,” Johnson said. “I was willing to go down there and object, but then I’m accused of not liking babies.”

Johnson also claimed support for Ukraine as it is fighting for its freedom against Russian invasion and believes that it is important for that support to not waiver.

“You see Russia on the run, and

the worst possible thing would be for Russians to see Americans equivocating in our support for Ukraine,” Johnson said.

Johnson pointed out that he has time to prepare for his campaign because he’s not facing anyone in the primary in August. However, there are several candidates who are, and a number of them — including two running for governor, two for county sheriff and six for the Sixth District Assembly seat being vacated by Gary Tauchen — were there making their pitches.

“We need to make sure we have a Republican on every line in the ballot, and then we have to support them,” Johnson said.

Richard Kucksdorf, county Republican Party chairman, described Johnson as the best senator in the United States for calling out the hypocrisy in Washington, D.C.

“He’s honest. He’s tenacious,” Kucksdorf said. “They just don’t like that.”

Abandoned dog's owner has much to answer for

The story of a dog found tied to a fire hydrant and abandoned in Green Bay captivated the television news for days recently, with people expressing shock that such a thing happened. The dog was found with a note and a backpack filled with food, treats and toys.

The dog, named Baby Girl, was left on a busy corner, which allowed folks to see that the dog was in trouble much sooner, a safer alternative to being left in the woods or some other middle-of-nowhere location where predators could devour the canine. This allowed the dog to be taken to the humane society by a good Samaritan who waited an hour to see if someone came back for the dog.

The Green Bay Humane Society posted a message on Facebook that it was evident that the owner loved the dog and struggled with medical complications and challenges. I have to disagree with the assertion that the dog was loved, because if it was so loved, it would not be abandoned on a street corner like a piece of trash, and there is a special place in hell for folks who have such a disregard for a life.

There are times when pets can no longer be cared for, I admit that. However, that's why humane societ-

ies exist, to care for the animals that can no longer remain in a home. It would have been kinder to bring the dog directly to a shelter instead of just tying it up to the hydrant and hoping someone cared enough to continue to provide for it.

All too often, animals are treated as disposable items, receiving indifference as they're tossed aside like a used sandwich bag. When you decide to adopt or buy an animal, you take on the responsibility of its care and well-being. Every effort should be made to care for those animals through good times and bad, but if there's no possible way left to continue doing so, there are ways to make sure they are cared for.

Abandoning a dog and tying it to a fire hydrant is not one of them.

This issue hits close to home for me because I adopted a dog many years ago, before I moved to Wisconsin. He'd been abandoned as well, only he was found wandering the streets near the airport of the commu-

nity I was living in. I'd initially agreed to foster him for a time, but I quickly fell in love and adopted him. He made the move with me to Wisconsin and gave me joy for 10 years.

Near the end, he developed diabetes, which soon left him blind and having bladder control issues. It never occurred to me, even with those issues, that I should give up on him. If I'd ever lost my job, I would have made sure he ate before I did. When looking for apartments, places that didn't allow pets were eliminated from consideration, and you'd be surprised how that limited my options when finding a place to live.

Even when I wound up having to be admitted to a hospital two years ago, my first phone call was to make sure family could take care of my dog. If that hadn't been possible, I probably would have left the hospital to return home and care for him, even being in as sorry a shape as I was because, to me, he was family. That's why I can't buy the argument that having medical issues necessitated just dumping the dog on a street corner.

I've seen my fair share of abandoned animals in life. On occasion while growing up, my family would

find puppies — sometimes with their mothers — left in the countryside to fend for themselves. It baffles me how, in a world where people are arguing when a human life has value, that there are some who can devalue the lives of dogs and cats.

I'm happy that Baby Girl has found a new home, with so many people reaching out and indicating they wanted to take her home. It's heartening to see that there are good people in the world who would provide this dog with a safe space for the rest of her days. It doesn't make up for the despicable act of the previous owner, though, and if I had my way, that person would never be responsible for the care of an animal again.

There were better ways to say goodbye to Baby Girl, even with providing food and toys. The happy ending to this story doesn't absolve the prior bad act, and this should teach us all that the decisions we make affect others. If you decide to care for an animal, have a plan. If those plans go awry, have a strategy to make sure it will still be cared for, even if it's not by you.

**Town of How, Oconto County, Wisconsin
Town Clerk and Town Treasurer Appointed**

The Town Board to WIS. Stat. 60.30 (1e) (a), the office of the town clerk and the town treasurer shall be filled by appointment of a majority of the members-elected of the town board.

The term of the office for the appointed positions shall be set by the town board, but may not exceed three (3) years per 60.30 (1e)(c). The town board may re-appoint the officers for additional terms. However, removal by the town board during a given term of office may only be for "cause" as defined under 17.001 and required by 60.30(1e)(f).

This ordinance is subject to approval by the town electors in a referendum, which is hereby called by the Town Board to be held on November 8, 2022 general election. The referendum questions shall be:

"Shall the person holding the office of Town Clerk in the Town of How be appointed by the town board?"

"Shall the person holding the office of Town Treasurer in the Town of How be appointed by the town board?"

The salary of the appointed positions shall be set by the town board and may not be reduced during the term of office.

This ordinance shall be in full force and effect from and after the date of its town board passage, notice after passage per 60.80 and also its referendum approval by the town electors as required by 60.30(1e)(b).

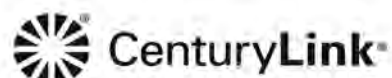

Most flood-damaged Oconto County roads reopen to traffic

Public Health Department warns of dangers from flooded wells

Oconto County Highway Department crews worked through the weekend to patch roads that been washed out when culverts failed during the floods of May 12.

Severe thunderstorms and high winds struck northern Oconto County around sunset May 12, with up to 3 inches of rain that caused flash flooding in several areas.

The county and several towns declared a flood emergency and closed several stretches of road to traffic. The Suring, Gillett, Oconto Falls and Coleman school districts canceled classes May 13, citing road damage across the area.

By the end of the weekend, only three roads remained closed:

- County Roads B and A, from West County Road A to west County Road M, in the Town of Lena;
- County Road A between Buseman Road and County Road G in the Town of Maple Valley;
- Behnke Lane in the Town of Maple Valley.

The county roads are expected to be closed for at least a few weeks. Damage and cost estimates were still being compiled as the waters receded.

An Oconto County sheriff's deputy escaped injury May 12 when the pavement collapsed under the road he was traveling because of floodwaters.

Sheriff Todd Skarban said the deputy was responding to assist with a vehicle that had been struck by a falling tree on Sleeter Road.

The incident occurred around 8:50 p.m. while the deputy was traveling west on County Road A east of Erickson Road in the Town of Maple Valley,

a 4-foot section of culvert pipe," Skarban said. "As the squad drove

over the culvert area, the pavement gave way, causing the squad to crash

into the water and side of the wash-out."

The deputy was able to get out of the squad to safety with his canine partner in tow, Skarban said. A highway department worker also helped the deputy at the scene.

"Mother Nature is not to be trifled with," Skarban said. "I would like to thank our citizens and the media for heeding the warning and staying away from the affected areas."

The Oconto County Public Health Department reminded residents that when a well has been flooded, bacteria and other harmful organisms can make the water unsafe for some time. Individuals with flooded wells should use bottled water, tap water that has been boiled for one minute or water from a well that was not flooded.

The department recommended that anyone with standing water in their yard tests their wells; if well disinfection is needed, a licensed well driller or pump installer should be contacted.

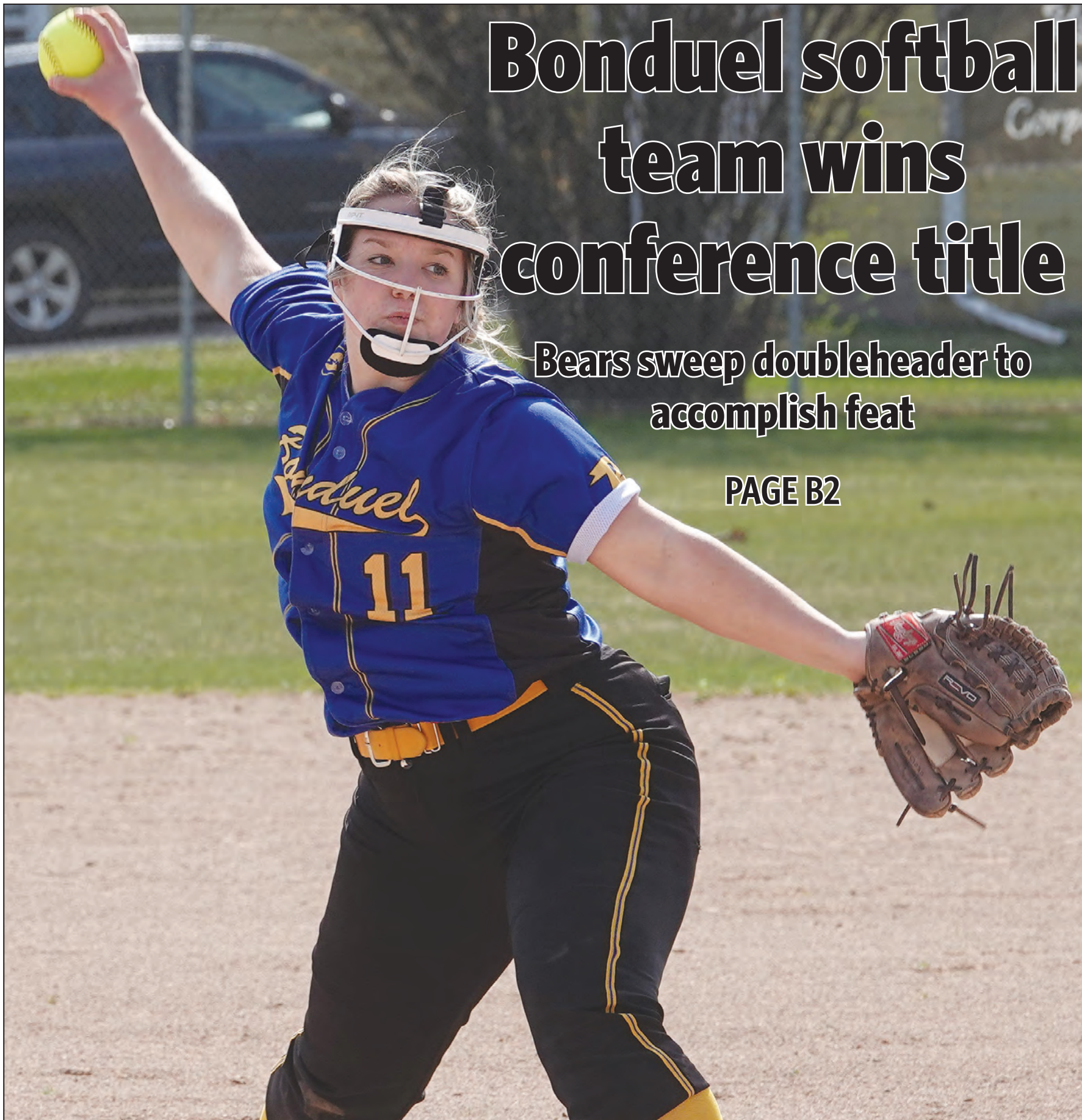

Laugh if you want to, but please laugh

Judd Reminger takes lessons from disastrous performance to create stand-up comedy career

If folks working in the fields of Leopolis hear laughter in the distance, it can only mean one thing: Judd Reminger has come home to visit his family.

Whether they're laughing with him or at him, the stand-up comedian who grew up in rural Shawano County is perfectly fine with that, as long as people are laughing. Constantly churning out jokes that leave audiences gasping for air and falling out of their chairs is no easy task, as Reminger learned over 11 years ago when someone suggested he give comedy a whirl.

"It was always something I wanted to do," Reminger said. "I was in college, and a roommate of mine kind of pushed me towards doing it. We found a comedy competition about an hour away, and it was a competition where, if you bring enough people — it's fan-voted — you become the winning comedian of the night."

Reminger brought enough people to win the popular vote that night. The prize was \$100 and the opportunity to open for a professional comedian at a club in Milwaukee.

"It was my first time doing comedy, and I didn't know much about the art form," Reminger said. "I wrote some jokes and thought I'd tell some jokes that I thought were funny and that my friends thought were funny."

He acknowledged some of the other competitors were probably upset that their humor had been executed better but he wound up winning because he brought enough friends to stuff the ballot box. That tactic would come back to bite Reminger when he opened for the comedian two weeks later.

"I completely bombed," he said. "My friends weren't in the audience. I was very new to the art form, and I just remember there was so much dead noise. After I got off the stage, I went to the back of the room and put my head down. The owner of the club saw me. He put his arm around me and said, 'Hey. You're very new. Don't worry. It happens.'"

Taking the words of wisdom to heart, Reminger stuck it out and continues to perform for metropolitan audiences across southern Wisconsin today. He turned that one-time disastrous performance into a successful full-time career, doing full shows as a

headliner, helping to book other comedians, introducing some of them and working as the producer and showrunner for the West Bend Theater in Milwaukee.

"Pretty much all my weekends are filled with comedy," he said. "I pretty much do it all. I have to put it on my taxes, so that's an official thing."

Reminger is currently living in Milwaukee but still finding time to come home to visit family. He is the son of John and Kay Reminger, the latter being familiar to locals because she writes the "Farm Life From a Farm Wife" column that appears in NEW Media newspapers, as well as the Marion Advertiser.

It was a matter of writing better jokes, practicing more and refining his craft that helped Reminger to avoid more shows where the last words from his mouth were not followed up with laughter and applause. He hadn't intended to go into comedy when he started at Lakeland University, but he said he fell in love with the craft.

"It's still like a rush when you get

on stage," Reminger said. "When you perform in any kind of live performance, the energy you feel from the crowd is unreal. You go to open mics. You go to places where you can try out new jokes and find out whether they were funny."

Reminger noted that, while folks come out on a Saturday night to see a comedian perform, they don't realize that person has been working all week to prepare for the show and figure out which jokes should make the cut and how they flow together.

"I fell in love with that as a young comedian," Reminger said. "That's fun to me."

Reminger said his whole family is a constant source of comedic material, noting that it gives audience a piece of who he is inside. Growing up on a farm is relatable across the Midwest, whether he's performing in Milwaukee or traveling to St. Louis, Missouri.

"I have jokes about about my mom and my dad, my siblings, growing up on a farm. It's fun to do," Reminger said. "Every time I go home, I can grab

another piece."

When asked if he'd ever come back home for a comedy show, Reminger was of two minds about that.

"My mom asked me about that very recently," Reminger said. "When I go back (home), I have rapport already. It's a little bit different than when I'm performing in front of strangers. When I talk about my dad, it's not like he's a character, and they already think, 'Oh, that's him. I know him. I play golf with him.'"

Although Reminger's making a living off of laughter, he still feels there's further to go on the comedy trail, growing his fan base. He dreams of having a television special or being on a show on Netflix, and he aspires to put out a comedy album. He said he plans to keep doing stand-up comedy as long as it's fun.

"I don't think I've even peaked yet," Reminger said. "For me, it just keeps growing and growing. I don't like to look back and think, 'Oh, that was a rejection point.' I just want to keep getting better and having fun with that."

Pulaski students get cooking on national stage

ProStart program gets youth involved with professional food prep

Dahlia Maroszek had never considered pursuing cooking as a career, recalling a disastrous time years ago that she had messed up instant pudding at home.

However, the Pulaski High School student and four of her classmates got the chance to showcase their culinary skills on a national stage as they competed at the national ProStart competition held May 6-9 in Washington, D.C. Making up the rest of the team were Sophia Berg, Angely Lee, Abi Roberts and team manager Brayden Pelot.

The chance to go to the national competition came after Pulaski won the state competition earlier this year. Pulaski was able to compare its food prep skills with other public schools as well as charter schools that are specifically geared toward culinary education. Pulaski did not place at the national contest, according to Liz Moehr, Pulaski culinary arts teacher. The winner at the national level was a public high school from Delaware.

"The National Restaurant Association Education Foundation has a two-year curriculum that students get hands-on experience to get them ready to be in the culinary and hospitality industry," Moehr said in describing the ProStart program. "If students complete both years with 400 hours of work experience, and there's certain competencies they have to get at the workplace, and there's two year-end tests ... they get college credits for a number of different culinary schools across the country."

Among the places nearby accepting ProStart credits are Fox Valley Technical College, Northeast Wisconsin Technical College and University of Wisconsin-Stout, according to Moehr. More than 130,000 students in 1,700 high schools across the United States participate in the ProStart program.

The students were tasked at the national competition with making an appetizer, a main course and a dessert, with only 60 minutes and two butane burners to prepare all three. Pulaski started with a lobster ravioli with sage butter sauce and red pepper

chutney, followed by the main dish of porcini-breaded veal chop served atop stracchino polenta, sauteed broccolini with red peppers and caper gremolata aioli. The dessert was a raspberry tiramisu with coffee pearls.

"It's quite the undertaking," Moehr noted.

Besides prepping the food, the students had to come up with their menu, price out how much it was going to cost to make it and determine the menu price, according to Moehr.

Maroszek said the experience of competing at a national level was "super awesome and super stressful simultaneously." She originally hadn't planned on competing for Pulaski, but when a friend said she was going to try to make the team, she decided it might be worth trying.

"We're small-town Pulaski competing against, like, so many higher-level schools," Maroszek said. "Our fingers were crossed that a public school would take it all."

There were some challenges that the Pulaski ProStart team had to face, including lost materials that threw off the team. But Moehr said that it didn't matter that the team didn't place, as

long as something positive was gained from the experience.

"I couldn't be more proud of them, because they showed that they knew what they were doing," Moehr said. "Their floor judge said they were one of the most poised teams. They just generally looked like they love cooking, and that's what I care about."

While having the skills to prepare difficult dishes does help in a competition like ProStart, Maroszek said teamwork was a key factor in what made the Pulaski team move so far. The team members had not all been friends when they first came together, but they're certainly bonding now.

"We all trust each other enough to be like, 'This person's going to have my back.' We're going to get a little bit funny here, but even then, we're going to be up until 1 a.m. talking for no reason," Maroszek said.

There were over 20 regular three-hour practices prior to the Wisconsin ProStart competition where the students got to refine their dishes, experiment with flavors and more. Moehr noted the students also came during their free periods to practice and even came in a couple of times

when school was not in session.

The constant prepping and refining was a benefit to Pulaski High School teachers, as they got to taste the students' work, according to Moehr.

"We were toying with flavors and seasonings until the very end," Moehr said.

Maroszek got a lot of her culinary skills in school, noting that she wasn't allowed to be in the kitchen much when she was younger.

"I screwed up instant pudding when I was young so bad that no one would eat it," Maroszek said with a laugh. "I enjoyed taking cooking classes in summer school at the middle school, and then the high school had such a broad variety. I took Foods for Life, and it was during COVID, so I didn't actually get to cook here."

The exposure to culinary training has made Maroszek seriously consider going into the restaurant business as a career.

"One of the things I say is that food is the way to someone's heart," Maroszek said. "If I bake cookies, this is my way of introducing myself to you."

FARM LIFE FROM A FARM WIFE

In spring, local farmers bring fields alive

The cow, what a magnificent animal. Not only do they calve to continue the herd but also produce milk and provide a natural fertilizer. This fertilizer is spread on the fields to promote harvest growth in order to feed the animal, and in turn feed people.

Cool temps and above average moisture this spring have delayed fieldwork. Now that the ground temperature has warmed and the fields have dried out, it's time for full steam ahead, with many farmers working around the clock. The roads are full of equipment that may take over half their share of the road. Be patient. Remember, these guys feed the country.

Countless semis full of natural fertilizer (pungent liquid gold) gets pumped onto fields, the country perfume saturating everything. On a still day the aroma hangs in the air and can downright make a person's eyes water. Some farmers use high-powered units which fork the manure directly into the ground while others spread it and then afterward, plow the field, pushing the naturally rich nutrients deep in the soil.

Since selling off our herd of Black Angus and remodeling our existing barn, we've been raising bred cows and heifers for my brother and his two boys. Gutting the barn, free stalls were put in and filled with a fine sand bedding. The outer yard holds a covered feed bunk, readily accommodating 60 cows at any one time. They rent our fields and utilize everything possible. This past year they had planted a field of sorghum, a first for us.

After taking the sorghum off last year, it regrew in the fall, so before plowing it up, a guy came and using a stalk shredder, cut up the regrowth. Afterward, a round baler spit out wrapped bales, which are then used for bedding. After fastening a fork bucket on our skidster, my husband hauled them off the field, storing them in our barn mow.

After they harvested the sorghum on the field next to the barn, they headed for the corn fields down the road. These corn fields have six-inch stubble left from last year's grain harvest. The guy working the stalk shredder goes first with the baler right behind. They move. My husband gathered the covered rounds with the skidster, stacking them on a waiting semi.

In order to snap a picture or two, I was standing on the outer edge of the field watching these fellas work. With wind gusts up to 50 miles per hour that day they must

have thought, "That lady needs to get a life." It was dusty, dirty work but they were both operating in an enclosed cab with a tractor that had back dual wheels taller than me.

I am in awe every spring, how a farmer can make fields come alive, waking them up after a barren winter. The rich, fertile soil gets overturned first with a plow, then disk, then drag. Some farmers direct-seed to cut fuel and equipment costs. Usually, though, the ground is worked up to a supple texture to better receive the seed.

After working up the soil we

pick stones. Picking stones is the least favorite job on a farm. I never heard any farm kid exclaim, "Oh, goody! We get to pick stones today!" Our kids didn't get out of that job, and it taught them how to work.

Way back in the day, there were such things called stone boats. These were boat-shaped vessels pulled by a tractor and made of planks with a steel plate bolted to the planks. They were laid flat on the ground with no wheels, used mostly for large stones. When full, it was pulled over to the stone fence and the guys rolled them off.

Thankfully, we didn't use that but instead purchased our first skidster. The bucket could be placed flush to the ground and the bigger stones rolled on. Usually, the oldest kid would drive the skidster over to the stone fence, dumping it. When our kids left home, we bought ourselves a stone bucket attachment. Nowadays we just drive around with the skidster and dig under the stone, lifting the bucket up and shaking it so the dirt sifts through. The kids howled, "Oh, we're gone and now you get that?" Our manpower had left.

Finally, getting all of last year's harvest off the fields, spreading manure, disking, dragging, and picking stones; the rich nutrient-soaked field is finally ready to be planted. After all of that time and effort plus fuel, and wear and tear on the equipment, the bone-weary farmer in faith watches the seed yield a wavy field of soybeans, oats or sorghum. Corn with its little green soldiers standing at attention in military-like rows causes me to sigh with satisfaction, acknowledging all the work it took.

Seeing the crops grow in anticipation of a good harvest makes it all worthwhile. Before you know it, it's time to cut hay.

"And let us not grow weary of doing good, for in due season we will reap, if we do not give up." — Galatians 6:9

Kay Reminger was born and raised on a dairy farm, and she married her high school sweetheart, who happened to farm for a living in Leopolis. Writing for quite a few years, she remains focused on the blessings of living the ups and downs of rural life from a farm wife's perspective.

Many of the spring blooming bulbs appear and bloom so quickly that they are completely dormant by the time the leaves flush out on the trees overhead. This makes them an ideal choice for gardeners who want a quick burst of color in spring before standard perennials began to appear and blossom.

There are many great ways to incorporate spring blooming bulbs in the garden. Planting in masses of color is one of my favorite ways. Instead of planting bulbs in individual holes in simple rows or lines, dig a large hole 2 to 3 feet across and cram it full of assorted bulbs for a beautiful display in spring.

One of my favorites of the spring blooming bulbs are the allium, or ornamental onion. Some of these can be quite large, up to 6-10 inches across. Most of these bloom in May or early June. Many varieties come in purple and white.

Tulips are the favorite of many gardeners. They come in such a wide variety of colors and shapes and styles that it is possible to create a breathtaking tulip garden that blooms from April all the way into early June. There are dwarf tulips and giant tulips. There are variegated tulips. Of course, the blooms come in every color of the rainbow.

Hyacinths are another favorite. Fragrant and lush in flower, the large Dutch hyacinths bloom in shades

of blue, purple, pink, yellow, orange and white. There are also the smaller grape hyacinths that bloom in blue and purple and white.

Of course, there are the daffodils. In most years, daffodils bloom a bit earlier than tulips. Besides the classic daffodils in shades of yellow, there are

many daffodils that bloom in white, as well as orange. An increasing number of daffodils bloom in pink and white. Some have cups that are even near-red in color.

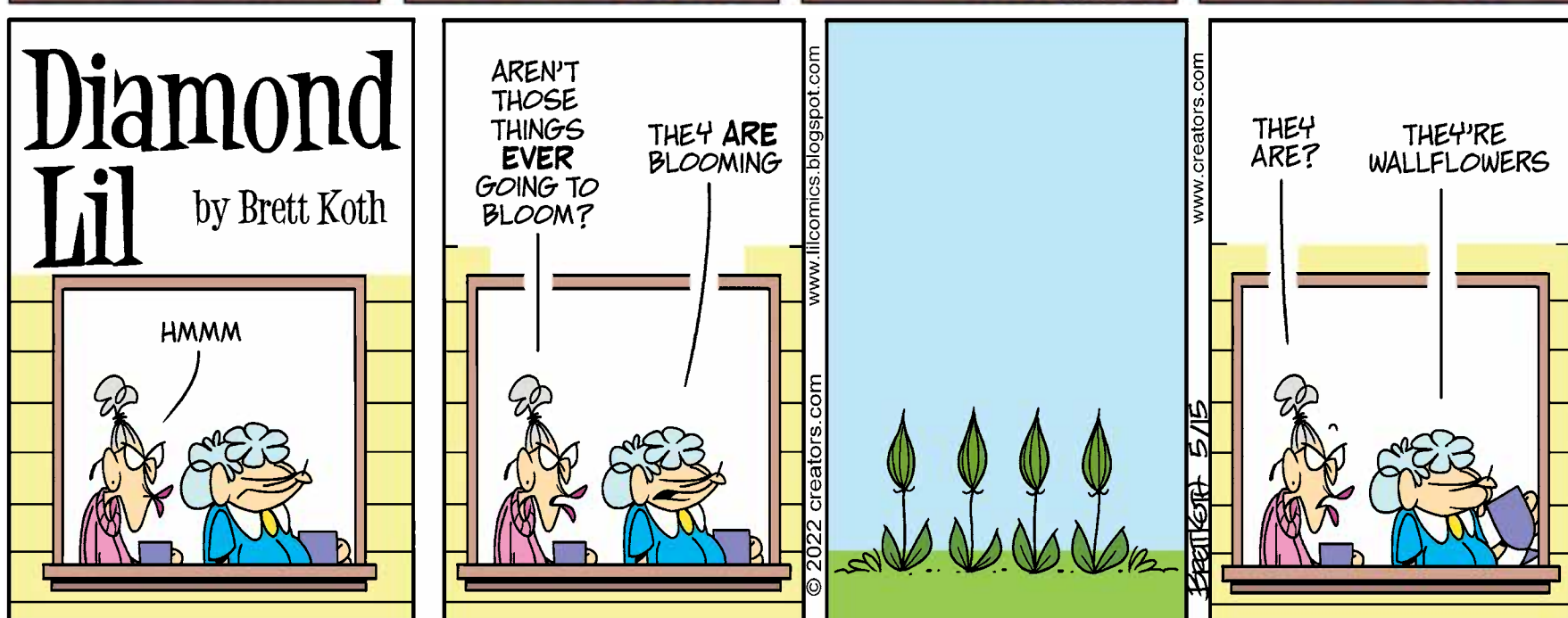
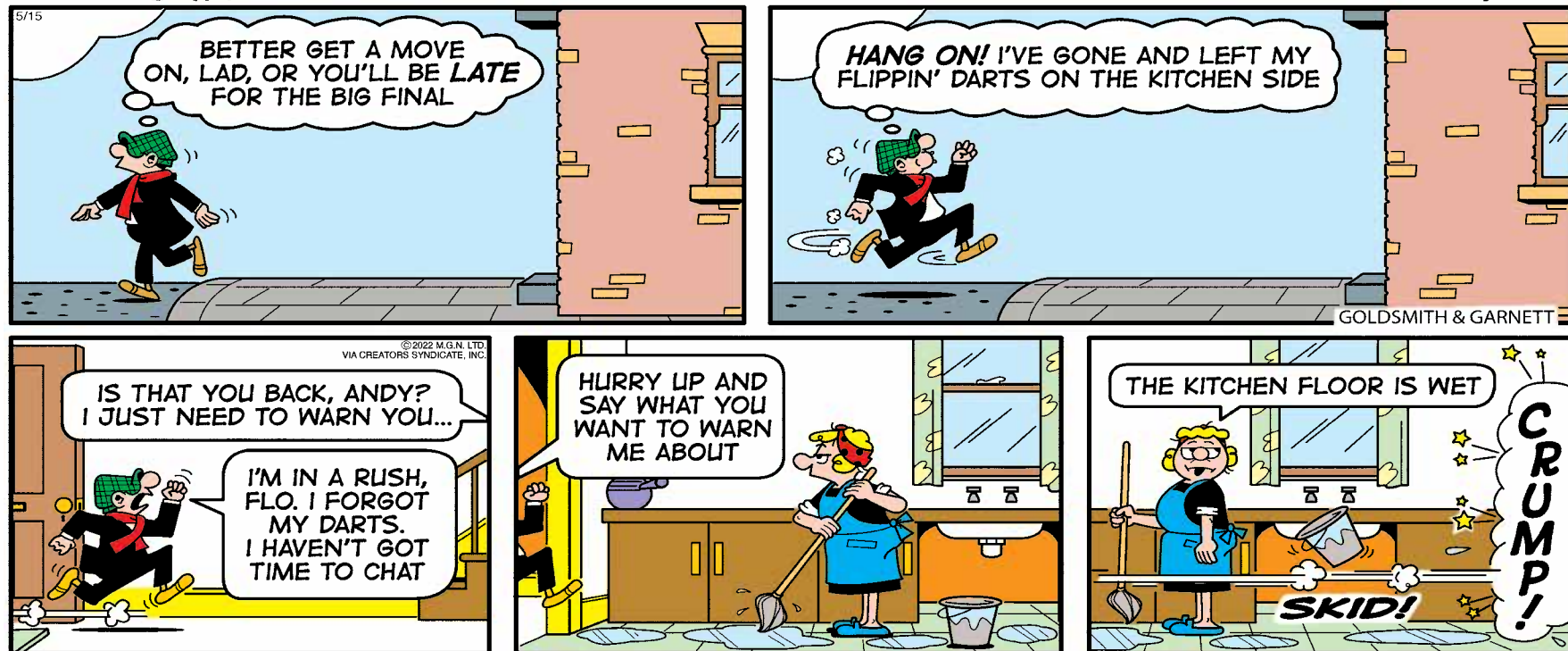

Because of this, you can find many garden centers that now sell pre-cooled bulbs in Spring that are ready to plant and ready to bloom. While these are often common varieties, it is a way for spring gardeners to have lush, spring blooms without having to do all of the hard work in the fall.

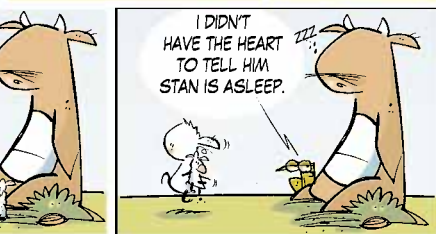
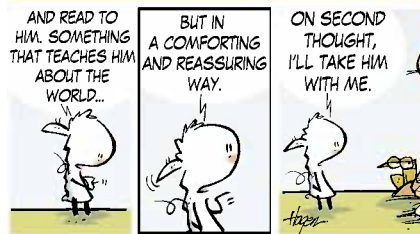
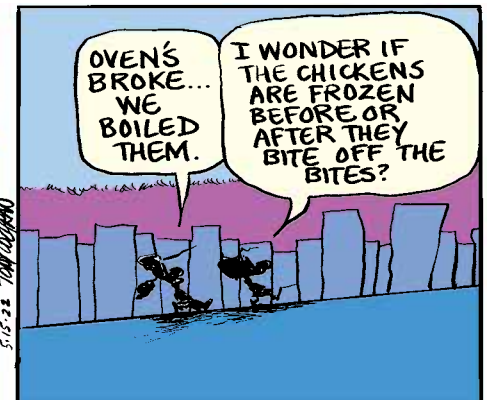
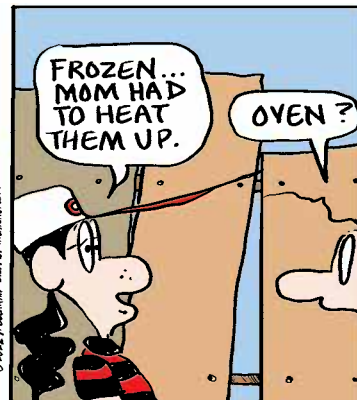
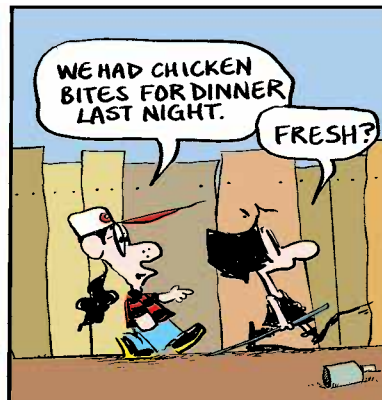
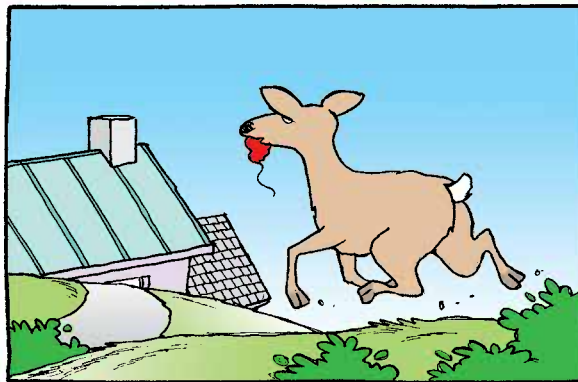
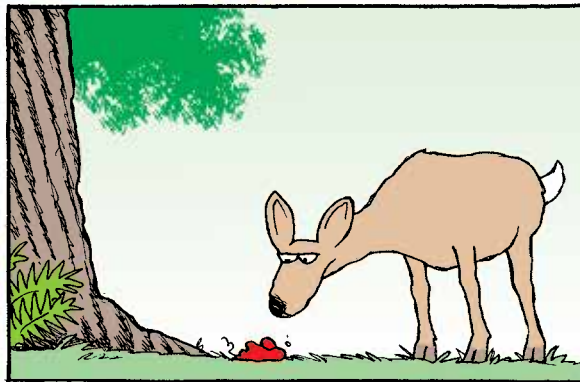
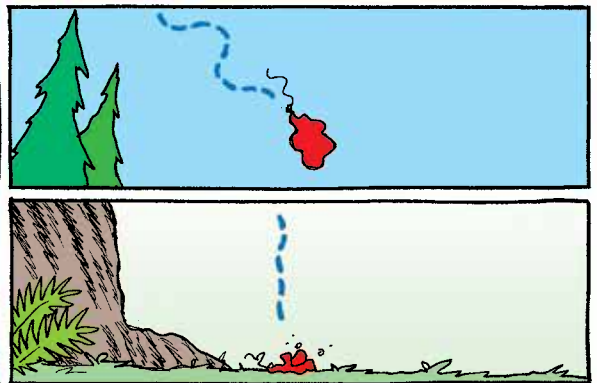
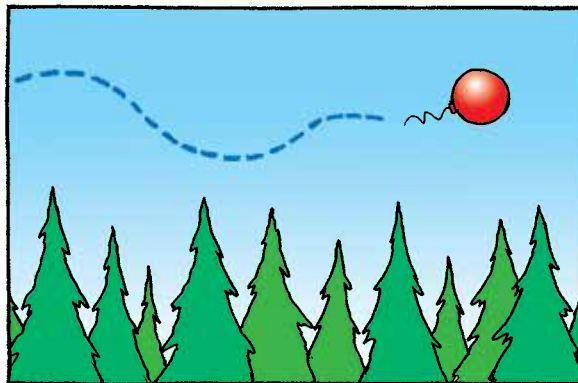

Open Thursdays from 4-8 p.m., the SAM25 Community Health Clinic provides free basic health care and health education to area residents who do not have health insurance and are living near or below the federal poverty level.

The Sam's Thrift Store and Professional Clothes Closet opened last April and is open to the public on Thursday, Friday and Saturday from 9 a.m. to 3 p.m.

The chapter and individual members donated \$358.60 in cash, stamps, gas cards, Aldi and Charlie's Market gift cards to SAM25.
