

Tribal chairman optimistic about casino project

Awonohopay sees Trump's efforts as sign efforts will succeed

The federal review of a proposed casino in Kenosha is still under review, but the chairman for the Menominee Indian Tribe of Wisconsin is optimistic about the project succeeding in light of Donald Trump being president.

The latest effort to build a Hard Rock hotel and casino in southeastern Wisconsin has been in the works for more than five years, noting that having a Democratic governor increases the likelihood of getting approval. The Menominee have previously tried to get approval for a Kenosha casino, but that failed when Gov. Scott Walker, a Republican, rejected it in 2015.

Tribal Chairman Joey Awonohopay believes that Trump's efforts to trim down the government and create jobs will work in the tribe's favor.

"President Trump and his administration have made it clear they are interested in creating jobs and streamlining rule processes to increase efficiency within the government," Awonohopay wrote in a memo to all tribal members. "Their commitments to these ideas are a positive indicator that OIG (Office of Indian Gaming) will complete their final review of the EA (Environmental Assessment), and that we are well-positioned to achieve project approval."

Awonohopay wrote that the casino project could signal economic revitalization for the tribe, the city of Kenosha and the state of Wisconsin.

The EA is a major step to get federal approval to be in compliance with the National Environmental Protection Act. According to Awonohopay, a draft was completed almost a year ago with revisions being done in summer and fall 2024. Last November, the EA was sent to the OIG for final review.

Once the review is completed, the public will have the opportunity to comment on the EA, Awonohopay wrote.

"The EA has shown no negative impact, and we are hopeful that BIA (Bureau of Indian Affairs) will determine the project is beneficial to both the Menominee and the Kenosha community," Awonohopay wrote. "Based on that determination, BIA will send their determination to Gov. Tony Evers for his concurrence. While the governor has up to one year to review the application, we are optimistic

his decision will come even sooner, reflecting the widespread support and clear advantages this project offers."

Awonohopay expects the casino will bring in plenty of construction jobs, along with employment for more than 1,000 people once it opens. The casino is expected to attract 2.4 million visitors annually, with about two-thirds of them coming from outside Wisconsin.

"This project will also have a positive ripple effect on other local businesses in southeastern Wisconsin," Awonohopay wrote. "For the tribe, this project is more than a business venture; it represents the best opportunity for the Menominee to

address the significant challenges facing our people."

The tribe anticipated the income generated will help to address health care, education and infrastructure on the reservation, which ranks among the poorest in the state and nation.

"With this project, we aim to become both a leading job generator and an example of economic empowerment in Wisconsin," Awonohopay wrote.

He added that future updates are coming, with project information posted at casino.hardrock.com/kenosha.

Residents opposed to county wheel tax

Claim property tax assessment would be more fair

About 100 residents packed the meeting room at the Shawano County Courthouse on Feb. 20 to hear the reason behind a proposed wheel tax and to voice their opposition to that proposal.

Instead, by an informal show of hands, the vast majority of those present said they favored an addition to their property tax bill to pay for county expenses.

Supervisors are considering a proposed \$20 annual wheel tax to raise about \$747,000 each year. While the money would be earmarked for roads and bridges, Board Chairman Tom Kautza said it is a "shell game" set up by the state.

While the new funds would be spent on roads and bridges, they would not necessarily be in addition to tax levy dollars already spent on roads and bridges. Because all county departments are pressed, tax dollars normally allocated to the highway department for roads and bridges would most likely be shifted to other departments.

By state law, the wheel tax cannot be assessed on farm vehicles, motorcycles, ATVs and UTVs, Amish horse and buggies, or any vehicle weighing more than 8,000 pounds. Kautza and Jim Davel, administrative coordinator, said anyone who wants that changed has to convince the legislature and governor.

The wheel tax was proposed to help spread the fee across those who most often use the roads and bridges.

This year, the county, after slashing budgets for all departments, opted to borrow \$2 million to balance the budget. Again, playing the state's shell game, the money was for roads and bridges so other existing funds could be shared among other departments.

The borrowed funds plus about \$13,000 in interest was paid back in a

Kropf sexual assault case going to trial

Bowler man accused of explicit acts with 10-year-old girl

James Kropf will be rolling the dice with a jury trial after one of his attorneys reported Feb. 18 that there has no progress in reaching a settlement in his case.

Kropf was charged May 5, 2023, with second degree sexual assault of a child and incest with a child in relation to two incidents between September 2021 and April 2022 in Bowler.

Defense attorney Carly Krueger said she was looking for trial dates due to “defense logistics” of the case; she asked for the trial to be in July and expected it to last three days. The

one available three-day slot in July did not work for the defense, so Shawano-Menominee County Circuit Court Judge William Kussel Jr. set it for

Aug. 12-14, with a final pre-trial hearing set for 3:30 p.m. Aug. 5 in Branch II of the Shawano County Courthouse.

Kussel also granted the defense’s motion to allow Kropf to travel out of state Feb. 21-23 from Bowler to Seattle, Washington, as a current condition of his bond requires court approval before he can leave Wisconsin.

According to the criminal complaint, a Shawano County deputy received a call from Child Protective Services regarding a 10-year-old girl in Kropf’s care. CPS reported the girl told them that Kropf touched her in the swimsuit area. The girl lives with her mother and has visitation with Kropf on weekends.

In an interview with the girl’s mother, the mother was allegedly surprised and unaware of the circumstances. She told law enforcement that visits with Kropf are from 11 a.m. to 4 p.m. and are supervised by Kropf’s mother.

In an interview with the child, the child described two instances where Kropf touched her chest in an inappropriate manner. She stated that both of the instances took place at Kropf’s mother’s home. When wrestling on the ground, the child said that Kropf touched her chest over her clothes, and she told him to stop, which she also said Kropf mimicked. The child also described a similar situation for the second time it happened.

If convicted, Kropf faces up to \$100,000 in fines and up to 40 years in prison. He is out on a \$50,000 bond.

Primary election narrows choice of candidates

Results of the Feb. 18 primary election narrowed the list of candidates for the the Menominee Indian School District and the Menominee County Board of Supervisors.

For the school district, residents cast ballots to narrow the candidates seeking the at-large seat. The top candidates — McKaylin Peters and Carrie Waukau-Grignon — will advance to the April 1 general election.

Unofficial vote totals show Peters with 104 votes, Waukau-Grignon with 65, Garry Pywasay with 55 and

Miriam Wauoose with 25. Waukau-Grignon picked up the two votes cast in the Town of Red Springs in Shawano County.

For the Ward 5 seat on the county board, Denise Gilane (92 votes) and Jamie Loudbear Wayka (39 votes) will advance. Douglas C. Cox received 17 votes.

A handful of voters in Shawano County were asked to cast their ballot for two Clintonville School District at-large members. Areas included in the district are part of the towns of Belle Plaine, Pella and Navarino.

Incumbent Mark Zachow will advance; he picked up 365 total votes, 35 in Shawano County. Challenger Christopher Hoffmann had 338 total votes, 20 in Shawano County. Incumbent Laurie Volrath had 332 total votes and 30 in Shawano County. Finally, David Battemberg will advance as he received 275 total votes, 28 in Shawano County.

Other candidates were Patrick K. Huss, 268 total, 18 Shawano County; Tanya Hepp-Netrefa, 136 total, 15 Shawano County; and Marie Vandenberg, 80 total, 11 Shawano County.

In the race for Wisconsin Superintendent of Public Instruction, incumbent Jill Underly had the most votes

and will face off against Brittany Kinser.

In Menominee County, Underly received 118 votes, Kinser had 64 and Jeff Wright had 63.

In Shawano County, Kinser collected 1,030 votes, Underly had 817, and Wright picked up 538.

Voter turnout in Shawano County was 9.23%, as 2,425 ballots were cast from among 26,272 registered voters. There were 19 registrations on Election Day.

Underly is currently serving her first term as state superintendent. Kinser is an advocate of the state’s private school voucher program and public charter schools.

Underly was first elected to head the Wisconsin Department of Public Instruction in 2021 with the support of Democrats and teachers unions.

She was endorsed by the Wisconsin Democratic Party, which also has given her campaign \$106,000 this month, and a host of Democratic officeholders.

But the Wisconsin Education Association Council, the statewide teachers union, did not endorse a candidate in the primary. The political action committee for the union had recommended Wright be endorsed.

Kinser is backed by Republicans, including the state party, which has given her campaign \$200,000 so far.

Wisconsin is the only state where voters elect the top education official but there is no state board of education. That gives the person who runs the Department of Public Instruction broad authority to oversee education policy, which includes dispersing money to schools and managing teacher licensing.

Michael Ingold homicide case remains at a standstill

Three months have passed with no attorney to take on case

Michael Ingold’s efforts to get a speedy trial continue to be hampered by the lack of attorneys available to take on a case of first-degree homicide.

In a case that has been on the court docket for more than 2 1/2 years, a Feb. 17 hearing revealed that in

the last three months, the public defender’s office has been unable to find an attorney for Ingold, 59. According to online court records, 618 attorneys have been contacted to take on the case without success.

According to Shawano-Menominee County Circuit Court Judge William Kussel Jr., the difficulty in finding attorneys to take on felony cases has persisted for years, but is even more difficult when it comes to homicide cases.

“I’m sure they’ll get someone for you, but because of the type of matter this is on the first-degree in-

tentional homicide, I’m sure they have certain requirements that the attorney has to have,” Kussel said. “I know they’re working hard to try to find someone. Hopefully, it will be soon. That’s the best I can tell you at this point.”

A status conference was set for 1:30 p.m. March 24 in Branch II of the Shawano County Courthouse to see if an attorney has been found by then.

This is the third time an attorney has been sought for Ingold. Julianne Lennon took on the case for Christopher Froehlich, who withdrew May 9, 2023, after being appointed Oct. 18, 2022. Lennon withdrew from the case Nov. 21, 2024, after Ingold refused to come to court with her or appear via Zoom on the eve of the trial.

The criminal complaint against Ingold states that at 4:13 a.m. June 25, 2022, the Shawano County Sheriff’s Department received a 911 call from Ingold, where he stated that he woke up and checked on his girlfriend, only to find her deceased.

An autopsy showed that Sheila Laudon, who was 59 at the time, was strangled to death.

Ingold told the deputies

that he got home at 6:30 p.m., talked with the victim, turned on the television and fell asleep on the couch, according to the complaint. He stated he woke up around 2:30 a.m. and heard the victim in the kitchen saying that she was getting a beer. He then claimed that he woke up again at 4:01 a.m. and found her dead in the bedroom.

Detectives received the autopsy report of the victim’s death on July 21, 2022, stating that the cause of death was manual strangulation.

On July 27, 2022, two detectives interviewed Ingold at the sheriff’s department, told Ingold that the victim died from strangulation and that they believed that he caused it. Ingold allegedly responded, saying, “No, it’s not; no, it’s not. I didn’t touch her,” according to the complaint. Ingold acknowledged he and Laudon were the only two people in the house but continued to deny touching her, according to the complaint.

Ingold faces life in prison if convicted of first-degree intentional homicide with a domestic abuse modifier. He remains in the Shawano County Jail on a \$1 million bond.

Time heals wounds from Novitiate takeover

Current owners moving ahead with remodeling efforts

It's been 50 years, and memories of the armed takeover of the former Alexian Brothers Novitiate near Gresham still resonate with longtime members of the community.

Ethan and Stephanie Fernhaber are working to bring new life to the 25,827-square-foot mansion that rests on the 177 acres along the Red River.

While some of the issues that led to the takeover continue, the Fernhabers hope to change what residents associate with the mansion once their remodeling effort is complete.

The mansion today

Today, the Novitiate is owned by the Fernhabers, who in turn own Novitiate LLC, which encompasses all of the land and building. The only building remaining on the site is the mansion itself.

There is also caretaker's RV on the site. Tim Bosman, Ethan Fernhaber's brother-in-law, is the caretaker. He is also a teacher in the Gresham School District.

Stephanie Fernhaber grew up about a mile from the mansion.

"It is the most beautiful and destroyed piece of property I have ever seen," Ethan Fernhaber said.

The plan is to restore the mansion and use it in a way that gives back to the community.

"We purchased the Novitiate so our family could work together to restore the mansion and enjoy the land," Fernhaber said.

In the past few years, the Fernhabers have installed a new roof and windows in the mansion. They are in the process of finalizing the

plans for the building and the grounds.

The building has been gutted; when remodeled, it will feature more than 20 rooms.

"We hope to bring the mansion into a habitational state by 2030," Fernhaber said.

Today, the grounds are used for hiking, fishing, camping and an occasional family event.

Fernhaber grew up in the Milwaukee area. He worked as a meat cutter and then went to UW-Milwaukee. After graduation, he performed audits for Wells Fargo Business Credit.

"Stephanie and I moved to Indiana for Stephanie to go to graduate school," Fernhaber said. "During this time, we used our home equity line of credit to purchase our first double-wide. We renovated it and placed a renter in that. Over the next two decades, we acquired more homes and then shifted into apartment communities."

The couple now oper-

ates three companies and a foundation.

Created in 2003, Renewing Management is their property management company. The portfolio includes 30 apartment communities with 4,200-plus rental apartments throughout Indiana.

Volumod is a volumetric modular construction facility founded in 2021 on the far east side of Indianapolis.

"We construct multi-family, single-family and light commercial in an environmentally-controlled factory," Fernhaber said.

"We offer second-chance hiring for individuals coming out of incarceration or other challenges."

Helix is a land development and construction management company, partnering with Renewing Management and Volumod.

Finally, Renewing Communities is a nonprofit organization serving the employees of Renewing Management, Volumod and Helix, the residents in their

apartment communities and neighbors throughout Indiana.

"We are passionate about education, entrepreneurship and faith," Fernhaber said. "We love to see hope restored and communities flourish."

Early history, hostile takeover

Completed in 1939, the mansion was built for Jennie Peters of New York and her disabled daughter, who died before the building was complete.

The Georgian style mansion originally included a two-story stone portico, large windows, 35 rooms, servants' quarters and a second story balcony.

In 1948, Peters returned to New York, and the building was turned over to the Alexian Brothers. This building was expanded in 1954 to include new dormitories, a cloister, chapel and other facilities. More land was also purchased in 1955, to provide a farm to feed the novices.

In 1969, the Brothers moved their operations to Chicago, putting the novitiate building up for sale, with the last Brothers moving out in 1972. Attempts to sell the property were unsuccessful.

On Jan. 1, 1975, an armed group called the Menominee Warrior Society, seized the property and took the caretaker and his family hostage. They demanded that the Novitiate and property be turned over to the Menominee Tribe, claiming that federal law allowed them to retake the land once it was no longer used for religious purposes.

Tensions ran high, shots were occasionally exchanged and negotiations stalled. Local law enforcement cut off power to the novitiate, which resulted in pipes freezing, causing extensive damage to the property. The National Guard was called in by the governor.

Vigilante activity was common, as groups of armed residents would access the property on snowmobiles to fire on the Novitiate.

Several American Indian Movement leaders traveled to Gresham to show support and help with negotiations. The presence of AIM also brought actor and Native American rights advocate Marlon Brando to the scene.

On Feb. 2, 1975, the standoff ended with a deal in which the Alexian Brothers agreed to sell the property to the tribe for \$1.

Since the standoff, the Novitiate has struggled to find a purpose in the area. The Menominee Tribe was unable to maintain the building and surrendered their claim to the property within a few months. In October 1975, a fire severely damaged the building.

Ownership went through several hands, the land was divided and all the buildings except for the mansion were razed.

"First place is \$400," Brzeczowski said. "We also have a Puzzles for Pints event at the museum when it is open Saturday (March 8). There are puzzles and prizes, and free Polish treats and desserts."

Community sponsors help ensure many of the events are free.

Also new this year are guided tours of Assumption BVM Catholic Church.

"It's such an iconic

landmark in the community," Brzeczowski said. "It's replicated after the church in Krakow, Poland."

The big events are the dance and the raffle.

"Admission to the dance is \$15, but those who show up in full ethnic attire get a discount," Brzeczowski said. "I already have my costume."

Raffle tickets are \$100 each, and only 300 are sold. The top prize is \$10,000, with another

\$6,000 or so given away in other prizes.

Events kick off March 4 with a special polka story time from 10:15-11:15 a.m. at the Pulaski Public Library. From 4-7 p.m., 20% of the proceeds from food and drink ordered at Dairy Queen will be donated to Promote Pulaski.

DID YOU KNOW?

Casimir Pulaski fought the Russians in his native Poland from 1770-72. He later fought with General George Washington at Brandywine during the Revolutionary War from 1777-78. After this battle, Washington made him a brigadier general for gallantry in commanding cavalry troops.

With congressional consent, Pulaski found an independent cavalry corps (Pulaski Legion). For this reason, he became known as the Father of the American Cavalry. In October 1779, Pulaski was mortally wounded while fighting with American and French forces against the British at Savannah, Georgia. He died Oct. 11, 1779.

John J. Hof, an agent of the General Land Company of Milwaukee, encouraged Polish families in Milwaukee and in other cities to sell their homes and to buy land in Wisconsin. In 1883, the first settlers arrived in this area.

Grignon succeeds Tourtillott as Menominee police chief

With a four-year term behind him, Keith Tourtillott prepared for retirement, and Menominee voters elected Vincent Grignon Jr. to succeed him.

The election was held in the middle of January.

Grignon was sworn in Feb. 9 by Menominee Tribal Chief Justice Bridget Long.

An enrolled member of the Menominee Indian Tribe of Wisconsin, Grignon has spent nearly his entire life on the Menominee Reservation, according to a social media post by the police department. A 2006 graduate of Menominee Indian High School, he went on to earn his associate's degree in criminal

justice in May 2011 from Fox Valley Technical College.

He began his law enforcement career as a patrolman with the Menominee Tribal Police Department.

Throughout his decade-plus time with the department, Grignon has held several leadership roles — including patrol sergeant, field training program supervisor, field training officer, school resource officer and Native American Drug & Gang Initiative Task Force officer.

Just days prior to Grignon being sworn in, Tourtillott was honored by Menominee tribal leaders, members of Menominee law enforcement community and representatives from the FBI.

Tourtillott noted the challenges he faced, including the escalating drug crisis, the emotional impact of the Murdered and Missing Indigenous Women/People issue and difficulties in recruiting police officers.

Despite these obstacles, he commended the commitment and professionalism of his team, leaving behind a department with strong ties to the community and other law enforcement agencies.

Tourtillott's experience stretched from his early work as an adolescent drug and alcohol counselor to his leadership roles within the Menominee Tribe, the U.S. Marshals Service and the Keweenaw Bay Indian Community.

He earned a bachelor's

degree from UW-Green Bay and a master's degree in business administration for the University of Phoenix.

Tourtillott served three separate terms as police chief — first by appointment from 1995-97, second by election from 2000-03 and again by election from 2021-25. His last day was Feb. 8.

He was presented with a plaque by Tribal Chairperson Gena Kakkak for his years of service and dedication. He was also honored by the FBI, represented by Assistant Special Agent in Charge Alan Karr (Milwaukee office) and Supervisory Special Agent Christopher West (Green Bay office).

Wittenberg's history no longer fits in schoolhouse

Historical society hopes to raise \$300-\$500K for new museum

History is always expanding, and for the Wittenberg Area Historical Society, that poses a problem with its current building.

The historical society made a formal announcement Feb. 21 that it planned to build a new building next to the existing 1904 one-room German Lutheran parochial schoolhouse, allowing it to showcase more of the memorabilia that makes Wittenberg and surrounding communities unique.

According to member John Powers, the building is estimated to cost between \$300,000 and \$500,000, and the society hopes to start it within the next three years.

Powers told a packed house at a fundraiser at the Little White Chapel that he sees the new museum building as the historical society's way of "moving into the 21st century." This is a stark contrast to six years earlier, when the historical society was worried it might disband entirely.

"What we're trying to do here is take an important step into Wittenberg's future," Powers said. "It's a step that will honor the past and preserve the past. For over 50 years, the current museum in town has been the historical society's focal point in efforts to preserve the artifacts, photographs, documents and life stories that have shaped the community for the last 150 years."

The current building was operated as a school adjacent to St. Paul Lutheran Church until 1955. Powers said the historical society bought the building in 1972 to serve as the current museum.

"Grover Meisner, who

was the president of the society at that time, stated the society would preserve that landmark building in its present state with a one-room school atmosphere," Powers said.

In the years since, it has become clear that the one building cannot contain more than a century of life in Wittenberg within its walls, especially as issues

with heating, plumbing and other infrastructure makes it even more difficult to run the facility as a museum. Currently, the museum is only open Sundays between Memorial Day and Labor Day.

"Those issues keep us from using the building year-round and cause problems in preserving documents," Powers said. "The

collections and displays have long outgrown the size of the building. It's not handicapped-accessible, and any remodel we do to it would destroy the historical significance of the school."

Powers said the historical society has spent more than two years looking at options where items can be displayed while also allowing local residents to stop in

and research their history. He even hopes that future generations would follow that trend and continue to keep history alive.

Under the proposed plan, the school remains part of the historical society's complex. The new museum building, while chronicling Wittenberg's history, would also serve as a gathering place, according to Powers.

"This space will allow us to expand our mission and make history more accessible to everyone in the community," he said.

Beth Koeppel, an architect with HGA Architects and Engineers, will design the project, Powers said.

"She has already demonstrated in our planning sessions that her work will reflect the heart and soul of the Wittenberg area in a space that looks toward the future," Powers said, noting that Koeppel is offering her services pro bono.

Plans only work, however, if the historical society is able to come up with the money to pay for its construction.

"This project cannot and will not happen without you, the community,"

Powers said. "This is not just about constructing a building. It's about building a vision together — a vision of both the past and the future."

Powers made it clear he wasn't stumping just for people's dollars. He also sought to get Wittenberg residents involved to volunteer and get the word out.

"We believe this is something every individual and family in Wittenberg can be proud to contribute," Powers said. "We will be hosting community meetings, sharing updates and keeping you involved every step of the way."

The project would also construct a ramp for the schoolhouse to make it accessible for people in wheelchairs, according to Powers, and the building would mainly serve as a school display. That would only get folks into the main part of the school, he said, and not the basement, which he noted is difficult for most people to currently get into.

As for the new building, the historical society hopes to have both the main floor and basement area serve as display space, Powers said, with another ramp leading to the basement. He noted that there will also be space for volunteers to work.

"Right now, we're doing it from home," Powers said. "Every now and then, we have to go back into the building, which causes tingly fingers after about 10 minutes."

Grants are something that the historical society is looking into, but it's believed that those grants would come easier if the historical society shows there's already some community money behind it.

"We're just in the beginning of that process," Powers said. "We know that there's grant money out there. As to how we can access it and when, that's something we need to work on."

Wisconsin cattle and calf numbers up slightly from 2024

All cattle and calves in Wisconsin as of Jan. 1 totaled 3.25 million head, according to the latest USDA, National Agricultural Statistics Service – Cattle report. This was up 50,000 head from Jan. 1, 2024.

Beef cows, at 275,000 head, were up 15,000 head from last year. Milk cow inventory was down 5,000 head at 1.27 million head.

All heifers 500 pounds and more were up 5% at 680,000 head. Heifers for beef cow replacement were up 18% from 2024 at 65,000 head; heifers for milk cow replacement, at 510,000 head, were up 2% from the previous year; and all other heifers were up 11% at 105,000 head.

Steers weighing 500 pounds and more were unchanged from last year at 360,000 head. Bulls weighing 500 pounds and more were unchanged at 30,000 head. Calves less than 500 pounds on Jan. 1 totaled 640,000 head, up 2% from last year.

The 2024 calf crop was estimated at 1.37 million head, unchanged from the 2023 calf crop. Cattle and calves on feed for slaughter in all feedlots on Jan. 1 totaled 230,000 head, up 5% from one year ago.

All cattle and calves in the United States as of Jan. 1 totaled 86.7 million head, 1% below the 87.2 million head on Jan. 1, 2024.

All cows and heifers that have calved, at 37.2 million head, were slightly below the 37.4 million head on Jan. 1, 2024. Beef cows, at 27.9 million head, were down 1% from a year ago. Milk cows, at 9.35 million head, were up slightly from the previous year.

All heifers 500 pounds and more as of Jan. 1 totaled 18.2 million head, 1% below the 18.3 million head on Jan. 1, 2024. Beef replacement heifers, at 4.67 million head, were down 1% from a year ago. Milk replacement heifers, at 3.91 million head, were down 1% from the previous year. Other heifers, at 9.59 million head, were 1% below a year earlier.

Steers weighing 500 pounds and more as of Jan. 1 totaled 15.8 million head, down 1% from Jan. 1, 2024.

Bulls weighing 500 pounds and more as of Jan. 1 totaled 2.01 million head, down 1% from Jan. 1, 2024.

Calves less than 500 pounds as of Jan. 1 totaled 13.5 million head, down slightly from Jan. 1, 2024.

Cattle and calves on feed for the slaughter market in the United States for all feedlots totaled 14.3 million head on Jan. 1. The inventory is down 1% from the Jan. 1, 2024, total of 14.4 million head. Cattle on feed in feedlots with capacity of 1,000 or more head accounted for 82.7% of the total cattle on feed on Jan. 1, up slightly from the previous year. The combined total of calves less than 500 pounds and other heifers and steers more than 500 pounds (outside of feedlots), at 24.6 million head, was slightly below Jan. 1, 2024.

The 2024 calf crop in the United States was estimated at 33.5 million head, down slightly from the previous year's calf crop. Calves born during the first half of 2024 were estimated at 24.6 million head, down slightly from the first half of 2023. Calves born during the second half of 2024 were estimated at 8.93 million head, 27% of the total 2024 calf crop.

All inventory and calf crop estimates for July 1, 2023, and Jan. 1, 2024, were reviewed using calf crop, official slaughter, import and export data and the relationship of new survey information to the prior surveys. Based on the findings of this review, July 1, 2023, all cows and heifers that have calved decreased by 0.3% and 2023 calf crop decreased by 0.1%. For Jan. 1, 2024, all cows and heifers that have calved decreased by 0.6%.

State-level estimates were reviewed and changes were made to reallocate inventory estimates to the United States total.

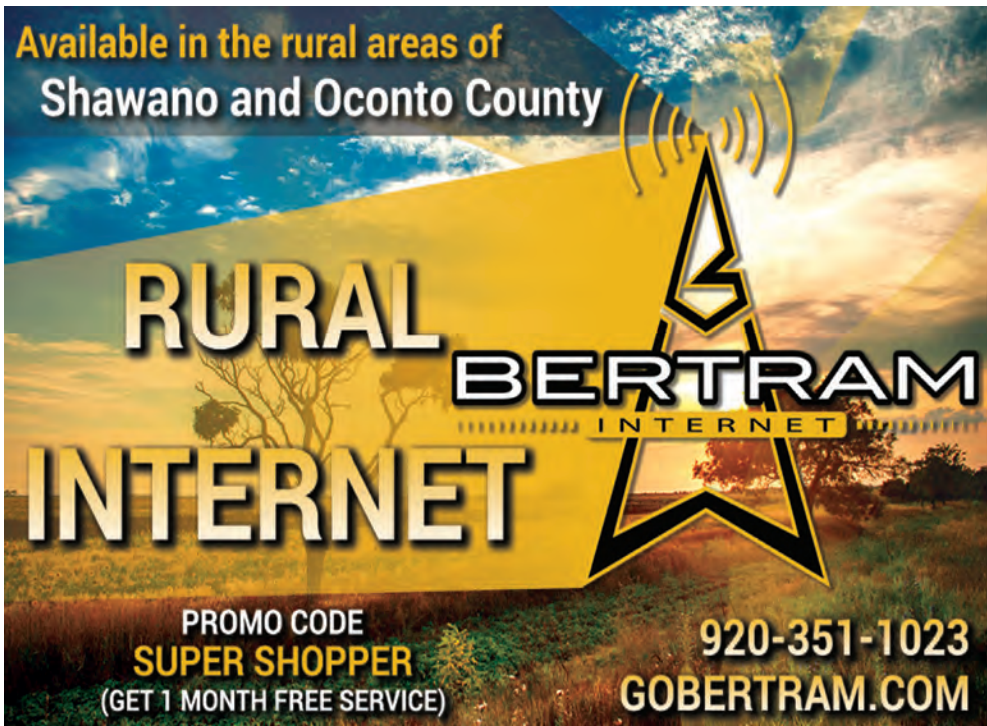

DNR conducting prescribed burns

The Wisconsin Department of Natural Resources (DNR) announced that fire management crews will begin conducting prescribed burns on DNR properties throughout the state where local conditions can provide a safe and effective burn.

The recent, much-needed precipitation has created conditions that are ideal for burning in certain areas of the state.

Winter burns typically begin with cattail marshes, wetlands and wet prairies. Cattail wildfires can present a control challenge for suppression authorities during the warmer summer months when dead and live cattails are available to burn. By burning in winter, DNR staff take advantage of ideal ice and snow cover, which reduces the heat and intensity of cattail marsh and barrens burns.

Additional windows of opportunity for prescribed burning will continue through spring and open again in late summer and fall (mid-July through November).

Prescribed burns support healthy ecosystems for an abundance of plants and animals in Wisconsin. These burns mimic the benefits historic fire once provided but occur under a safer "prescription" range of weather and fuel conditions (compared to most

wildfires). Throughout history, many ecosystems in Wisconsin experienced either periodic natural fire or were managed with cultural fire by Indigenous people. These "fire-dependent" plant communities — such as prairies, wetlands and oak or pine barrens, savannas or woodlands — developed a tolerance and eventual dependence on periodic fire; they would not be sustained today without prescribed burning.

Winter burns remove dead vegetation buildup and open waterways for

migratory fowl and other wildlife. The dead vegetation is reduced to ash, transferring this natural fertilizer back into the soil.

Following the burn, hazardous fuels are reduced, foraging and nesting improve in the revitalized vegetation, and the stimulated growth of their root systems enhances their ability to store more carbon. Other benefits of prescribed burns include reducing non-native or invasive plant species and increasing regeneration of important native trees, like oak and pine.

When conducting prescribed burns near roads or recreational trails, the DNR will post signs to notify the public. For safety, avoid these areas while the burn is being conducted. The DNR also notifies local law enforcement and fire officials in advance about when and where DNR prescribed burns will take place.

USDA releases final 2024 crop production data

Corn for grain production in Wisconsin for 2024 was estimated at 515 million bushels, according to the USDA, National Agricultural Statistics Service – Crop Production 2024 Summary.

Current year production was down 7% from the previous year's 553 million bushels. Wisconsin's corn for grain yield was estimated at 174 bushels per acre. Area harvested for grain was estimated at 2.96 million acres, 180,000 acres below 2023.

Corn planted for all purposes in 2024 was estimated at 3.75 million acres.

Corn for silage production was estimated at 14.6 million tons, down 11% from 2023. The silage yield estimate of 20 tons per acre was down 1 ton per acre from 2023. Producers harvested 730,000 acres of corn for silage, down 6% from 2023.

Soybean production was estimated at 102 million bushels in 2024. This was down 3% from the previous year's 105 million bushels. The Wisconsin soybean crop yielded 48 bushels per acre in 2024. The harvested acreage of 2.12 million was up 60,000 acres from 2023. Soybean planted acreage, at 2.15 million, was up 40,000 acres from 2023.

All hay production for the state was estimated at 3.90 million tons, up 75% from the 2.24 million tons produced in 2023. Producers averaged 3.03 tons per acre, up 0.86 tons per acre from 2023. All hay harvested acres were estimated at 1.29 million acres, up 260,000 acres from 2023.

Alfalfa and alfalfa mixtures for hay production was estimated at 3.03 million tons, up 75% from

2023. Producers averaged 3.65 tons per acre, up 0.95 tons per acre from 2023. Harvested acres were up 190,000 from the previous year, to 830,000 acres. Wisconsin producers seeded 240,000 acres of alfalfa and alfalfa mixtures in 2024, up 14% from 2023.

Other hay production was estimated at 874,000 tons, up 72% from 2023. Producers averaged 1.90 tons per acre, up 0.60 tons from the 2023 yield. Harvested acres of other hay, at 460,000, were up 70,000 acres from 2023.

Potato production for 2024 was estimated at 26.1 million hundred-weight (cwt), down 8% from 2023. Producers averaged 395 cwt per acre, down 6% from the 2023 yield. Planted and harvested acres were estimated at 67,000 acres and 66,000 acres, respectively.

Nationally, corn for grain production in 2024 was estimated at 14.9 billion bushels, down 3% from the 2023 estimate.

The average yield in the United States was estimated at a record high 179.3 bushels per acre, 2 bushels above the 2023 yield of 177.3 bushels per acre. Area harvested for grain was estimated at 82.9 million acres, down 4% from the 2023 estimate.

Soybean production in 2024 totaled 4.37 billion bushels, up 5% from 2023. The average yield per acre was estimated at 50.7 bushels, up 0.1 bushel from 2023. Harvested area, at 86.1 million acres, was up 5% from the previous year.

TAKING A GAMBLE IN GILLETT

Let Me Be Frank's Vegas show fundraiser for FFA Ireland trip

Folks in and around Gillett won't need to buy plane tickets and make hotel accommodations to enjoy a Vegas-style show in March as Let Me Be Frank Productions brings "Frank's Tribute to Las Vegas" to town.

The show is a fundraiser for the Gillett FFA Alumni to send some of its FFA members to Ireland in 2026. Only 300 tickets are available for the event.

"Frank's Tribute to Las Vegas" is two hours of non-stop music and laughs where Let Me Be Frank founder Frank Hermans and members of his troupe transform into Reba McEntire, Neil Diamond, Cher, Adele, George Jones and others.

"One of the offshoots of what Let Me Be Frank does is the tribute show," Hermans said. "My wife (Amy Riemer) is probably the best Reba impersonator you will see in the nation. I traveled with this for a while with Let Me Be Frank."

Hermans said the show originated because many of the performers in his troupe look similar to some of the people who have done residencies at Las Vegas casinos. He noted it's a side gig, with the tribute show doing 20-30 performances per year.

In addition to those performances, Let Me Be Frank has performed in Las Vegas itself, specifically the Plaza Casino, for the last three years.

"The first time we went to the Plaza Casino, Adele had just canceled at the MGM Grand. So we got to advertise that, 'No, Adele is really here. She's at the Plaza Casino,'" Hermans said. "It's kind of a cool thing we can hang our hat on that our Adele impersonator was in Vegas when Adele canceled."

Hermans noted the performers act and sing like the people they're impersonating, but they also bring out the funny side of those people. Let Me Be Frank also has an award-winning house band that backs up the performers, something that's new compared with shows they've done to benefit FFA organizations around north-east Wisconsin.

So what is it about "Frank's Tribute to Las Vegas" that makes it a moneymaker for organizations?

"I think it's the iconic personalities," Hermans said. "Elvis will never die. People love Elvis."

GARDENING WITH MELINDA MYERS

Cultivate relationship with king of herbs

Fresh on your pizza, added to your favorite Italian and Southeastern Asian dishes or made into pesto, it's not surprising basil is often called the king of herbs.

Look for opportunities to include basil in gardens, containers and ornamental plantings. Purple varieties add color and combine nicely with other flowers and vegetables. Everleaf Emerald Towers is a very tall and productive plant that adds vertical interest to container and in-ground gardens.

Always wait for the air and soil to warm before moving basil into the garden. Cold air and soil can stunt or damage the plants and increase the risk of downy mildew. You may even see blackened leaves and other damage when temperatures drop to 50 degrees.

Protect tender plants in spring and extend the harvest in fall with the help of floating row covers. These spun fabrics trap heat around the plants while



allowing air, light and water through. Lightweight row covers can be used throughout the summer to protect the plants from Japanese beetles.

Keep plants healthy and help reduce the risk of downy mildew disease by growing basil in sunny locations with plenty of room to reach their mature size. The extra space allows sunlight to reach all parts of the plants, and the added air movement quickly dries the leaves.

Avoid overhead irrigation whenever possible. Instead, use soaker hoses, drip irrigation or a watering wand to apply the water directly to the soil.

Red leaf, Thai and lemon-flavored basil varieties are less susceptible to downy mildew. Relatively new sweet basil varieties

such as Devotion DMR, Obsession DMR, Passion DMR, Thunderstruck DMR, Prospera Compact DMR and Prospera are downy mildew resistant.

Watch for slugs that feed at night, eating large, ragged holes in the leaves. Trap them with shallow containers of beer sunk

into the ground or use a slug beer trap with a built-in cover. The slugs are attracted to the fermenting yeast; they'll crawl inside and die.

Unlike slugs, the Japanese beetles feed and mate in broad daylight. They devour large portions of the leaves, leaving only the

veins behind.

If you see circular clear or black spots on the leaves, the four-lined plant bug is the culprit. The dead tissue may eventually fall out, resulting in small holes.

Manage Japanese beetles and plant bugs by knocking them into a can

of soapy water or treating the plants with an organic insecticide labeled for controlling these pests on basil. Always read and follow all label directions for safe and effective control.

Harvest basil as needed. Regular harvesting will increase productivity and ensure the best flavor. Remove flower buds as soon as they appear to maintain foliage flavor, but don't worry if a few blossoms appear; these are also edible and a favorite of beneficial insects.

Plan to grow and harvest extra basil to make pesto or flavored vinegar. Make plenty to enjoy throughout the year and share with family and friends.

A fine kettle of fish as Lenten season approaches

We are quickly approaching the six-week vigil Christians call Lent. March 5 is Ash Wednesday. I fully appreciate this is a solemn and holy season, a time of penance and atonement. So, of course, I would never make light of Lent, but if, as the Bible says, we are made in God's image, He surely has a sense of humor and will forgive me for going a bit astray here.

In case you were wondering, the English word "Lent" originated from the old German "lencten," an ancient term for spring. Its roots come from a noun "length," not the verb "to lend." It denotes the lengthening of days as the earth moves to the Spring Equinox.

Unfortunately, the second definition is the one I mistakenly applied as a Catholic school second grader. I erroneously assumed it was called Lent because God had loaned



His son to mankind. Therefore, my developing brain simply could not wrap itself around the fact that when Jesus came to save the world, people rejected Him.

Like almost all children, I was not only given to huge misconceptions, I was ever so magnanimous. I big-heartedly forgave the Jewish people who demanded Jesus's execution because if he could, I could. In my teen years, a glorious time when I knew absolutely everything, I was more judgmental.

I was sure I would never have participated in the horrific act of putting Jesus to death. I even went so far as to wish God had waited 2,000 years

and sent His son to Sherwood instead of Nazareth, because we would have acted appropriately. After what's been happening in our country lately, I'm not all that sure anymore.

Perhaps I found the 40 days of Lent difficult in my formative years because the nuns preached that we must sacrifice during Lent; interpreted as "do without something." I always chose candy because it wasn't that hard. Candy was a treat, we didn't get it that often, and I was fussy. I ate only Snickers and peanut M&Ms, which meant I was giving up two things. I suppose I should have felt guilty instead of proud of myself, but there were so many things to feel guilty about that I made up for it easily.

A related sacrifice of living through Lent when I was growing up was the meal menus. It was bad enough that Catholics

couldn't eat meat on Friday, but during Lent the ban on meat in our household extended to Wednesdays. Since there were no Walleye Wednesdays or Friday Fish Frys in our dairy cow-centered world, we had two choices: tuna fish or salmon.

Mom made an edible tuna casserole. I politely ate a small helping so I could get to the good stuff: creamy cottage cheese, buttery baked potato, home-canned stewed tomatoes. Salmon casserole? Yuk. Just the smell of it when Mom opened the can turned my stomach. Then watching her pick out the bones before mixing the salmon with the other ingredients was disgusting. The worst part was the smell of it baking in the oven. The repercussions were deep and have lasted a lifetime. I have never bought a can of salmon, and I never will.

Fresh salmon? That's a

totally different kettle of fish. I am mad at myself that it took me over 50 years to discover grilled salmon. That happened in 1999 when Jon and I took an 11-week road trip to Alaska in a slide-in camper. We were on a small excursion boat out of Seward to see the glacier calve. Dinner was included in the ticket price, which was nice until I learned from the smell that the entrée was salmon. The waves were fierce, so I can't totally blame it on the salmon, but it was the only time in my life I got seasick.

Someone had told Jon that ginger warded off seasickness so he had brought along a box of ginger cookies. I passed; I hate ginger cookies almost as much as salmon. By the time dinner was served, I was too queasy to eat. Jon had eaten half the cookies and felt fine. However, he shared my distaste for

salmon, skipped it and ate both his and my side dishes.

The server felt sorry for me and wrapped the fish in a to-go box. I felt so much better when we got back to the camper that I was hungry. In desperation, I reheated the salmon. That's when I discovered that grilled fresh salmon can be a downright delicious delicacy, even reheated in a microwave.

Oh, dear. Old customs are calling. I feel compelled to sacrifice something during Lent. Observing meatless Wednesdays and Fridays will not qualify because I love seafood. What to do? I better think of something appropriate soon or I'll have to give up candy.

Monitoring bluebird nest boxes helps birds thrive

“Yoo-hoo, anyone home?” I sing as I gently tap tap on the side of an Eastern bluebird nest box. I want to make my presence known before opening the door so any adults on the inside get a chance to fly out. They don’t mind me as long as I am gentle and move quickly. I’m getting ahead of myself; let me back up a little.

The Eastern bluebird is a cavity nester, meaning they use natural cavities, like old woodpecker holes in dead trees, for nesting. In the late 1960s, the Eastern bluebird population reached record lows. In 1978, the North American Bluebird Society (NABS) was founded to promote the recovery of bluebirds and other cavity nesters.

In 1986, Wisconsin created its own affiliate of NABS called the Bluebird Restoration Association of Wisconsin (BRAW). They estimated the Eastern bluebird population had declined by 90% during the preceding 50 years due to changes in agriculture practices, severe weather, invasive house sparrows and European starlings, as well as the loss of nesting sites.

BRAW’s mission is to



increase the Eastern bluebird population throughout Wisconsin in many ways including building, setting up and monitoring nest boxes and expanding public knowledge and enthusiasm for the Eastern bluebird so people will have the desire and know-how to aid these and other cavity nesters in their own communities.

Why do we care? The Eastern bluebird is important not only for its beauty and spiritual meaning of hope, joy and rebirth, but also because bluebirds play an important role in protecting crops from insects. Farmers put up bluebird boxes around agricultural fields so the birds can feed on insects that could otherwise destroy their crops.

When I learned about the opportunity to monitor 14 bluebird nest boxes, I quickly raised my hand. I wanted to be a part of the effort to help this beautiful bird’s population grow. Other cavity nesters that I

may encounter in my nest boxes are wrens, house sparrows, European starlings and tree swallows.

In a nutshell, this is what monitoring a nest box entails. Every week from March through August, I check the nest boxes. I record what I see, (i.e., the bird species, number of eggs, number of

chicks) and then identify and fix any problems such as removing ants or wasps from the boxes. At the end of the season, I send in my records through regular mail or online. This data is analyzed to find population trends.

To help identify the bird species, the BRAW website has pictures to

show what each bird’s nest is composed of, how it is structured and what each bird’s eggs look like. Bluebird nests are cup shaped and woven with fine grass or pine needles. Their eggs are pale blue or white with no spots.

Eastern bluebirds have one to two broods, sometimes three, each summer. I pay attention to when the chicks have fledged (left the nest), so I can clean it out before the female looks for a place to build her next nest. Bluebirds do not clean out their own boxes but are more likely to choose a nest box that is clean, whereas house sparrows and wrens prefer them not cleaned out. So it helps my chances of getting a bluebird to use a box if I clean it out when it is vacated.

Learning about the other cavity nesters is a side benefit. The tree swallows include soft, fluffy feathers in their nests. The territorial wrens will put a small stack of sticks, called a “dummy nest,” in boxes near their own to make them appear to be occupied. The aggressive house sparrows will build their nest on top of another bird’s nest, even with eggs

and chicks inside. Although it may seem that there are many things to learn about monitoring nest boxes, it isn’t hard. It is fun and rewarding. Imagine the joy of opening the box and seeing a nest, then eggs, then babies and then watching them grow. My heart grows along with them. Best of all, it is working. Due to thousands of bluebird nest boxes being installed across the country and volunteers monitoring them, bluebirds have made an incredible comeback.

It will include everything you need to know to get started and provides contacts, real people, to support you along the way. Even better, ask a friend to join you or pair up with someone already monitoring.

Perhaps in the near future, it will be you tap tapping on the side of a nest box, singing: “Yoo-hoo, anyone home?”

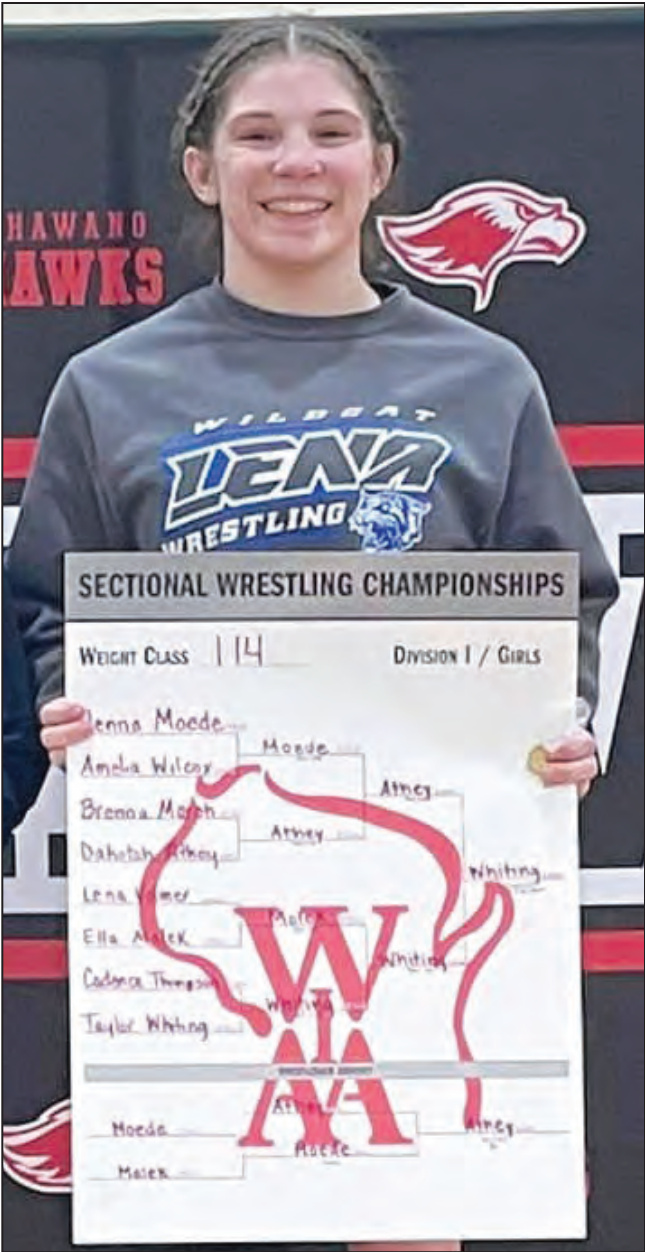

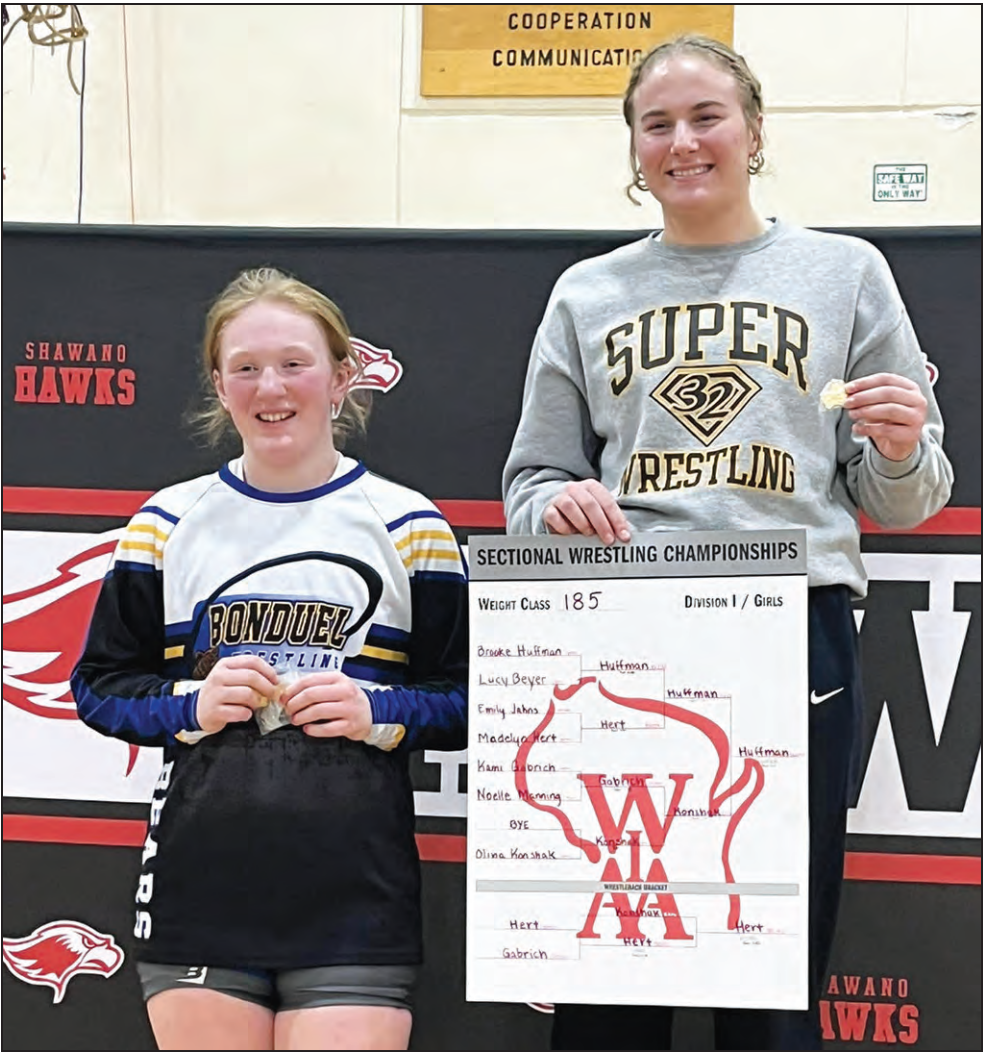

matter of weeks. The debt and its interest were then added to the levy for all property taxpayers to share in paying for.

This is what many at the meeting said the county should do if it needs to balance the budget.

Others suggested placing the wheel tax proposal on the ballot as a referendum.

“Put it to a vote! You work for us!” one unidentified man shouted. “Put it to a vote for us to vote on! That’s what you do. We’ll decide what you do.”

Officials pointed out the cost of such a referendum would be equal to the money the tax would raise in one year.

“I’d much rather pay for that when we get a

vote!” the man responded. “How did we get in this predicament in the first place? Who overspent the checkbook?”

Highway Commissioner Grant Bystol explained the \$2 million shortfall by noting the human services department lost \$800,000 in grants, cybersecurity issues, tens of thousands in additional funds needed to feed the jail inmates due to increased food costs, and more.

“There’s simply not enough for the whole big picture,” Kautza said.

“We’ll squeeze the lemon as hard as we can,” Davel added.

Another unidentified man asked if the \$747,000 would be enough to meet the county’s needs, or if

more or less was needed each year.

“This feels like an easy grab at money,” he said. “Have you exhausted every other opportunity to look for money?”

Kautza said the county board needs to look several years down the road when it considers budgets and tax levies.

“We can’t predict the future,” he said.

Davel said the borrowing, wheel tax and referendum options would all options for supervisors to consider.

The board was scheduled to meet Feb. 26. The proposed wheel tax was on that agenda, after being tabled from January.
