Items can be dropped off at the Main Street Diner in Tigerton. The Tigerton ambulance garage will accept donations in the evening hours.

The Olde Dime Store in Wittenberg will also assist the families in need.

Items needed for women include extra large and large shirts, extra large and medium leggings, large/extra large and medium pants, size 5 jeans, large and medium underwear, medium sports bras, socks and shoes in sizes 7-7 1/2, 9 and 10 1/2.

Men's clothing needed include medium/large shirts, large shirts, large sweatshirts, 36/34 pants, 34/36 pants, 32/30 pants, medium sweatpants, large and extra large boxers, socks and shoes in sizes 9-10, 11 1/2-12 and 13.

For a teen girl, needed supplies include sensory toys, a weighted blanket, size 14/16 shirt, size 14/16 sweatshirt, large teen bra, size 14/16 pants, socks, size 7 youth shoes.

Needed for boys are large sweatshirts and shirts, size 16 pants, large teen boxers, socks, large white T-shirts, size 8-9 shoes; boys size 7-8 shirts and pants, and size 2

Pizza on the Farm set at Schairer's Autumn Acres

Labor Day weekend is filled with plenty of events, including county fairs, festivals, concerts and flea markets.

Pizza on the Farm can be added to that list as well.

Schairer's Autumn Acres will host that event from 3-8 p.m. Aug. 30 at its new location, 154 U.S. Highway 45, Birnamwood.

Karen Schairer is organizing Pizza on the Farm, which is being held three weeks before Schairer's Autumn Acres officially opens for the fall season on Sept. 20.

"Since we're moving to the new place, we wanted to give people a chance to come to the farm and check it out before we have our fall opener," she said. "We thought, why not try Pizza on the Farm to get our customers acquainted with the new place? This is a new event for us.

It's just a PR thing to let people know, 'Hey, we're not over at our old location anymore.'"

A traveling pizza business based in Antigo will cook pizzas onsite in a wood-fired oven.

"We'll have Stoked Pizza Co. coming in to do the pizza," Schairer said. "They're handmade with artisan flour."

A 14-inch pizza will be available for \$17, and visitors will have several toppings to choose from.

"We'll provide drinks," Schairer said. "We'll have our wine bin open with Munson Bridge Wine, and we'll be selling soda, water and apple cider floats. We'll also have our fry wagon, where I do deep-fried cheese curds and butterfly fries."

Once the fall season opens in September, visitors to the farm can check out a

corn maze, pumpkin patch, wagon rides and petting zoo. Don't expect to see that during Pizza on the Farm, however. "We're not going to have our fall stuff open for Pizza on the Farm," Schairer said. "This is basically just to get acquainted with the new place. People are going to come and want to do the corn maze. Nope, it's not ready. They can see the pumpkins, but we're not going to be picking them. I want to save our fall stuff for our fall opener." Schairer's Autumn Acres was held at a different location for more than a decade and would draw up to 400 visitors a day. "We outgrew our old barn, and it needs some foundation work and a new roof," Schairer said. "We decided to shift gears. The greenhouse and market stand is there. It's all going to be in one spot." Schairer knows there's going to be plenty of traffic during the weekend heading north on Highway 45. If things go well, Pizza on the Farm might be held

again down the road. "We'll see how it goes and how the response is," she said. "We're definitely open to doing that. The new location opens up more opportunities for me. Being more visible, that's going to be different for us. People will stop in because they see it. The old place was very quiet, very hidden. The new place, not so much." Schairer's Autumn Acres will be open from 10 a.m. to 6 p.m. Saturdays and 11 a.m. to 6 p.m. Sundays from Sept. 20 to Oct. 31. Scheduled events include live music; horse-drawn wagon rides, and an apple fest and craft show weekend. A trick-or-treat corn maze is planned from 10 a.m. to 4 p.m. Oct. 18, and a pumpkin stroll with more than 100 carved pumpkins on a lighted corn maze trail will be held from 6-9 p.m. Oct. 24-25. Officials break ground at Marion Elementary School

Plans to move middle school students there come in fall 2026

The Marion School District broke ground Aug. 21 on an expansion project that will turn the K-6 Marion Elementary School into a K-8 school.

In November, voters approved a referendum totaling almost \$15 million. The plans for the elementary school are to build a new kitchen and commons behind the school, along with music practice rooms and a concession stand, and then turn the existing food area and gathering place into classrooms for the seventh- and eighth-grade students.

The expansion work is beginning in September, while the classroom renovations will take place next summer once school lets out.

Also taking place next summer will be an update to Marion High School's technical education classrooms and labs. Remodeling the elementary school office and catching up on maintenance at both schools are also on the to-do list. All work is expected to be completed by fall 2026.

The referendum work is expected to increase school taxes for district residents by \$1.71 per \$1,000 of assessed value, which means the owner of a \$200,000 piece of property will pay \$342, and the owner for \$300,000 worth of property will pay \$513.

"We've been waiting a while, and it's exciting that it's starting," said Superintendent Troy

Edwards.

He noted that the district's overall plan is to have all grades in one building, but constructing a new high school plan is in the long-term goals. He estimated the existing high school can last about 15-20 years.

"Building out toward our playground area, we will be eventually, if things go well in 15-20 years with a referendum, add on the high school portion of the 4K-12 complex," Edwards said.

The work on the elementary school office will provide security upgrades that will require visitors to get office staff to open the doors for them when they enter.

"We're adding another level of security, where we'll have everyone buzz into the office, which we have specifically for both buildings," Edwards said. "The community was

very supportive of more security."

The referendum work includes larger classrooms for the elementary school, of which some could become fabrication labs. Edwards said the district plans to apply for three grants where the elementary, middle and high schools could get money to create the labs.

"We would have to put in \$12,500, and the state would provide \$25,000, so you'd be getting \$37,500 to put toward fab lab equipment," Edwards said. "It could be robotic arms. It could be 3D printers. It could be plasma cutters, so all those things will help our academic and career planning and students thinking about careers."

Marion School Board President John Schwartz said a lot of work has been done by staff and the community to get to the

point of breaking ground. The November referendum was the second attempt by the district to approve the expansion work.

"They all do a wonderful job making this a safe, happy place to educate the students of our community," Schwartz said. "These projects that we're doing with our ref-

erendum dollars will go a long way to enhance the already great work in this community and in this district."

Marion Mayor Chris Goke noted that the school district's success is also his city's success, as many communities have a symbiotic relationship between the municipal government and the

school district.

"Although the city and the school district operate separately from each other, we work well together, because the city and the school district understand our success go hand in hand with each other," Goke said. "A strong Marion School District makes the city of Marion more attractive to potential families looking to live here and for potential businesses looking to open here."

The groundbreaking represents more than the start of the construction schedule to Goke.

"It marks a renewed commitment to our children, to our teachers and to generations to come," he said. "With this expansion, the district's residents are investing in a learning environment that inspires growth, creativity and excellence. They are investing in a vision where every child has the opportunity to learn in a space that is safe, updated and designed for success. It's about opening more doors for our children's future."

Besides the groundbreaking, the school hosted a picnic for the Marion community with burgers and brats.

Borrowing, reserves to balance county budget

Shift premium for dispatchers, jailers approved by committee

Members of the Shawano County Executive Committee agreed Aug. 20 to borrow \$3.4 million and use another \$3 from its reserve fund to balance the proposed 2026 budget.

A final vote on the exact dollar amounts is expected to be made when the committee meets Sept. 3.

"I think we broke the seal last year with borrowing that really hadn't been done before," said Jim Davel, administrative coordinator, referring to the county borrowing \$2 million for the 2025 budget. "It's a financial tool to help us set some conditions that we need for running our organization. This is not uncommon."

Short-term borrowing, which the county pays back just 30 days into the new year, is a way to raise funds without increasing the operational levy. That levy is limited by state law, but the borrowing is considered debt service, in which the county has plenty of leeway.

"A lot of counties are borrowing," said Nichole Zuehl, finance director. "A lot of counties are borrowing quite a bit."

She added that even with the borrowing, the county's 2026 mill rate would decrease from its 2025 level.

Wage increase

One of the largest portions of the budget is wages and benefits for employees. Shawano County wages are 8.5% below comparable counties.

Vacancies in 2025 mean the county will have a surplus of \$1.8 million in that account. Of that, \$84,545.08 will be used to provide employees with a 2% pay raise in the fourth quarter of 2025.

"The fourth quarter this year really corrects what should have been done," said Julie Hasser, director of human resources.

Employees will also see a 3% increase due to a market adjustment of the wage scale and another 2.5% across-the-board pay increase for a total pay increase of 7.5%.

Hasser said other counties are expected to provide their employees with a total increase of 3.5-5%.

"It closes the gap, but it doesn't eliminate it," she said of the proposed Shawano County pay increase. "This is fantastic, but we still aren't addressing all of the wage compression issues that we're having. It would be a wonderful message to our employees, but it's one piece of our puzzle, our piece of our budget, one piece of what we need to do to retain our employees."

DID YOU KNOW?

Capital improvement projects were also approved by the Shawano County Executive Committee. These include:

- Highway department roof project: This project is designed to repair the leaking roof that was sealed with a flexible liquid rubberized sealer in 2018 due to the roof leaking at that time. The estimated cost is \$620,000, and the new roof would be placed on top of the existing roof with foam put below the new roof to add extra insulation to the building.

- East highway shop garage door replacement: This project is designed to replace seven overhead garage doors that are deteriorated to the point of needing replacement. These replacements would help repair the structural issues with the building that was originally built in the 1930s. The total estimated cost is \$125,000.

- Cold storage with office building: This project is designed to provide shelter to parks department equipment that remains outside year-round along with adding a parks director office to replace the one in the proposed future rental house. The total estimated cost is \$363,000.

- Rental house remodel: This project is designed to update the house where the current parks director office is located to make into a rental unit to generate revenue. The total estimated cost is \$75,570.

The committee also agreed to hold off on carpet and flooring for the sheriff's department (\$34,000), increase boat rental revenue projection (\$12,000) and increase veterans office hours to 32 hours (\$8,000).

Supervisor Tess Serrano agreed.

"I've never thought that this county was paid properly," she said of the county employees. "They're our biggest asset, and we're not treating them the way that they should be treated."

Shift premiums, lead positions

Lively debate ensued when discussion turned to shift premiums for correctional officers and dispatchers. Both jobs have had several vacancies at any give time in the past year, forcing cancelled days off, low morale and high turnover.

The public safety committee recommended weekend premium pay for dispatchers and correctional officers, as well as adding team lead positions in dispatch.

County Board Chairman Tom Kautza has long opposed these premiums. He does not believe paying employees more will make them happy enough to stay.

"Every county has a problem getting people for dispatch. Every county has a problem with jailers," he said. "Grant (Bystol, highway commissioner) has a problem keeping enough good people for the highway department. Everybody's got a labor problem right now."

Serrano disagreed. "You are focused on one thing, and that is the percentage of the increase that is being suggested," she said. "What you're forgetting is the fact that we aren't even there from the previous however many thousands of dollars of study that's been done on what is needed. We aren't where we need to be."

Supervisor Randy Mallmann said the shift premium is worth a try.

"Trying doesn't work in (the) county, because once it's there, it's there and it's there forever," Kautza said. "Nobody ever reduces anything. That's my whole point of the time I've been here, nobody ever reduces anything."

"How can you?" Serrano asked. "Mental health goes up. Food costs go up. Everything goes up except for the wages."

"It's called efficiency," Kautza responded.

In the end, the additional pay and lead positions were approved, with Kautza also voting in favor.

Roads and bridges

Agreed to previously was money to repair 6.7 miles of county roads and bridges.

It's been a longstanding goal of the county to perform work on 10 miles each year. At \$325,000 per mile, another \$1,040,000 is needed to reach that goal in 2026.

"We have to get Grant the funds to do what he needs to do," Mallmann said. "Obviously, citizens are complaining that we're not getting done what we need to get done already. The more we keep pushing it down the road, it's going to get worse."

Supervisor Randy Young agreed.

"We keep saying we need to do something," he said. "It's finally just time."

Reserve funds

Shawano County has its own rule about its reserve fund — that it should be between 20-25% of the next year's expenses. Right now, that fund is at 30%, which is why officials will use some of those funds.

Using \$3 million in these funds will still leave the reserve account balance closer to 25% than 20%.

Another \$249,000 will be used from the federal ARPA account. These funds represent interested earned and can be used for any purpose.

The public health department has a \$161,000 fund balance, so \$100,000 of that will be used, leaving \$61,000 in the account.

Controlling cholesterol key to good health

High cholesterol, a waxy, fat-like substance found in the blood, can be harmful to a person's health.

That's why ThedaCare is encouraging people to understand their cholesterol levels and their risk for diseases associated with high cholesterol numbers.

Since it has no symptoms, many people with high cholesterol don't know they have it so they aren't treating or addressing their condition. This may put them at greater risk for health issues such as heart disease, stroke, peripheral artery disease and high blood pressure.

Nearly 25 million U.S. adults have high cholesterol, according to the Centers for Disease Control and Prevention. Another 86 million have borderline high cholesterol.

"The first step is knowing your cholesterol levels," said Dr. Abdulmohsin Ahmadjee, ThedaCare cardiologist. "From there, your cardiologist or primary care provider can work with you to manage and treat your high cholesterol."

The body needs cholesterol to build cells and make vitamins and other hormones. At a certain threshold, cholesterol can become problematic. When the level of bad, or low-density lipoprotein (LDL), cholesterol becomes too high, it can lead to a buildup of plaque in the arteries. This may increase the risk for conditions such as heart attack, heart disease and stroke.

Cholesterol is made up of two parts. LDL is known as bad cholesterol because it contributes to fatty

buildup in the arteries. High-density lipoprotein (HDL) is called good cholesterol because it helps clear out the cholesterol your body doesn't need.

A lipid panel is a common blood test that measures the levels of certain types of fat in the blood. This includes total cholesterol, LDL, HDL and triglycerides, which store excess fat from a person's diet. Total cholesterol should be less than 200 milligrams per deciliter. LDL cholesterol should be less than 100 mg/dl, HDL cholesterol should be more than 60 mg/dl, and triglyc-

erides should be less than 150 mg/dl.

"It's tempting to focus on numbers alone, but it's not always that simple," Ahmadjee said. "Your primary care provider will assess your complete health picture to help determine if your cholesterol levels are of concern."

Based on a person's individual risk factors, their primary care provider may also determine at what age they should first have a lipid panel and how often they should complete the blood test. A person's age, gender, family history and heart disease risk fac-

tors all come into play in decision-making.

"When you stay on top of routine care, your primary care provider can more effectively help you track and manage your cholesterol and other heart health risk factors," Ahmadjee said. "Certain factors can increase your risk for developing high cholesterol. Some of these you can control; some, you can't."

Risk factors include type 2 diabetes, obesity, family history of high cholesterol, poor diet, sedentary lifestyle, smoking, age (risk increases as

a person ages) and gender (women's risk increases after menopause).

There are steps people can take to help reduce their risk for high cholesterol, Ahmadjee said. They include but aren't limited to eating a healthy and balanced diet, maintaining a healthy weight, exercising regularly, quitting smoking and limiting alcohol.

Lifestyle modifications alone might not be enough to treat high cholesterol. A person's primary care provider or cardiologist may recommend one or more medications to help manage high cholesterol.

Statins, which block a substance the liver needs to make cholesterol, are common. Other types of drugs include cholesterol absorption inhibitors and medications for high triglycerides.

"Any medication you take can work in concert with healthy lifestyle steps that your doctor recommends," Ahmadjee said. "It's important for you to take medications as directed, as they can help reduce your risk for heart attack and stroke. If you're experiencing bothersome side effects, talk with your provider."

Farm stand in Shawano offers fresh goodies

Full range of produce currently available with more to come

Finally Fresh is a new produce market in Shawano, the first permanent market in the city in recent memory.

Owner Amanda Young is excited to offer farm-fresh vegetables and fruits at this new farm stand. Located on the corner of East Green Bay Street and Rusch Road, the market opened July 22. It offers the convenience of a quick stop to pick up just one tomato, for instance, or even a bushel of tomatoes, knowing that they are fresh and of a high quality.

A full-range of produce is available, including sweet corn, tomatoes, pickles, cucumbers, dill, zucchini, potatoes, green beans and everything else in season.

Young and her husband, Jim Young, bought the 1.3-acre corner lot, just east of Shawano Cinema, in fall 2024. The street address is 1500 E. Green Bay St.

The construction activity on the lot has piqued the interest of Shawano residents.

On the western edge of the lot, a repair and maintenance shop for Briarton Logging company, owned by Jim Young, is being built.

"We had been planning on building his shop eventually," Amanda Young noted.

The building Jim Young had been leasing was sold, so it was a perfect time to build on the lot.

"It's a nice big lot, with room to grow,"

Amanda Young said.

A small store for Young's retail market store is nearing completion on the east end of the lot.

Young plans to sell seasonal home décor in the building, along with canned and pickled items. She's been coordinating with local maple syrup producers for maple syrup to sell, also.

Young will have home décor and kitchen items for sale, crafted by local artisans and artists.

She stressed that they are their own business, their own market. She noted that she respects and admires other markets in the area but has no association with any of them.

"We are our own and unique produce market, and we look forward to building our own, unique brand," Young said. "As people come and the season progresses, we'll have new things. We'll keep our

New owners renovate business in Tilleda

Former Wright's Place turns into Packers-themed bar

A new sports bar called **Pack it in Pub**, N6185 County Road D, Tilleda, is open for business and looking, as their name implies, to pack it in just in time for the Green Bay Packers season.

Owners Holly and Darold Suda remodeled **The Wright's Place**, a time-honored establishment in the small town.

"We had a plan in place. My wife and I and a few friends pretty much handled all the remodeling on our own," said Darold Suda. "Friends from our home in Door County came, parked their campers and helped us out for a couple of months."

Owning a cleaning company prior to this endeavor and wanting to slow their lifestyle down, sort of semi-retiring, the Sudas chose to purchase a bar — it was something they could do together. Looking at a lot of bars in many different towns and especially in small towns, they felt this bar was the right size, especially wanting to do everything themselves.

"We wanted certain things, and this bar fit the bill for us," said Darold Suda.

Currently living in Door County with their cleaning businesses in Green Bay, they are in the process of selling them now — planning as of the first of the year to be living full time in **Pack it in**'s upstairs housing area. Once done in Green Bay, they'll have the time to fully focus their attention here on their new endeavor.

The previous owners, Harley and Mary Wright, owned the bar for 27 years. Along with giving the well-established bar a facelift, the new owners added numerous large, wall-mounted televisions strategically placed to cover all sports.

Wanting a sports bar not a restaurant, the couple removed the food tables, adding bar tables. Trying to accommodate as many people as possible within a small space, Darold built small bar tables attached to the walls, with the means to be

Gillett funeral home receives renovation

Gruetzmacher to host open house in September

The former Kuehl Funeral Home received a much-needed facelift. Under new management by Brent Gruetzmacher, the property at 108 E. Main St. in Gillett is ready for a public tour. “The carpet that we replaced was installed in 1964,” Gruetzmacher said. “You can imagine what orange 60-year-old carpet looked like.”

Interior and exterior renovations began almost immediately after the transition of ownership, which took place in December. “We updated a lot of the interior. I think folks who have seen it before will have a hard time recognizing it,” Gruetzmacher said. Looking at the building from the curb, onlookers will notice the fresh concrete entrance and sidewalk. “The old ramp to the door was not safe,” Gruetzmacher said. “The new sidewalk and ramp entrance will just better accommodate everyone.” Gruetzmacher said that in recent years the Gillett community had felt underserved, because the funeral home was not lo-

cally staffed and the building was neglected. “It was previously ran at a distance. There wasn’t that relationship between the funeral directors and the community, which I think is so vital,” Gruetzmacher said. “A lot of funerals, which could have stayed in Gillett, began ending up in Suring and other nearby cities.” Gruetzmacher also operates Gruetzmacher Funeral Home in Suring, which his father, Ray Gruetzmacher, began in 1983. “I helped my dad with everything that I could possibly do as a kid,” Gruetzmacher said. “I started watering the flowers, then went on to mowing the grass, doing building and vehicle maintenance, and then slowly transitioned

into helping the people at funerals.” The Gruetzmacher family legacy lives on as Brent and his wife, Kim, include their sons in the funeral home operations. “Our 12-year-old says he wants to be just like his dad at this point, but time will tell,” Gruetzmacher said. “It’s a toss-up between that and a race car driver.” The open house will take place Sept. 4, with a ribbon-cutting ceremony from the Gillett Area Chamber of Commerce at 4 p.m., followed by sandwiches and refreshments until 7 p.m. “We want Gillett to have a gathering place again, a place for comfort and compassion on those worst of days,” Gruetzmacher said.

produce fresh and local. That’s very important to us.” By early September, she will have gourds, squash and pumpkins for sale. Mums will also be available. “All of the fall décor will start to roll in,” Young said. “We’ll also be doing ‘paint your own pumpkins’ for the kids, with the purchase of a small pumpkin.” Shelf-stable items like potatoes and onions will be available inside the store through December. Young sources her produce from farms within 45 minutes of the stand. Some days, she visits four farms and other days, she may

only stop at one. She said that it depends on what she needs to replenish or what is in season. She is adamant about having fresh items for sale. “It’s lots of early mornings to stock up, but that’s OK,” she said. Young, herself, has a large kitchen garden. “We have beans, peas, onions, pumpkins, gourds. Also, tomatoes and herbs,” she said. “We do bring some of our produce here to sell at the stand.” Young doesn’t divulge the names of her sources, even when the produce is her own. Growers that she’s

known for a long time, including family friends, are Young’s sources for the produce on sale at the market. She also sources from people that she’s heard who grow great produce and specialize in specific items. “I like to buy from people who grow things like no one else can,” she said. Finally Fresh is the first retail partner of The Rustic Oven. Young currently sells Rustic Oven’s traditional and Parmesan garlic sourdough breads. Fresh bread is delivered to the market by Aspen Brunner, owner and baker of The Rustic Oven, on Monday afternoons.

Partnering with The Rustic Oven came about because Jim Young’s and Brunner’s mothers grew up together in the Bonduel schools. Also, Brunner’s uncle is one of Jim Young’s best friends. “I’ve always loved being outside,” Amanda Young said when asked why she opened the market. “I have a master’s degree in animal science, so I’ve always been outside.” Amanda Young grew up in northwest Iowa. Her husband grew up south of Bonduel, graduating from Bonduel High School. “I got up this way doing my internship here, met my

husband and haven’t left,” Young said. Her internship was with Apple Creek Whitetails in herd health. Her husband was raising deer and selling them to Apple Creek, which is how they met. “We got married and settled here. We live in Bonduel,” Young said. The couple has three children, Henry, 9; Charlie, 7; and Aspen, 4. The children enjoy eating the fresh peas and beans from the garden. “When those things are nice and fresh, they will eat them,” Young said. Finally Fresh plans to sell fresh-cut Christmas trees.

Young noted that they will be very fresh, coming from a local source. When the supply goes down, she’ll simply call her source who will cut new trees and bring them to the market. The market will stay open through December, then reopen in May, when Young will sell hanging baskets and flowers before the fresh produce season starts. The market accepts cash or card. Finally Fresh has a Facebook page. Young said that is the best place for finding out what is available or if something new is coming in. The phone number is 920-609-5149.

There are ways to grow bee-friendly lawns

Boost the bee and pollinator appeal of your lawn by incorporating microclover, self-heal, creeping thyme, crocus, grape hyacinths and other bee-friendly flowering plants in your lawn. You'll create and enjoy a carpet of green with splashes of color and one that requires less ongoing maintenance. The pollinators will benefit from the nutritious sources of nectar and pollen your bee lawn provides.

Flowering bee lawns include traditional lawn grasses combined with other hardy grasses, like fine fescues as well as warm season centipede grass. Kentucky bluegrass and Bermuda grass also combine well with bee-friendly plants but require more ongoing care than fescues and centipede grass. You'll be creating a more diverse lawn that not only appeals to bees but also is more resilient to pests and environmental stressors than traditional lawn grasses. Consult your local university extension service for help in selecting the best lawn grasses

and bee-friendly plants. Like any new addition to the landscape or garden, it does require some effort. Once established, you'll

be spending less time with ongoing care like watering, mowing and fertilization. Start by evaluating your current lawn situation. If grass is growing well in the area, so will a bee lawn. This is not an all-or-nothing endeavor, and like any new undertaking, starting small is always a good strategy. Consider converting

just lesser-used spaces. This allows bees and butterflies to forage in peace. Even though native bees are docile and typically don't sting, neither the kids nor bees want to share the same space. Keep your neighbors in mind when selecting a space for your bee lawn. Those neighbors with pristine lawns may be less

tolerant of your bee lawn. Selecting areas surrounded by walks and drives will also help keep aggressive plants in bounds. Consider starting your bee lawn by overseeding the white microclover into your existing lawn. Clover is adaptable, tolerates foot traffic and drought, and blooms for a long period, providing bees with high-sugar-content nectar and protein-rich pollen. Microclover can also be combined with other bee-friendly plants. You can seed these at the same time or add them later as you expand your bee lawn. Sow microclover seed in late winter, early spring or late summer in the south and early spring or late summer in the north. Outsidepride's Miniclover with Nitro-Coat (outsidepride.com) aids in establishment and allows you to use no-till, minimum-till and broadcast seeding techniques. Even though it is not native, research found clover attracts and supports a diverse group of native bees. Once your bee lawn is

established, mow high, at least 3 inches, so the flowering plants can bloom and support the bees and other visiting pollinators. Leave the grass clippings on the lawn. This is a good practice for both traditional and bee lawns. Short clippings break down quickly, adding moisture and nutrients back to the soil. Once established, you'll only need to water during extended dry periods, and seldom if any, fertilization. Skip the pesticides that can harm the pollinators you are trying to attract. Increase your landscape's pollinator appeal further by growing more bee- and pollinator-friendly plants in your gardens. Helping these important members of our community is good for the environment and all of us. Chiropractic endorsed for low back pain

Most patients suffering with acute mild or moderate low back pain recover in a short period of time using heat or cold packs and maintenance of most of their usual activities. Among those who have greater pain and dysfunction, many seek professional health care.

Recently, the American College of Physicians commissioned an evidence-based review of the scientific literature to advise health care professionals and patients how best to manage low back pain and disability. They used only data from randomized clinical trials (high quality research) to measure treatment benefit.

The results from this panel's research were published in *Annals of Internal Medicine*. This scientific review board found several treatments that demonstrated effectiveness.

For patients with acute low back pain (symptoms fewer than 12 weeks' duration), spinal manipulation, therapeutic massage, acupuncture and superficial heat were effective.

For patients with chronic low back pain (symptoms more than 12 weeks' duration), spinal manipulation, therapeutic exercise, acupuncture, stress reduction and low-level laser therapy were effective.

This guideline specifically instructed clinicians to avoid prescribing costly therapies and those with substantial potential harms, such as long-term opioids, and pharmacologic therapies that were not shown to be effective, such as antidepressants.

Another scientific review published in the *Journal of the American Medical Association* investigated the effects of spinal manipulation for patients with fewer than six weeks of low back pain. This research team also examined only randomized clinical trials. They confirmed the findings of *Annals of Internal Medicine* that spinal manipulation is effective for reducing pain and improving function.

This is very good news for the millions of Americans who suffer with these symptoms, especially because these treatments (under the guidance of a licensed professional) have an excellent safety record.

Finding healthy food in grocery stores easy

ThedaCare health coach provides tips on where the good stuff is

Filling up the shopping cart with healthier grocery options can be a breeze, according to a ThedaCare health coach.

Carey Grieves understands the challenges of healthy eating and healthy grocery shopping.

"Some products are made to keep you wanting to eat more," she said. "They're also heavily marketed and wrapped in eye-catching packaging that's featured in prominent locations throughout the store."

That's why heading to the store with a list in hand and a strategy may make healthier grocery shopping easier, Grieves said.

Grocery shoppers can go old-school with a paper list or use one of many smartphone apps. Before writing a list, consider creating a meal plan, Grieves said.

"Having a meal plan can help you avoid the need for convenience foods like frozen pizza or a trip through the drive-thru," she said. "As you craft your plan, consider your schedule. For example, if your evening is packed with after-school activities, maybe you'll want to plan a slow cooker meal for that night. You also might want some quick go-to options such as tacos made with ground turkey or whole-wheat spaghetti."

It's best to do most of the grocery shopping around the perimeter of the store. That's where most of the whole foods are. Think produce, meats, dairy and frozen foods, Grieves said.

"That's not to say there's no value on the shelves in the middle," she said. "If you stick mostly to the perimeter, you're more likely to fill your cart with the items you need for a healthy diet."

The produce department is at the front of most stores. Loaded with vitamins, minerals and fiber, fruits and vegetables are healthy staples and a must for the grocery cart.

"Try to select in-season produce," Grieves said. "It's abundant and likely cheaper than when it's off season. Plus, it will taste better."

Frozen vegetables and fruits are just as healthy as their fresh counterparts, according to Grieves.

Whole grains can come in the forms of whole-wheat bread, brown rice, whole-grain pastas

and grains such as quinoa, farro, barley and millet.

"A good source of fiber, whole grains can help keep you fuller longer," Grieves said. "Whole-grain foods can serve as the basis for quick, healthy lunches and dinners."

Breakfast cereal need not be a calorie-laden sugar bomb.

"Look for options with little to no added sugar and plenty of fiber," Grieves said. "Eating cereal with milk can give you protein as well."

Good choices can include bran flakes, unsweetened shredded-wheat squares and plain Cheerios. In this aisle, shoppers also often find various types of hot cereal options.

Shoppers can stock up on pantry staples including beans, lentils, tomatoes and tomato

paste. They should look for options that are low in sodium and don't include added sugars.

Look for natural sweeteners such as molasses, pure maple syrup and honey. Compared to processed sugars, natural sweeteners have the benefit of including antioxidants. Use any sweetener sparingly.

Keep a well-stocked spice rack. Having a wide array of spices can help people cut back on sodium use.

"When buying flour, look for whole wheat, white whole wheat or whole wheat pastry varieties," Grieves said. "In the same aisle, you may also find chia seeds and flax meal. Throw some chia seeds on top of your yogurt, and add some flax meal to your smoothie."

Look for snack options high in protein and fiber. Examples include unsalted nuts and popcorn.

Skip fruit juices. They are high in sugar and don't include the benefit of fiber that comes with eating whole fruit. Try unsweetened varieties of sparkling water or iced tea, Grieves said.

If eating meat, choose lean cuts of chicken, pork, beef and turkey. Limit or avoid processed meats such as sausages, bacon and deli meats.

Dairy foods include protein and calcium. Choose low-fat milks and cheeses. Yogurt and kefir give people much-needed protein with the benefit of probiotics that promote good gut health. Choose varieties without added sugar.

"Grocery shopping doesn't have to be a stressful task," Grieves said. "A little prep and planning can go a long way to enjoying a healthier grocery shopping experience."

Chargers take care of business at home

Defense shines in 20-point win over Bears

It didn't take long for the Wittenberg-Birnamwood football team to add a win over a quality opponent to its list of accomplishments.

The Chargers opened the season Aug. 22 with a 33-13 win over Bonduel, a team that was a win away from playing for a state championship last year.

Bo Davis and Kaden Yaeger turned out to be an effective one-two scoring punch for Wittenberg-Birnamwood, as they had a hand in all five of the Chargers' touchdowns.

Bonduel struck first on its first possession, as a long punt return set the Bears up at the Chargers 29-yard line.

Two plays later, Quinn Wesenberg connected with Mason Ballwahn for a 23-yard touchdown pass and the Bears had a 7-0 lead less than three minutes into the game.

The Chargers answered on their next drive with Yaeger's 37-yard touchdown run. The two-point conversion attempt failed, and Bonduel held on to a 7-6 lead.

Wittenberg-Birnamwood took its first lead midway through the second quarter, as Davis capped the Chargers' third drive of the game with a 1-yard run. He was stopped on the two-point conversion try, but the home team had a 12-7 lead.

Bonduel had one more

chance to score before half-time, as Carter Moesch's punt return set the Bears up at the Chargers 12-yard line with just under a minute to go before the break.

Wesenberg found Gavin Hundt in the end zone with no time on the clock and the Bears took a 13-12 lead.

That turned out to be Bonduel's final time in the end zone, as the Bears came up empty on all seven of their possessions in the second half.

The Chargers took the lead for good on Yaeger's 26-yard run with just over three minutes remaining in the third quarter.

Wittenberg-Birnamwood then closed out the scoring with a pair of touchdowns in the fourth

quarter. Davis scored on a 47-yard quarterback keeper on the first play of the quarter and added a 75-yard pass to Yaeger to cap the Chargers' next drive.

"We gave up that touchdown on the last play of the (first) half and could have just folded," Wittenberg-Birnamwood coach Jason Rieck said. "They came out in the second half, really played well and wanted it."

Although the offense came up with some big plays in the second half, the Chargers' defense set the tone for the rest of the game.

"Our defense was phenomenal," Rieck said. "We have a lot of guys returning from last year

and we're going to lean on them. They're not known to throw the ball. They're a good, strong run team. If you can take them out of that one-dimensional game and make them throw it, hopefully, good things are going to happen."

Davis filled in for Bryson Schmid, last season's quarterback, who injured his knee during the summer.

"He earned that last week at our scrimmage," Rieck said. "He really stepped up and did what we wanted. We said we don't have to use Kaden at quarterback with his speed. We can trust Bo."

The Chargers also counted on running back Alberto Sanchez.

"We worked Alberto a lot up the middle," Rieck said. "He was getting positive yards, and that's going to open things on the outside. We didn't dominate up front, but when you're getting 3, 4 yards a pop, that's going to wear on a defense, and you're going to get a big play every once in a while."

Both teams headed into the 2025 season after making the WIAA playoffs last year. Bonduel dropped a 34-29 decision to Grantsburg in a Division 6 state semifinal game, while the Chargers fell to St. Croix Falls 21-20 in the second round.

Bonduel is the defending Packerland Conference champion, while Wittenberg-Birnamwood placed

second behind Division 5 state champion Stratford in the Central Wisconsin-Large Conference last season.

"They're a great team," Rieck said. "(Coach James) Westrich is a great coach over there, and we knew they were going to be prepared and disciplined. That's why we have them on our nonconference schedule."

Rieck expects this season's CWC-Large to include a number of solid programs, including Stratford, Amherst and Weyauwega-Fremont.

"It's a juggernaut conference," he said. "You can't take a week off. You have to prepare every week because one loss can cost you your playoff hopes."
