Commission sees work on rec center

Facility expected to reopen to public in mid-August

The Shawano Recreation Center is set to reopen in less than three months, and the Shawano Parks and Recreation Commission got a chance to see the latest work done in the facility during its May 20 meeting.

Parks and recreation director Matt Hendricks told the commission the center will reopen in mid-August with a planned ribbon-cutting ceremony Sept. 12. He said 8Pine, the company managing the \$5.25 million renovation project, needed three weeks to inspect the building and make sure it's ready for occupancy.

Hendricks said that the pool is remaining the same size but looks better because of the amenities that are coming with it, including furniture for families and others to watch during swim lessons or pool sessions.

"They're going to make life in the pool better," he said. "Visibility along the pool area wasn't great."

Hendricks also showed off the area where the computer lab is being set up, noting there's a movable wall to make the room bigger for special events, and all the furniture can be rolled around depending upon the occasion. He noted the area can also allow for winter events to take place through the center.

"Think of library computer use – applying for jobs, coming in to do research," Hendricks said. "It could be for high school kids doing a chem project. It could be a 4-H club that's wanting to meet. There are going to be two setups like that in the building."

He added that the area can be used separately from the rest of the building so that, if there's an event on a Sunday when the recreation center is normally closed, the space can still be used with the remainder of the recreation center still locked up.

"It doesn't open up basketball games or indoor soccer, but it opens up art classes, and it opens up yoga classes," Hendricks said. "It opens up anything you can do with moderate movement."

Locker room facilities are still in progress with individual shower facilities expected to be installed soon, ending the era of group bathing, according to Hendricks.

A multipurpose room and the new athletic facilities are mostly set up, but

The collective and individual successes, failures and challenges of the Bonduel High School class of 2026 were noted by several speakers at the May 22 graduation ceremony.

Salutatorian Hailey Spates was the first to mention them.

“No two journeys to this stage were alike,” she said.

Spates recounted that in the small graduating class, many of the students grew up together, shared classes, shared teachers and shared memories of growing up in the small, tight-knit community.

“Today, all of our different stories, every challenge, every success, every moment comes together in the same place. This stage. This moment. This accomplishment.”

Her message was later echoed by valedictorian Mariah Wondra and social studies teacher James Radish.

One of the traditions of the Bonduel School Board is that the newest member addresses the graduates. This year, that honor fell on Ashley Pierce.

She said that, as a new mother, she discovered children’s books, often contain prophetic messages.

She shared three of them with the students.

- To get something out of your community, you have to put something into it.
- There has never has been, nor ever will be, another person just like you.
- Don’t allow yourself to become stuck out of fear.

Wondra noted the many accomplishments of the class of 2026, including the highest class ACT score in years, solo and ensemble awards, appearances at state WIAA tournaments, one-of-a-kind art projects and more.

She also touched on the challenges overcome by the class and by individual students. She said her classmates overcame the challenges, learned from them and became stronger because of them.

“Let your goals drive you, but don’t let them define you,” she said. “Down the road, if you come up short, know that it’s OK. Life isn’t simply a matter of wining or losing unless you let it be. Don’t be afraid to set the bar high.

“Take the time to just enjoy life.”

County gets state grant

Funds designated for one-time expenses

Local municipalities seldom get federal or state grants with no strings attached regarding how the money can be spent.

That is not the case with a \$200,000 windfall from the Wisconsin Department of Administration. The same amount of money was given to each Wisconsin county with a Native American tribe in its boundaries.

Shawano County departments were asked to submit requests for the funds, and those totaled \$385,000.

At the May 20 executive committee meeting, supervisors reviewed the requests and opted to spend \$170,000 and keep the remainder in reserve.

Nichole Zuehl, finance director, noted the four-week trial of Michael Ingold put the district attorney and clerk of courts offices over budget for the year, so there was a request to bring those budgets back in line.

However, several supervisors said they preferred the grant be used for one-time expenses rather than salaries or budget overruns.

“I’d rather spend this money on more material things than covering budgets and stuff,” Supervisor Randy Young said.

Later, Chairman Tom Kautza brought up the recent severe flooding and its effect on the county. No requests were made for these expenses.

“Do we give \$5,000 or \$10,000 to the highway department for their budget overrun from the last storm?” he asked. “That was three days straight, and that had to put an awful hole (in their budget).”

Sheriff’s Lt. Chris Madle, the emergency management director, said that

amount could be included in the county’s overall request for state disaster aid funds.

“For fairness, looking at other departments being over budget, then you also have to take in consideration the other departments that were mentioned about being over budget because of the jury trial,” said Julie Hasser, human resources director and interim administrative coordinator.

“I wonder if we should hold off until the end of the year to see how bad we’re over budget on some of these,” added Supervisor Kathy Luebke.

Expenses approved were:

- \$15,000 for a new audio system at the county park pavilion.
- \$4,750 for the treasurer’s office for testing and email notification software.
- \$10,000 for code enforcement software in the planning, development and zoning office.
- \$53,000 for a new rescue boat for the sheriff’s department. The money will be reimbursed by the Department of Natural Resources over a five-year period.
- \$5,000 for an industrial paper shredder for the register in probate.
- \$5,000 toward a library fundraising feasibility study.
- \$15,000 for human resources to transfer from the old to a new, more efficient and cost-effective management system.
- \$30,000 for two backup generators at 911 towers.
- \$6,600 for a mortuary lift and \$750 for a stretcher for the coroner.
- \$4,900 for mobile screens and carts for the library to be used for video presentations.
- \$20,000 for two years of well testing in the northwest corner of the county and around the Stockbridge-Munsee area.

The remaining \$30,000 will be kept for emergencies or other unplanned expenses. There is no end date on when the money has to be spent.

Gresham gives 17 grads diplomas

Valedictorian: Classmates knew each other well

Gresham Community School sent 17 graduates out into the world May 22 with diplomas and messages of hope.

Most of the graduates have known each other since kindergarten, according to valedictorian Riley Hohensee, which means there has been no hiding for the class of 2026, because everybody knows each other in the school.

"We didn't just grow up together. We grew into ourselves together," Hohensee said. "In a world where people come and go, most of us have been side by side since kindergarten. We learned our ABCs together, survived middle school together – which might have been our greatest accomplishment – and somehow made it all the way here to graduation night."

Hohensee recounted how his grandfather received his diploma from Gresham 50 years ago, and he said it wouldn't be that long before he and his classmates would be looking back on high school as a distant memory.

"Not every part of high school was easy, but even the hardest parts taught me resilience and self-respect," Hohensee said. "I learned that other people's opinions don't define your direction. Only your choices do,

so let's be our most authentic selves." Hohensee said something he'll miss is the simple, everyday moments, being a team and knowing the people surrounding him. Even though the class is now heading off in different directions, he said, he knows there is no limit to the impact that the graduates can have on the world.

"We carry something in common – the lessons, the friendships and the resilience we've built right here in this small but mighty class," Hohensee said.

Graduation is the end of one chapter, but it's not the end of the story, according to salutatorian Allie Cerveney.

"I remember when I was an underclassman, I couldn't wait to be 18

and graduate," Cerveney said. "Now that I am, I don't understand why I was so excited."

Cerveney looked back on her memories and recounted how nap time was her favorite time in kindergarten. She also told the crowd how she was married in third grade and divorced in fourth grade. She described middle school and high school as scary at times, but the class of 2026 made it through because they did it together.

"After spending every day together for the last 12 years, I can see us as more of a family," Cerveney said. "Even those who haven't been here the whole time, it feels like you've been here all along."

Teachers speak out on board's votes

They warn legal action could come from decisions

The Shawano School Board is still feeling the heat from a recent vote in closed session to issue nonrenewal notices for contracts to three teachers, even though the board voted again on the matter in open session.

Shawano Community High School teacher Matt Brunette read a letter May 18 at the board meeting on behalf of another teacher warning that the actions taken in secret could result in legal troubles for the Shawano School District due to "a growing number and severity of issues." When asked by a school board member who wrote the letter, Brunette declined to disclose the teacher's identity in public.

According to the letter read by Brunette, poor video and audio recording of meetings has made it difficult to keep up on what has happened as the board has taken steps to cut \$1.7 million in expenses from next year's budget for the school district. This has included the nonrenewal notices, not filling positions vacated by staff resigning or retiring, and cutting course offerings, according to the letter.

Brunette said through the letter that some of the actions involving the nonrenewal notices could be illegal.

"Two grievances related to improper disciplinary actions resulted from alleged improper communications between staff and board members and alleged improper and illegal actions surrounding nonrenewals have been properly submitted in late April and the fifth of May," Brunette said through the letter. "The former was denied on the basis of timeliness by the superintendent and the review by the board was immediately requested by the grievant, but no action by the board appears to have been scheduled or taken as required by board policy PO3340."

In both grievances, it was requested the matter be brought before an impartial hearing officer, as required under the policy, according to the letter.

Another grievance was

filed May 17, according to the letter, specifically referring to the board votes on the nonrenewal notices. Initially, the board voted in its April 27 closed session to issue the notices. Another vote took place at a May 11 board workshop to meet the state deadline of May 15 for the notices.

According to the letter as read by Brunette, the votes involve "statutory violations of the open meeting law."

Shawano Community Middle School teacher Dan O'Connell, who has been vocal in other meetings about the board's actions in recent months, said his own attorney has also found the recent closed session vote suspect. He reiterated a stance taken by Jennifer Schmidt, president of the Shawano Education Association, that the vote for the nonrenewal notices should have taken place originally in open session.

"School boards should not vote in closed session when it comes to cutting positions," O'Connell said.

O'Connell called out the district's attorney, Geoff Lacy, for first saying the notices could be voted on in closed session, only to reverse his stance two weeks later, saying that the vote in open session was to protect the district's interests and to avoid any appearance that the district did not want the vote to be public.

"Is it possible to be cautious against allegations after they have already been alleged?" O'Connell said. "Again, Ms. Schmidt already warned against this two weeks before."

O'Connell said the district received a public records request May 12, the day after the open vote on the notices.

"Members of the board, we need you to ask yourself if you can put your confidence in the competency and actions of the district's leadership and legal counsel," O'Connell said. "The district's legal counsel is apparently not paying attention to what you are doing, doesn't fully understand the law or is willing to let the district cross the legal line."

City sets record straight on courthouse

Statements by Shawano County officials and its consultant that the city of Shawano supports its plans for a new courthouse and jail complex are not going over well at City Hall.

On May 13, city officials sent a letter to the county board and county administration admonishing them for making "inaccurate statements" and attributing them to city officials.

"The city has not taken any position on the project, directly or indirectly, nor does it intend to," according to the letter. "Our administration and elected officials remain committed partners and will continue to defer to the county's authority and decision-making for this project."

The county continues making plans for a \$121 million project that will include a new courthouse, 150-bed jail and auxiliary services for the jail, all to

be located west of the current courthouse and sheriff's department.

City officials said any misattributions will be addressed privately with the parties involved.

At the April county board meeting, supervisors requested city officials attend a future meeting, so supervisors could hear directly from them their thoughts on the building plans.

"Moving forward, the city will not offer further

public comments or attend any meetings to address opinions or false statements being made without our knowledge," the letter reads.

City officials said they remain willing to assist and support the county as necessary.

The letter was signed by Mayor Bruce Milavitz, City Administrator Eddie Shepard and City Attorney Keith Steckbauer.

City seeks disaster aid to repair culvert

Heavy rains and flooding on April 12-13 and beyond led to several area culverts being washed out and roads closed due to high water.

The city of Shawano was no exception. A culvert washed out on East Richmond Street east of South Airport Drive, and it cost the city \$5,000 to repair it.

However, state disaster aid will help cover much of that

cost.

At the May 13 Shawano Common Council meeting, aldermen approved a resolution seeking reimbursement.

“This is really the extent of our public flooding issues that we had,” City Administrator

Eddie Sheppard said. “We had a culvert wash out on Richmond Street, and as being part of a disaster declaration area, if you have any damage to your public infrastructure related to the flooding, you’re eligible for 75% replacement costs plus

50% of the increased cost to reconstruct it.”

Sheppard said that because of the dam at Sturgeon Park, most of the city’s waterways area are not in the floodplain.

Shawano schools launch social media campaign

Officials hope to shed light on school financing through videos, articles

During the summer months, the Shawano School District will be posting videos and articles to address school finances. District officials hope this will help those who disagree with recent cost-cutting decisions to understand why those decisions were made.

Superintendent Kurt Krizan sent out a letter May 18 to staff members and the community, noting that the community cares about the schools and the people who make up those schools, and that communication on the issues was important. Krizan wrote that a recent bill that was considered by the Wisconsin Legislature that intended to provide additional funding for special education in schools did not pass.

"Recently, we learned that one-time funding from the state budget surplus was brought

forward for a vote in the state legislature," Krizan wrote. "As of this writing, the measure did not pass. We don't know what future actions, if any, may emerge to partially use the state's budget surplus to provide one-time support for education. However, many complicating factors continue to contribute to the ongoing school funding challenges faced by districts across the state."

A bipartisan \$1.8 billion budget surplus plan made it through the Wisconsin Assembly on

May 13 but was rejected by the Wisconsin Senate that night as three Republicans crossed the aisle and joined the Democrats in rejecting the proposal. Of the total, \$600 million for special education reimbursements and general school aid was part of the deal.

Krizan wrote in an email to NEW Media that it was unclear how much the bill would have helped Shawano's public schools.

"I can't honestly answer this question, as we were never

provided with an exact amount that we could have expected or the timeline for distribution of funds," he wrote.

Krizan hopes that community members can learn through the videos about why districts like Shawano's are finding it difficult to provide services, with funding from the state estimated to be \$3,500 per student below the cost of inflation. The videos are providing information delivered by the Wisconsin Association of School Boards, Wisconsin Association of School Business Officials and the Wisconsin School Public Relations Association.

"To help us tell this story, we are going to rely on information that has been composed by several statewide organizations to help districts like ours explain the school funding challenge facing all Wisconsin school districts," Krizan wrote in the letter to the community. "I am happy that our professional organizations have started supplying materials that we can all use, because budget reductions are not just here in Shawano. They are sweeping across almost every district in the state. Schools are facing major staff reductions, school closures and the

elimination of programs across the board."

New videos are expected to be posted every two or three weeks with more details on the different funding systems for schools, including the difference between operating funds and capital funds.

"Later in our series, we will post about how state aid and increasing costs impact us locally," Krizan wrote in the community letter. "I also will be describing the difference between operating funds — those that are being strained and causing our budget reductions — compared to capital referendum funds, those that are being used right now to repair and upgrade our buildings. In later articles, we will address other factors affecting our schools."

For those district residents who don't utilize computers or access the internet, Krizan informed NEW Media that the district is looking at sending consolidated information out in the mail.

Dispatch center awarded grant for new equipment

County's share totals over \$70K

The Shawano County Dispatch Center was awarded an over \$700,000 grant for new equipment, but elected officials have to sign off on it first as it comes with a need for county funds that aren't part of the current budget.

The grant is from Round 2 of the Wisconsin Department of Military Affairs Office of Emergency Communications PSAP Grant. The application was due in February and awarded May 1.

The grant award total budget is \$705,829, and the county would be responsible for a 10% match.

"It sounds strange to say only \$70,582.90," said

Kasey Cross, communications supervisor. "I am a taxpayer in this county, too. I don't want to do anything that is going to put more strain on taxpayers than what we already have to contend with."

The total of the remaining 90% is \$635,246.10.

Grant money will help cover the costs of upgrades to the dispatch radio consoles and backup consolettes, upgrades to the phone system and an online subscription to improve the efficiencies of mutual aid fire dispatching.

"The new console that they're offering us will bring us up to speed, keep us in communication with our patrol guys, link to our surrounding counties that have that technology built in already," Cross said.

Upgrades to the dispatch consoles will better incorporate the tools that

are available with the radio upgrade the sheriff's department did in January.

"Our current equipment does still function but not as seamlessly as it would if we complete the dispatch equipment updates," Cross said. "For our dispatch center to communicate with neighboring counties that do not operate on the same frequencies that we do, we have to set up radio patches to make communication possible. Thankfully, it is not something that we have to do often, but in the event that something critical takes place, establishing the patch takes time and background coordination to make sure the correct channels are selected."

For Shawano County deputies using the new portables that came along with the January upgrade, the radio service created some permanent patches

on existing consoles so they can stay in contact with dispatchers regardless of what frequency the deputy is using.

"We have had a few hiccups with the setup when we've lost the connection briefly and have one console (out of our five total consoles) that is programmed to maintain the patch connection and cannot be used to page fire and EMS responders," Cross said.

The dispatch center currently operates on the Motorola Callworks platform and has about five years left on a contract with the company.

Motorola has decided to discontinue development of the Callworks system, but it is contractually obligated to honor the contract.

"What Motorola has told us moving forward, they're

not going to be supporting (the phone system)," Cross said. "Within another five years, we have to get a new one. It's not an option. We have to do something."

Motorola is investing development in its cloud-based Vesta products, which is what is being offered to the county now.

"Their proposal takes into consideration what we have already paid for Callworks and applies credits toward all of the equipment that would be needed to complete the transition," Cross said. "This amounts to considerable savings now."

The county has the option to continue with the remainder of its Callworks contract and not spend anything, but at the end of the contract, it would have to decide a next step.

"I don't have numbers on what the cost would be

without the credits, but a quote I received about a year ago on the previous version of Vesta was in excess of \$500,000," Cross said.

Finally, the grant would cover a subscription to the HIEBA software application specifically related to mutual aid for fire dispatching.

Cross explained how the program works now.

"Every department has cards for different scene circumstances with the agency and equipment they will need," she said. "This saves them time to just call out a card number instead of a drawn out list over the radio of who and what they want. Dispatch has a copy of every Shawano County fire department card set. Once they call out a card, we go to that particular card and contact the responders needed."

Housing projects get go-ahead from council

Over 100
condos could
be added
over time

Shawano Common Council members agreed to swap land in and out of a tax incremental finance district and rezone another parcel in hopes of spurring a pair of developers into building upwards of 100 condo units in the city.

At the May 18 meeting, aldermen altered the boundaries of TID 7 to include all of the land owned by HNKZ LLC. The land is northeast of Hillcrest Primary School and east of Piccadilly Circle and Timber Trail.

"We are maxed out at our overall TID value. So when we do have amendments that we are making, we have to make corresponding reductions to the district," City Administrator Eddie Sheppard said about the change to the TID 7 boundaries.

"We did the same thing for TID 6 last year when we were taking some parcels out and moving some

parcels in. When you create these boundaries, you take your best guess as to where projects are going to happen. You aren't able to just grab the whole thing. You have to be mindful of what the values are, what's likely to happen. In both of these instances, a couple of panels where we didn't anticipate much happening is happening."

The council also approved a developer's agreement with HNKZ LLC (Pine View Estates Development). All of the company's property needed to be included in the TID for the project to move forward, Sheppard said. Land along Beauprey Road was removed to accommodate the addition.

"They're going to commit to putting the infrastructure and the roadways in for most of a 64-lot layout," Sheppard said. "We're tying the development agreement to 35 developable lots over seven years, and at the same time, we're working with them to build out a regional stormwater pond not only to serve their development, but we have significant stormwater with all of the development that happened on Engel Drive. They're essentially oversizing it, so

we can use it as a public stormwater, which we'll then take over management of."

HNKZ will spend \$2.18 million on infrastructure and roads.

The city will commit \$206,661 in TID dollars for the regional stormwater pond.

The city will also purchase six corner lots for \$120,000 in phase 2, hoping to make them into a park.

Finally, HNKZ will have a forgivable loan of \$380,000 if they build 35 condos in seven years. If not, city can recuperate a portion of the loan for any condos not completed.

Phases 1 and 2 will result in 64 lots. A potential phase 3 would become a single-family neighborhood.

"As soon as they get approved through council and through joint review board (in June), they intend to start digging," Sheppard said.

In a related matter, council members agreed to rezone 45.8 acres at 221 N. Airport Drive (across from the airport) to spur development there.

Sheppard said the city has been working with a developer to make a project financially feasible. The land is owned by

Dallas Waterstradt.

"To do that, the proposer of the project needs to get comfortable, knowing that: 'Hey, if I'm going to spend a bunch of money, by the end of the day, the city's going to actually allow for the zoning change,'" Sheppard said.

This project would affect the north portion of the parcel.

"In this case, the developer's looking to do some residential units — some low-density, multifamily,"

Sheppard said.

The rezoning was approved pending approval of a development agreement, which is expected to happen in June.

At the April 16 meeting of the city's industrial and commercial development committee, it was noted the proposed project would include construction of 40 condo units for rentals on the north portion of the property. The 1,400-square-foot units would each have three

bedrooms, two baths and two-car garages with no basements. The condos would rent for about \$1,700 per month.

Sheppard also reported that a developer is showing interest in the south portion of the Waterstradt property. The project could include construction of four 20-unit apartments and possibly a clubhouse with a recreational area.

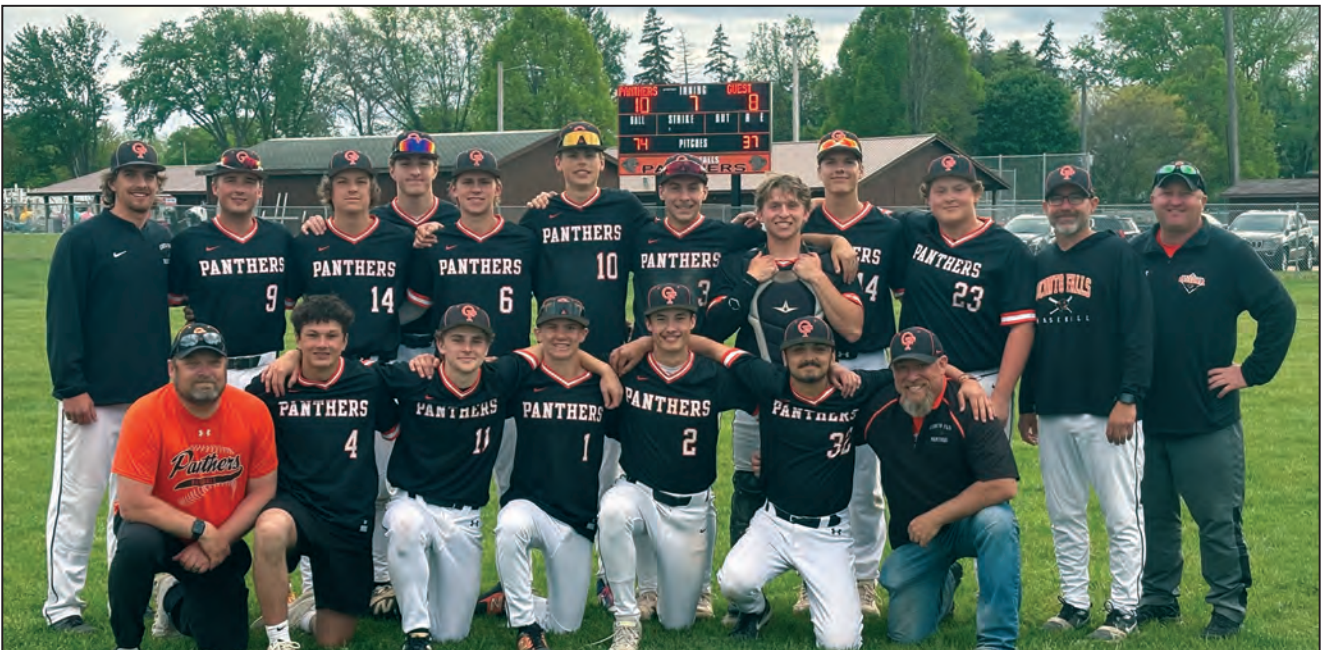

Stubborn Brothers slicing its way into pizza market

Brewery tests cheeses on patrons to determine best ingredients

Free pizza? In Shawano? It happened. Free pizza was the ticket May 15 at Stubborn Brothers Brewery to help choose the cheese that will be featured on the pies at Stubborn Slice, the new venture of Erik and Aaron Gilling, owners of Stubborn Brothers.

Classic Neapolitan style pizza and thin crust pizzas will be on the menu.

Neapolitan pizza originated in Naples, Italy. It has a thin dough with high edges. A few simple, quality ingredients are typically featured, rather than heavy toppings.

Three slices of pizza were offered to each customer at the tasting, along with a rating sheet.

Customers were encouraged to focus on the qualities of the cheese. Aaron Gilling said that the crust and sauce were not what they would be making their pizzas with.

Customers rated the three cheeses on a scale of one to five, with five being the best. The brands of the cheeses weren't revealed, so the raters would focus only on the taste and consistency.

The results of the tasting haven't been revealed.

The Gillings don't have an opening date yet for Stubborn Slice.

"We are waiting for approval from the state of Wisconsin," Gilling said. "We are constantly working on improving and getting ready to open."

Lily Miller was hired by the Gillings to develop their pizza offerings.

"She went to Pizza University in Maryland and another program as well to really dial in on making pizza," Gilling said. "She's an amazing and talented part of our team."

He said that she is dedicated to making the best pizza around.

Pizza University is a pizza school that

helps passionate cooks learn how to create, innovate and learn about the world of pizza.

Miller chose most of the equipment that will be used at Stubborn Slice, such as a special oven that operates with gas and wood fire.

"She's been really amazing in doing

Poppies show more than veterans' sacrifice

Memorial Day weekend may prompt visions of the red poppy known as Flanders or corn poppy (*Papaver rhoeas*). This beautiful flower inspired the poem *In Flanders Field* written by the Canadian doctor Lt. Col. John McCrae, who ran a field hospital during World War I.

The red poppy continues to symbolize sacrifices made by veterans. On National Poppy Day, celebrated the Friday before

Memorial Day weekend, members of the American Legion Family distribute crepe paper red poppies, requesting donations used to support veterans.

The flower has a long history linked to bloodshed and death as well as life and fertility. While you may associate it with World War I, it was also the subject of a medieval poem, *Le Chanson de Roland*, where the blood red flowers of this poppy were associated with a battle during the reign of Charlemagne.

Its more positive past includes the Greeks' dedication of the flower to Aphrodite, the goddess of vegetation and its association with Ceres, the Roman corn goddess. Pictures show her holding sheaths of corn and seed pods of this poppy. In Great Britain it also symbolized fertility and remembrance, perhaps inspired by the longevity of the seeds that can sprout and grow after being dormant in the soil for up to 80 years.

Corn poppy is native to Europe and Asia and arrived with imported agriculture seeds. Before extensive use of herbicides, it could be seen growing in farm fields which inspired the common name, corn poppy.

Its beautiful red flowers were once used as dye, for coloring red ink and medicinal purposes. The individual flowers only last a day but the plant blooms for months, leaving an abundance of seeds behind.

Make sure they are not invasive in your area before adding them to your garden. In areas where they don't pose a threat you can enjoy them in the garden, use as cut flowers and watch for visiting pollinators. Plus, the deer tend to leave these plants alone.

Plant the seeds directly in the garden in fall or early spring. Allow the plants to set seed if you want them to return each

this,” Gilling said. It was Miller’s idea to do the cheese tasting, to try out a few different cheeses and get people’s feedback.

“Sometimes you think that this is the best product, but there’s also a thing about it being specific to where you live, your regional area,” Gilling said.

According to Gilling, there are cheeses in Italy that aren’t popular here. He’s committed to having the best cheese for the local taste.

Stubborn Slice will be in the old Reinhold Shoe Store, right next to the Stubborn Brothers Brewery at 220 S. Main St. in Shawano. Plans are to do

carryout, with very limited sit-down.

“We’re trying to treat it as a separate business,” Gilling said. “Our goal is, if we expand and open up more breweries, we don’t know if we’re going to do our full menu at other locations.”

He said that they would probably focus on their pizzas if they go to other locations.

Gilling said that Shawano has a number of pizzerias in town and noted specifically how their friends at Luigi’s do a great job.

“I can’t give anything but compliments about Luigi’s,” he said.

year. When the seeds drop on bare soil and are left undisturbed, seedlings will appear in next year’s garden. Just thin out unwanted seedlings and add them to the compost pile.

Grow Flanders poppies in full sun to light shade and those in hotter climates should plant them in a spot with afternoon shade. Although tolerant of a wide range of soils, they prefer those that are moist and well-drained. They do not tolerate wet, soggy conditions. Mature plants

will grow 12-30 inches in height and are often used in naturalized, informal, or cutting gardens.

Flanders poppy’s close relative, oriental poppy, is a popular perennial garden plant and cut flower. Grow it in full sun or partial shade in well-drained soil. Enjoy the late spring to early summer blooms. Don’t worry when the foliage disappears after flowering. This is normal and you can partner it with a later blooming perennial to cover the void that’s left

in your garden.

Menominee Pageant partners with Smithsonian

The Menominee community will play a role in the United States' 250th anniversary celebration. "Of the People: The Smithsonian Festival of Festivals" will host about 40 festivals around the country, with the July 29 production of the Menominee Pageant being the only event held in Wisconsin.

A revived tradition of the Menominee Nation, the annual production is a show of pantomime, live music and Native dance that marks the beginning of Menominee Powwow week each summer. Since the pageant's renaissance in 2016, the College of Menominee Nation has imagined the event as an opportunity to engage performers and storytellers across generations, bridging heritage with contemporary theater practices and highlighting culture bearers of all ages.

Staged in the famed Woodland Bowl at dusk, the show offers patrons a chance to partake in a cultural exchange that the Smithsonian concurs will further the mission to "commemorate, celebrate and contemplate" our shared national milestone.

Pageant attendees will be treated to a new script titled "Timeless Teachings." Written by the

Menominee Pageant Players Guild, the 2026 show includes adaptations from "A Sampling of Menominee Legends," assembled by the Menominee Tribal Historic Office, and "The Legend of the Dells" by the late Theresa Wescott, as well as additional songs and performances from

Menominee youths sharing their language and culture.

Joining existing sponsors, the Wisconsin Arts Board, the Menominee Powwow Committee, and Taproot Artists and Community Trust, this year's Smithsonian collaboration enables CMN to purchase new lighting and technical equipment that will enhance the special effects, as well as a designated sound system that Menominee elders requested be placed at the top of the amphitheater.

Because encouraging the next generation is central to both Menominee teachings and the

Smithsonian festivals' ideals, this summer will also extend intern and mentorship opportunities to emerging voices.

While the union between the Menominee Pageant and the Smithsonian is unique to America's semiquincentennial, the value of the show is as evident now as it was during the initial run that spanned from 1937 into the 1970s.

"The pageants are the highlight of my year," stage manager Melinda Cook said. "I have been a part of the planning since

the start of the revival pageants. I believe the pageants provide an avenue to share Menominee history, language, songs, dancing and community."

Pageant actor Karen Ann Hoffman agrees about the value of the shows.

"Being part of the Menominee Pageant is a highlight of my year," Hoffman said. "It's fun. It's a welcoming group. It's a chance to use Menominee language while we act out and celebrate traditional values."

Cook and Hoffman are members of the team writing this summer's show. Dawn Wilbur is also an integral person in the process of guiding a show from concept to script to staging.

"My mother and grandfather's connection to the past pageants inspired me to be a part of the shows," Wilbur said. "I enjoy planning and creating the most recent plays and scripts. I believe it can help portray our legends and help our people, especially our youth to learn about our history."

This summer's cast and crew have yet to be set, as auditions will be held on CMN's Keshena campus from 5-7 p.m. June 8. Interested members should arrive at the campus atrium or contact me through the college's website or phone switchboard.

Non-Native pageant veteran Brian Marquardt expressed the sentiments of the Pageant Players

Guild concerning anyone who is debating joining us this summer.

"Anyone interested in attending pageants should attend. Those who wish to be part of the show should simply audition. Regardless if they're Native American or not, I'm certain they all will enjoy it," Marquardt said.

"The 250th anniversary is a time to celebrate our extraordinary cultural democracy, to visit with the people, places and traditions within it and to contemplate our shared future," wrote Clifford Murphy, director of the Center for Folklife and Cultural Heritage. "By taking the Folklife Festival beyond Washington, we recommit to our original purpose to take the Smithsonian beyond objects and buildings; we also carry out our mission to connect communities across cultures —cultivating curiosity, understanding and belonging for all people."

CMN and the Smithsonian Folklife Festival hope you'll join us as we mark our shared contribution to this national celebration. The pageant builds upon traditions while looking to the future, creating space for everyone to come and partake in the wisdom of Menominee cultural teachings.

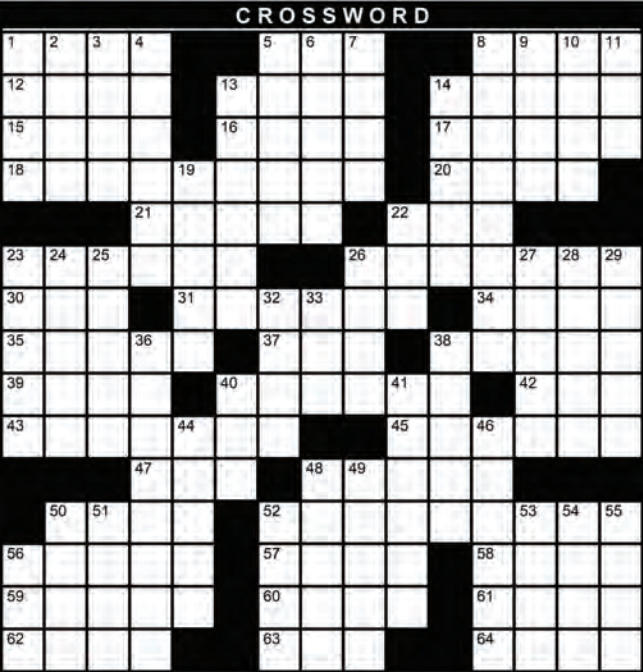

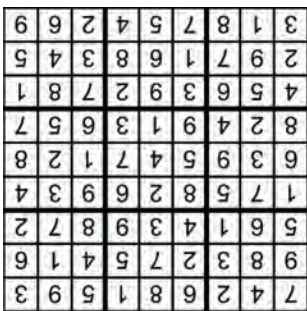

Antigo man dead in Highway 29 rollover

An Antigo man is dead after a crash where a semi-tractor/trailer flipped over in the Town of Hartland.

On May 19 at 4:54 a.m., the Shawano County Sheriff's Department dispatch center received the call about the crash on state Highway 29 near

Porter Road. Initial reports indicted the driver was trapped inside the vehicle on the eastbound lanes of the highway.

Sheriff's deputies responded to the scene along with fire and emergency medical service units. Upon arrival, the eastbound lanes were

completely blocked due to the crash. The driver of the semi, a 59-year-old man, was trapped inside the cab and pronounced dead.

Preliminary investigation indicates the semi-truck was traveling westbound on the highway in the right lane through the

construction zone. In this area of the construction zone, there was a large section of roadway cut out in the left lane which had orange traffic posts around it. The driver side tire entered this cut out causing the tire to blow and the semi-truck driver to lose control. The semi

then flipped over into the median. The trailer came to rest in the median, and the semi cab came to rest in the eastbound lanes of Highway 29. Both the semi-tractor and trailer sustained severe damage.

Witnesses reported they observed the semi traveling westbound,

enter the median and flip over.

No further details, including the name of the individual, will be released at this time as the investigation remains ongoing, according to a sheriff's department press release.

they’re currently being used for construction equipment storage while the rest of the building is being worked on. Partially finished is a space for a gas fireplace to be used by the community in the winter months.

“Whatever you knew us for, we’ll have – whether it’s racquetball or swimming or lifting weights,” Hendricks said. “The part that we’re excited to add is the social connection: ‘I’ve got an hour to kill before my next meeting, so I’m going to play someone in a game of cribbage,’ or, ‘Hey, I’ve got to meet with a couple of nonprofit people, so let’s meet at the rec.’ That’s what we hope to be.”

Hendricks was excited to show off some of the furniture and decorations that will be used in the new facility, including the front desk, which was built by city staff from the

hardwood flooring of the former racquetball courts. To create a brand new desk would have cost the city \$58,000, he said.

The Glam Band is made up of six guys with a love of '80s Hair Metal.

A few friends sitting at a bar talking about how cool '80s rock was led to an inaugural show on a Tuesday night at Riders Saloon in Kimberly back in 2007. The crowd reaction at that first event was unbelievably positive, and The Glam Band was born. The band started out as a five-piece ensemble and later added a keyboardist in 2013. This six-piece band is now in their 17th year of bringing a killer decadent '80s rock show to venues across Green Ba and The Fox Cities.

The band gets its name from the Glam Metal era of music, also known as Hair Metal or Pop Metal. It is a subgenre of hard rock and heavy metal, and is most known for its catchy hooks and guitar riffs. This style can be traced back to acts like Aerosmith, Alice Cooper, Cheap Trick, Kiss, The New York Dolls and Van Halen.

Glam Metal arose in the late 1970s and early 1980s in the United States, particularly on the Los Angeles Sunset Strip music scene, pioneered by bands such as Motley Crue, Quiet Riot, Ratt and Bon Jovi. It was popular throughout the 1980s and the beginning of the 1990s, bringing to prominence bands including Poison, Cinderella and Warrant. Glam metal was notably associated with flashy clothing and makeup. Many bands from this era featured long shaggy or backcombed hair, accessories, metal studs, leather and make-up during their live performances.
