Humane society seeks municipal support

Group could stop taking in strays from communities that don't participate

The Shawano County Humane Society is changing its policy regarding animals brought into its shelter in Shawano, and it will require municipalities to cough up some money to help find homes for unwanted animals.

A notice from the humane society was recently sent out to village and town boards, city councils and municipal higher-ups from Pam Nowak, the society's executive director, and Dusty Martzke, president for the board of directors. The matter came up for the Wittenberg Village Board meeting Aug. 4, and it could be coming up on other agendas, as well.

The notice is asking for municipalities to help the humane society in one of two ways.

The first option is for municipalities to pay \$2.50 for each resident within their borders, based on the most recent official numbers from the U.S. Census. For the village of Wittenberg, that would equal \$2,497.50 annually, while the city of Shawano, having 9,251 residents as of the census, would be contributing \$23,127.50 per year.

The second option would seek \$500 for every stray dog or cat, or for every dog or cat with a litter apprehended within municipal boundaries, which would be more challenging for local governments to budget. Municipalities would be billed on a quarterly basis under this option.

For any municipalities that don't choose from the two, the third option will be that the humane society will no

Housing authorities will not merge

Retirement on horizon for leaders of both organizations

Members of the boards governing the Shawano city and county housing authorities have opted not to merge together — at least not now.

Todd Buettner is planning to retire in the next several months as the executive director of the Shawano City Housing Authority, which led some at the Housing Authority of Shawano County to consider a merger of the two organizations.

"We explored it, but we decided we are not going to merge at this time," said Jeff Theis, executive director for the county housing authority. "It's something we feel we should do down the road, but it's a two-plus-year process."

For his part, Theis is 67 and is also considering retirement within the next couple of years.

"Because it takes a few years to do this, we didn't think it would be right to merge and then have both current leaders retired," Theis said.

Buettner, who has been with the city housing authority for 29 years, agreed.

"It's just not the right time," he said. "It wouldn't be right to merge and risk having someone new step in and be overwhelmed. We can always look at it again down the road."

Now, Buettner will work with his board members to find a replacement for him.

The first inquiry about a possible merger happened in March.

In April, Buettner and two commissioners from

the city housing authority met with the county housing authority committee to review initial thoughts from both boards.

The function of both boards is similar — helping low-income residents secure adequate housing.

The Shawano City Housing Authority has been around since 1967.

It offers two programs that are federally funded through the Department of Housing and Urban Development. These programs consist of public housing and Housing Choice Voucher Program.

The public housing program consists of 146 units in the city, including 110 one-bedroom units and two two-bedroom units at Parkside Apartments and Elizabeth Manor. It also has two one-bedroom duplex units, 22 two-bedroom duplex units and 10 three-bedroom duplex units located on Oak Street, Richmond Court, Military Road and Acorn Street.

The city housing program also offers 52 vouchers for the Housing Choice Voucher Program that can be used anywhere in Shawano County.

The Housing Authority of Shawano County has been around since 1972.

It provides apartment and single-family home rentals for low-income individuals, families, disabled and senior citizens in 11 municipalities Shawano County. Income limits apply.

Menominee County seeks to develop vacant land

Planning underway with potential designs slated for October

Menominee County has a piece of land about 1 1/2 acres in size that it wants to utilize, and it's turning to residents to determine what will be the best use for the property.

The county and the Menominee Indian Tribe of Wisconsin have teamed up with the East Central Wisconsin Regional Planning Commission to look at what opportunities are available for economic development, housing, services and community investment. The planning is being facilitated by a \$60,000 grant provided by the National Association of Development Organizations for the Strategic Planning and Action for Revitalizing Communities (SPARC) program.

The property the county owns is in Keshena, just of the Menominee Casino Resort. However, the project is also looking at providing development in Neopit at a site to be determined.

Meetings were held to get public input, and a survey was also sent to residents in the county and on the reservation to determine the needs. Responses have been limited, according to Jeremy Johnson, Menominee County land conservation/forestry/zoning director, but there are indications from those who did respond that affordable housing or retail shops might be high on the list to be placed on the property.

"There's a need for more retail to keep local dollars here," Johnson said. "They can't get things here locally."

The county is looking at previous economic research that shows the reservation and county have more than \$312 million in unmet local demand, with most residents traveling to bigger communities like Shawano

and Antigo to get most of their basic needs. Johnson said it's important to reduce that to have amenities available in Menominee communities.

"The county will have the ability to sell it to a developer with a vision of what should be done with it," Johnson said. "The grant will fund the process, from start to finish, for actually having a development plan for the site."

He added that any plans for Neopit will be developed to apply to a tribal-owned site, as the county does not have any land available for development in that community. More than 95% of the land within the boundaries of the county is owned by the tribe.

Johnson said that among some of the things discussed for any project are environmental stewardship and eco-tourism.

"Some of the grounds areas could be used for pollinator gardens and rain gardens for the runoff from the buildings," Johnson said. "We're trying to include some of that eco-friendly design

concept in this development, to use native and natural stuff for the grounds. As far as cultural significance, we're trying to make sure that the Menominee culture is taken into account and even put into the natural building design."

Johnson said that the land has enough space for several buildings, whether it's for retail or housing, noting that affordable housing is an issue everywhere.

East Central will be putting together renderings, plans and implementation strategies that will go before the Menominee County Plan Commission near the end of October and then possibly move on to the county board from there.

"East Central has been a very integral part of this," said Johnson, who also serves as an alternate on East Central's commission. "They've done four or five of these around East Central Wisconsin. This is just the first time they've done it here."

Gibson hired as evidence tech

Mixes technological, forensics skills with law enforcement duties

For years, Bryan Gibson toed the line between his two passions of law enforcement and IT. Now, he uses those skills interchangeably on a regular basis for the Shawano County Sheriff's Department.

Gibson recently transferred from the county's IT department to the sheriff's department to serve as the new evidence specialist. He replaces Ann Holcomb, who retired.

"My family was always involved in, if not directly employed as, IT professionals and so naturally that was how I started out, but I quickly realized I had a desire to serve my community, and felt law enforcement was more my calling because I got to help people in a real way," said Gibson, who grew up in Cloquet, Minnesota, about 30 miles from Superior.

"As my career progressed, I toed a line between law enforcement and IT — working as a security guard at a local hospital, where I regularly interacted with law enforcement officers and stoked that fire. Locally, that role was a stepping stone to becoming a law enforcement officer. Many of my colleagues there went on to do just that. I went on to do IT work for that hospital, but something always felt like it was missing."

During that time, he gained another degree, cyber leadership and intelligence, with a specialization in digital forensics, which is where he found the most enjoyment out of anything he studied.

"I decided upon graduation that I would work toward a position in law enforcement that would allow me to use both my technological and forensics skills to continue to help people, and this role is, in my opinion, the perfect mixture," Gibson said.

The duties of this role involve the taking in, management, secure storage and maintained availability of any item that can be defined as evidence, as well as providing information and services to the public such as weapons destruction.

Physical evidence is defined by the sheriff's department as "any item, substance or material found or recovered in connection with an investigation." That means any item that speaks to the facts of a case, from the tiniest hair to an SUV.

"These are all possible items of evidence that when pieced together, tell a story of what happened at a particular place, at a specific time," Gibson said.

He said each piece of evidence is handled based on what it can provide to an investigation, as well as the discretion of the deputy or detective working the case. All evidence is securely stored and kept separate from other evidence.

Gibson said he could go on for hours regarding the evidence chain, who collects the evidence

and how they determine what to collect.

"But the key takeaway is that it all depends on the case," he said. "Typically the deputy or detective on scene will

collect the evidence and bring it back to the evidence building where I would take possession. This would be for things like traffic stops. But on occasion, I can also be requested to assist right then and there. Those would be for things like search warrants. The size or severity of the case is not the determining factor, but rather how much evidence is present, whether it follows the typical chain of custody flow or could be called 'special.'"

Once collected, all evidence is cataloged, both on chain of custody forms as well as in department computers. From there, it is brought to its designated location based on what it is, if it needs temperature control, etc.

"It is held until it is needed for court proceedings, processing at the crime lab and eventually its destruction," Gibson said.

He believes every case deserves the same level of reverence for its evidence.

"The court of law should be fair, and the part that I play is to make sure there is no question at the time of the proceedings that evidence is and has been handled correctly and securely," he said. "We have different secure storage areas based on the type of evidence, but the entire evidence building is built on the idea of least privilege — only those with specific need to access certain areas can do so, and those who request access need to be escorted if they are not normally working in those areas."

Everyone, including the defense attorneys and the prosecutors, have to put in written requests when it comes to reviewing evidence.

"Once an item is logged as evidence, regardless of who it is or what part they play, I am also present to supervise their examination of the evidence as a witness as well," Gibson said.

How long evidence is kept depends on the case and the type of evidence. Also, most cases can be appealed, which means that evidence can be stored longer depending on the status of the case.

"Part of my duties is to consistently be monitoring cases to keep accurate tabs on where the case is in the process of being worked through, and then purging it as required," Gibson said. "The purging process again is dependent on the item, but most of the time, it is either sent off or hand-delivered to a location that specializes in the destruction of that item."

In some cases, evidence is returned to the owner, while other items are recycled.

Aspirus urges helmet use, safe riding for e-bikes

Aspirus trauma leaders are seeing a noticeable rise in serious e-bike-related injuries as warmer weather brings more riders outdoors.

Unlike traditional pedal bicycles, e-bikes are heavier, travel at higher speeds and require longer stopping distances, factors that contribute to more severe trauma when crashes occur.

According to the National Institutes of Health, national data shows that a properly fitted helmet can reduce the risk of severe head injury by as much as 85%.

Aspirus trauma coordinator

Jamie Armbruster says the most common injuries include fractures, facial and dental trauma, internal organ damage and traumatic brain injuries, many of which are linked to riders not wearing helmets or using helmets that are not designed for e-bike speeds. She notes that recent studies identify two groups at highest risk: children and teens, especially males younger than 16 and adults 45-64.

"E-bikes are not the same as pedal bikes," Armbruster said. "They're heavier, they go faster, and they're less maneuverable. The injuries we see can be

life-altering or fatal, especially when riders skip helmets or use ones that aren't certified for higher speeds."

Local law enforcement is also seeing increased use of e-bikes and e-motos, electric dirt-bike-style devices that lack pedals and are not legal for use on public roads, sidewalks or multiuse trails. Wausau Police Department Patrol Capt. Melinda Pauls says many riders do not realize that e-motos cannot be registered, lack required safety features and may be subject to citations or impoundment if operated in public areas.

Multiuse trails present additional safety concerns. Pedestrians, including children near parks, may enter paths unexpectedly. Riders are encouraged to slow down, announce when passing and use bells or verbal cues to prevent collisions.

"Safe e-bike riding is just safe bicycle riding," Pauls said. "Wear a helmet, follow the rules of the road, and know what you're buying before you ride it. Some devices simply aren't legal or safe for public use."

Trauma experts also recommend safety training, understanding local ordinances,

avoiding riding under the influence and following manufacturer guidance when charging lithium-ion batteries.

"Many people still view e-bikes the same way they view traditional bicycles," Armbruster said. "But the speed, weight, and injury patterns tell a different story. Taking a few basic precautions can make the difference between a minor crash and a life-changing injury."

Trauma specialists say helmet use remains the single most effective step riders can take to reduce the risk of serious injury.

LAWRENCE JAMES ROMUALD

Lawrence James Romuald, 78, passed away Aug. 5, 2026, leaving behind a legacy of service, leadership, faith, friendship and devotion to family.

Born to Arnold and Marie (Tombal) Romuald on Aug. 8, 1947, in Champion, he lived a life marked by hard work, generosity and a deep commitment to the people and communities he served.

A 1965 graduate of Luxemburg High School, he excelled in athletics, lettering four years in baseball and two years in football. His love of sports remained with him throughout his life. He played both fast-pitch and slow-pitch softball for more than 40 years, was an avid golf player and a lifelong fan of the Green Bay Packers and Milwaukee Brewers.

Following high school, he proudly served his country in the United States Army as part of the Army Security Agency and military intelligence, from 1966-70, including service in Vietnam from 1967-68. He remained deeply committed to fellow veterans throughout his life, maintaining active membership in the Veterans of Foreign Wars, Vietnam Veterans of



America and the American Legion. He was privileged to participate in an Honor Flight in 2018, a memorable experience he greatly cherished.

He earned an associate's degrees in data processing and accounting from Northeast Wisconsin Technical College in June 1973. He later received his bachelor's degree in managerial accounting from the University of Wisconsin-Green Bay in 1982 and became a certified public accountant in 1983.

He enjoyed a distinguished 42-year career serving the agricultural cooperative community, a career he considered rewarding because of the farmers he considered the greatest people to work for.

He began with Consolidated Badger/Morning Glory Farms in June 1973, eventually serving as controller from 1983-85.

In 1985, he joined 21st Century Genetics/Cooperative Resources International, where he served as treasurer and vice president of finance until his retirement in 2015. During his tenure, he traveled extensively throughout the world, helping establish foreign distributorships and supporting CRI's international growth.

A respected leader in his profession, he devoted significant time to professional organizations. He served as president of the local chapter of the Institute of Management Accountants (formerly the National Association of Accountants) in 1992, following years of involvement from 1983-92.

He was an active member of the National Society of Accountants for Cooperatives, Great Lakes Chapter, from 1996 through 2026, served on the national NSAC board from 1996 to 2013, and was elected national president in 2012. In recognition of his contributions, he received the NSAC National Silver Bowl Award in 2015 and was inducted

into the NSAC Great Lakes Chapter Hall of Fame in 2023.

His expertise also benefited the Farm Credit and AgStar organizations. He served on the board of directors from 2006-15 as a recognized financial expert. From 2009-15, he also served on the Farm Credit Plan Sponsorship Committee, overseeing human resources and payroll functions for affiliated associations and serving as committee [resident from 2014-15.

Faith and community involvement were central to his life. At Sacred Heart Catholic Church in Shawano, he served on the school board in 1993, the pastoral council from 1997 to 2007, and the finance council from 2023-26. He was a dedicated member of the Knights of Columbus from 1988 to 2026.

His commitment to service extended throughout the Shawano community, where he was active in Rotary Club of Shawano, serving as president in 2008, and also participated in the Shawano Jaycees, Optimist Club, United Way board and Shawano Club.

Above all, he treasured his family. He shared 53

wonderful years of marriage with his beloved wife, Patricia (Schott) Romuald, creating a lifetime of memories together. Following his retirement in 2015, the couple embraced life as snowbirds, spending the past 10 winters in Sun City West, Arizona. There he enjoyed golf, friendships and the warm community that became a second home.

He had a passion for photography, military history, golf, softball, travel and spending time with friends and family. He enjoyed two unforgettable river cruises and an ocean cruise, and developed what he jokingly referred to as an "acquired taste" for bourbon.

He will be remembered for his integrity, leadership, patriotism, faith, sense of humor and genuine appreciation for people. His impact will be felt by family, friends, colleagues, fellow parishioners, veterans and the countless individuals whose lives he touched throughout his remarkable journey.

He will be deeply missed and lovingly remembered.

Lawrence is survived by his wife, Patricia (Schott) Romuald; children, Roxi (Aaron) Stelter, Suzie (Paul) Blasczyk and Brendan

On leave of absence from 1966-69, he earned a master's degree in chemical engineering and a doctorate in macromolecular science from Case Institute of Technology (now CWRU).

He went into management and held positions including manager at Kenecott Copper Mine, president of Colonial Pipeline, general manager of Marine Transportation, director of development engineering and information sciences laboratory. At the end of his career, he was director of the Sohio BP Research and Development Laboratory in Warrensville Heights.

Flying was his passion;

he obtained his pilot's license in 1962 and bought a Cessna 182 in 1982. He used his plane to visit his extended family in Wisconsin, Tennessee, Maryland and Georgia, as well as go on adventures flying up canyons in the Rockies.

Jon retired at the age of 53 and became an entrepreneur by making his flying hobby into a business. He formed Skywatch Inc. in 1992 and contracted to fly over pipelines looking for leaks and unauthorized digging. He was an avid gardener, bicyclist and fisherman. In 2002, he helped create the Greenwood Village community garden. He led his family on bike camping trips across Wisconsin and Ohio Amish country and pedaled with his nephew David around the Leelanau Peninsula in Michigan and biked across the south of France with his friend Dave.

Jon loved taking his small

boat on Lake Erie with his buddies and coming home with perch and walleye for dinner or spending winters fishing off his boat in Cape Coral Florida.

He served over 30 years on the board of Greenwood Village and led the creation of the current architectural rules for Greenwood as chair of the architectural committee.

He was a videographer before there was video, presenting his Super8 films as part of the Sohio Speakers' Bureau.

He shared his parents' love for God and brought up his family to share his deep faith.

He loved singing in the choir and served on the board of elders. He was also known for his sense of humor and loved practical jokes. He provided a warm home for his family filled with love and laughter.

Reshaping speedway could cost \$250,000

Project most likely won't be done until 2027

Most of the plans to reduce the size of the Shawano Speedway have been drawn up, but the question of who will pay for it still lingers.

For more than a year, track organizers have pushed to shrink the raceway from the half-mile to a three-eighths mile oval. It's believed a shorter track will attract more drivers, which will lead to more fans and more money for all involved.

"I think before we decide on any shape or anything like that, we have to discuss funding, because any decision from this meeting forward is going to cost money," Nick Hesse, facilities management director for Shawano County, told members of the public property committee Aug. 6. "We need to figure out who's paying for what."

Grant Bystol, county highway commissioner, said if the county takes the lead on this, a plan with point data, cross-sections and draining plans needs to be finalized.

Based on contours provided in the current proposal, Bystol offered several estimates for bringing in Turns 3 and 4 to make the track shorter.

"There's 25,000-30,000 cubic yards of earthwork. There are between six and eight power poles in conflict, plus or minus four electrical pads and outlets in the pits, and the stop-and-go lights need to be relocated," he said. "There is 1,300 feet of old retaining

wall to remove, reinstall 822 feet of retaining wall. There's about 885 feet of new fence to wrap the exterior. There's approximately 400 feet of storm sewer plus additional yard drains. There's approximately 1,600 cubic yards of topsoil that will be needed to restore the abandoned area to the north."

The total, without final design, is about \$250,000, Bystol said.

Some of the work could be done with in-kind donations, such as the moving of electrical poles, or costs can be saved by reusing the old fencing.

Still be decided would be the locations of the pit entrance and exit lanes.

The current proposal has a 307-foot straightaway, which is short of the 340 feet needed for tractor pulls that are held on the track during the county fair.

Whether the project will require a retention pond will be determined by the Wisconsin Department of Natural Resources after they review the plans.

On Aug. 10, the highway department started a 2-mile reconstruction project for another municipality that will keep them busy the rest of the season.

"I don't know who wants who to do what, but we're pretty much tied up with equipment through the end of October," Bystol said.

Bystol said the construction time would most likely be in the fall of 2027 if the highway department is involved.

"Let's get some numbers and see where we sit," said Rick Giese, chairman of the public property committee.

The topic will be back on the committee's Sept. 3 agenda.

Study links alcohol to risk of cancer

Public health leaders continue to raise awareness about alcohol's link to cancer, following a 2025 U.S. Surgeon General advisory that identified alcohol as a leading preventable cause of cancer in the United States.

The advisory also calls for updated alcohol warning labels to better inform consumers about cancer risk. Yet despite extensive research, many Americans remain unaware of alcohol's link to cancer.

The advisory identifies alcohol as the third leading preventable cause of cancer in the United States, contributing to about 100,000 cancer cases and 20,000

cancer-related deaths each year. Aspirus Health is working to increase awareness of these risks and encourage informed choices about alcohol consumption.

"Any time the American public is consuming a product that can cause cancer, I think it is important for us to know," said Dr. Andrew Huang, radiation oncologist.

Alcohol is a known carcinogen, and research shows it increases the risk of several cancers, including those of the mouth, throat, liver and breast. Its impact goes beyond cancer. Long-term alcohol use can lead to organ damage and contribute

to chronic diseases of the liver and heart.

For years, some studies suggested that moderate drinking had health benefits, but newer research has challenged that idea. According to Huang, earlier studies failed to account for people who avoided alcohol due to preexisting health conditions.

"Once those individuals were removed from the data, the reality became clear — there is no protective effect of alcohol. Even small amounts increase the risk of death," he said.

Avoiding alcohol completely is the safest choice, but moderation is key for those who choose to

drink. Excessive or habitual alcohol use can harm physical and mental health.

"It is not just about the physical effects," Huang said. "Alcohol can impact relationships, mental health and overall well-being."

Aspirus Health encourages individuals to have open conversations with their primary care provider about alcohol use. Honest discussions help assess personal risk factors, explore healthier alternatives and provide resources for those looking to cut back. Regular checkups offer an opportunity to take control of long-term health.

18% hike in police calls not all crime related

Chief believes more officers on street would improve service

Police calls are up 18% compared with this time last year, but that doesn't translate to more crime in the city of Shawano.

From Jan. 1 through Aug. 5, the Shawano Police Department responded to 5,517 calls, compared with 4,675 for the same time period last year. Besides the criminal investigations, officers also respond to quality-of-life complaints, traffic-related incidents, assisting other first responders and other service calls, according to Police Chief Mike Musolff.

"Shawano continues to be a safe community," Musolff said. "Our officers remain committed to being visible, responding quickly, investigating crimes thoroughly and working with residents to solve problems. Public safety is a partnership, and we appreciate the support we receive from our community."

Several areas where the police department has seen an increase compared with last year include disturbances, harassment calls, thefts, noise complaints and property damage traffic crashes. Musolff noted that calls for vehicle break-ins for the summer have gone down, though.

Decreases in certain categories have been seen, too, specifically in drug-related incidents, welfare checks, suspicious activity complaints, family disturbance calls and picking up people with outstanding warrants. Despite the decrease in welfare checks, they still comprise hundreds of calls each year, according to Musolff.

"Some community-service type calls remain among our highest-volume activities. We continue to respond to hundreds of welfare checks, medical assists, agency assists, disturbances and traffic-related incidents," Musolff said. "Those calls consume a significant amount of our officers' time and reflect the wide range of services today's police departments provide."

Calls about juvenile mischief in city parks continue to be a problem in Shawano, according to Musolff, although the numbers remain relative flat from last year to this year. While he reported in June that there were no major problems near Memorial Park when Sun Drop Dayz was happening, there were several instances where juveniles were getting into fights at other parks in the city.

Musolff said that many of the juvenile incidents in Shawano could be curtailed if parents paid more attention to their children.

"They're either allowing them to go out and cause mischief in the city, which is alarming to me, or they don't know they're sneaking out," Musolff said. "What we need is to parents to step up and make sure they're monitoring their children and what their kids are doing at night, just like you would during the day."

Mental health issues continue to be an issue in police calls, although those seem to be trending downward in 2026; the police have responded to 24 calls so far. In 2025, 35 calls were related to mental health.

"We're acting many times as a counselor, even though we're not a counselor," Musolff said. "We wear many hats. That's one area I'd like to see the state work on. We have all this money, and they don't know what to do with it. Work on mental health."

Dealing with off-road vehicles has been a rare issue, with city police handling four calls this year and three for the same time period in 2025. However, this tends to be an underreported statistic, according to Musolff, as most complainers tend to post on social media in lieu of calling dispatchers to report.

"Despite what you see on Facebook, we don't get a lot of complaints," Musolff said. "People seem to think that reporting to social media is reporting to the police, and that's not the case. We may catch things on there, and we may make phone calls to follow up on things from social media, but that isn't our primary concern. Our primary concern is following up on calls that come in to the dispatch center."

Another notable statistic is the number of times officers have to assist at a scene where ambulances are responding to medical calls. So far in 2026, there have been 368 calls for ambulance assistance, more than one per day.

Musolff said there are currently at least two officers on duty at all times, but that still stretches the department thin at times. He believes two more officers for the department who could work a 12-hour shift during the afternoon and evening hours, when the call volume is highest, could help increase response times.

"I think it's time to start evaluating that more," Musolff said. "The last increase was through a grant, which was for a detective position (six years ago). That was a position increase, but now we have a detective and a detective lieutenant, so that takes people off the road."

Chapman-Chevalier is an enrolled member of the Menominee Indian Tribe of Wisconsin and was raised and currently lives on the Menominee Reservation. Chapman-Chevalier graduated from CMN with an associate of arts and science in liberal arts, with a minor in Native American studies emphasis with her coursework in Menominee language, and an associate of arts and science in sustainable development with her coursework in cultural geography.

She also earned her master of science from UW-Platteville with a major in organizational change leadership. Benjamin "Benny" Rieth will talk on the topic of education.

Nahwahquaw, who is a member of the Menominee Nation, works with her team to administer health services to tribes and educate employees within the Department of Health Services about different tribal communities to ensure the services are culturally appropriate.

Menominee Tribe recognized with Energy Sovereignty Champion Award

The Menominee Indian Tribe of Wisconsin has been selected to receive the inaugural Energy Sovereignty Champion Award at the 2026 People of the Sun Gathering, recognizing the tribe's leadership, perseverance and long-term commitment to building an energy future rooted in sovereignty, resilience and service to the community.

The award will be presented Sept. 17 at Standing Rock in North Dakota as part of the People of the Sun Gathering, a national convening of tribal leaders, innovators, educators, artists and allies working to advance Indigenous-led

solutions in energy, economic development and community resilience.

For more than a decade, the Menominee Tribe has steadily pursued a vision of energy sovereignty. Beginning with an early commitment to invest Recovery Act funding in renewable energy, tribal leadership chose to plant the seeds of a long-term strategy rather than pursue short-term projects. Today, that vision includes a commitment to achieving energy sovereignty by 2035 through renewable energy development, workforce preparation, resilience planning and innovative financing.

The journey has not been without challenges. After helping lead a multi-state coalition that secured significant federal funding to expand tribal solar programs, the tribe saw that opportunity come to an abrupt halt when the program was terminated before implementation. Rather than abandon its vision, the Menominee Tribe continued moving forward, securing philanthropic support, developing new partnerships and exploring financing strategies that use the long-term value created by renewable energy projects to finance future investments.

The award also recognizes something less visible but equally important: the tribe's commitment to serving future generations. Energy planning at Menominee has been guided by a broader vision of stewardship – caring for elders, protecting the tribe's natural resources, strengthening the local economy and creating opportunities for tribal members through education and workforce development. Rather than

viewing renewable energy as a stand-alone project, the tribe has embraced it as part of a larger strategy for self-determination and community well-being.

"We knew renewable energy represented an important opportunity for our tribe, but we also knew we needed experienced partners to help us make informed decisions," said Ron Corn, former chairman of the Menominee Indian Tribe. "We brought together organizations and technical experts who respected our vision and helped us develop a long-term strategy that reflected our values and priorities. That collaborative approach has helped position us for continued success."

That long-term vision is now reaching tribal members through the Menominee Utility Rebate Program, which helps households improve energy efficiency, electrify their homes, reduce energy costs and prepare for a more resilient energy future.

"It's an incredible honor to do this work for

our tribe," said Jaime Oshekshquoam, who leads the Menominee Utility Rebate Program. "Opportunities like this don't come along very often – to help families lower their energy bills, make their homes more comfortable and build a stronger future for our community. This isn't just a job for me – it's work I truly love, because I get to see the difference it makes in people's lives every day."

For the Menominee Tribe, this recognition is both an honor and a responsibility.

"We are deeply honored to receive this recognition," said Darryl Pyawasay, director of the Menominee Tribal Utility. "This award belongs to the many tribal leaders, staff and community members who have stayed committed to this vision over the years. We hope our journey demonstrates that energy sovereignty is achievable. If our experience helps another tribal nation take the first step toward building its own energy future, then this recognition means even more to us."

According to Cody Two Bears, founder and CEO of Indigenized Energy, the Menominee Tribe exemplifies the type of leadership the People of the Sun Awards were created to recognize.

"It has been an honor to work alongside the Menominee Tribe over the past several years and witness the leadership and determination they've demonstrated," said Two Bears. "From the very beginning, they made a commitment to energy sovereignty and never lost sight of that vision. They persevered through changing circumstances – including the loss of major federal funding – and continued finding new ways to move forward."

The Energy Sovereignty Champion Award recognizes tribal nations that are boldly advancing energy sovereignty through leadership, vision and action. The award honors tribes laying the foundation for long-term energy independence through planning, innovation, infrastructure, and community leadership.

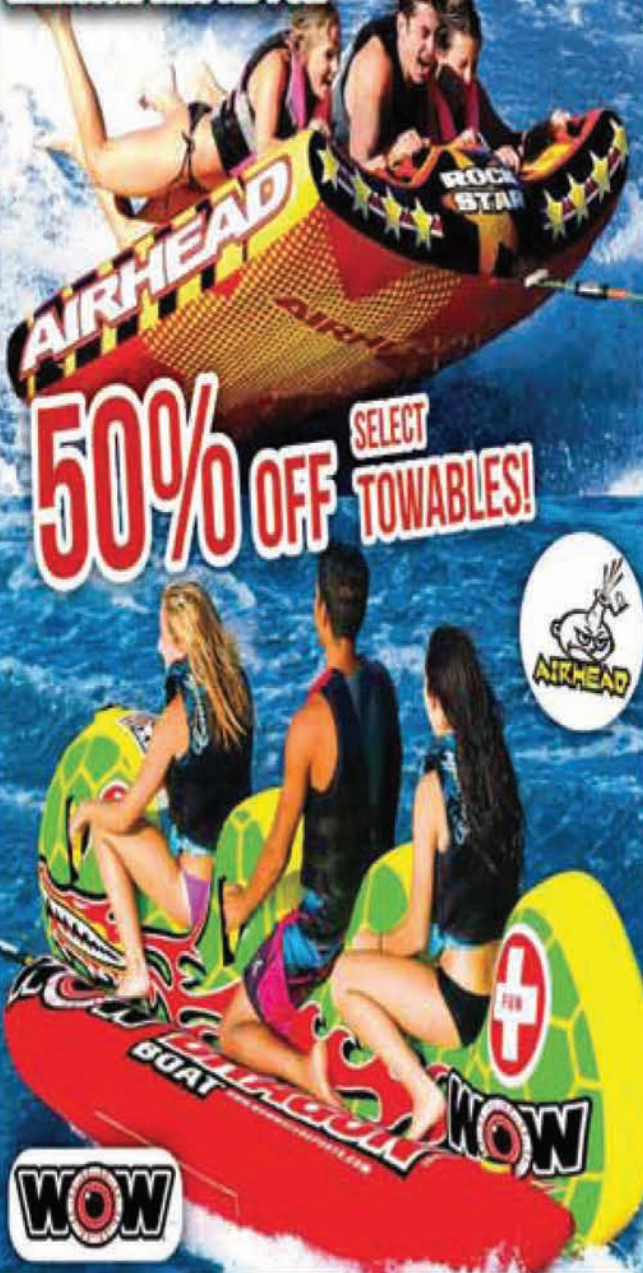

FEMA aid continues for April storms

Additional FEMA help may be available from the April storms and flooding in 19 designated counties in Wisconsin and the Oneida Nation.

If you received initial rental assistance from FEMA because your home was not safe to live in, and you are still working toward your permanent housing plan, continued temporary housing assistance may be available.

To be considered, you must:

- Show you used the initial FEMA rental assistance to pay for temporary housing.
- Be unable to return to your pre-disaster residence because it is still not safe to live in or is no longer available because of the disaster.
- Not have the financial ability to obtain housing without assistance.
- Show that you are working toward a permanent housing plan.

If you were initially approved for rental assistance, an application for continued temporary housing assistance will be mailed to you 15

days after the grant is approved. If you do not receive one, call FEMA at 800-621-3362.

Take the time now to ensure your furnace and water heater are operating safely, and they weren't damaged by the April storms and flooding. FEMA grants may be available to help repair those items and replace them if they were destroyed by floodwater.

If you received a FEMA grant for repair of your furnace or water heater and later discovered those items need replacing, you can use the FEMA appeal process for additional grant funds. Applicants have 60 days to appeal and must submit a letter with a verified contractor's estimate for replacement of the furnace or water heater.

Send in your request for continued temporary housing or additional money to repair or replace your heating systems in one of the following ways:

- Online: This is the fastest option to submit documents. If you have a FEMA online account,

upload your documents electronically. To set up the account first, visit DisasterAssistance.gov, click on "Check Status" and follow the directions.

- By mail: FEMA, P.O. Box 10055, Hyattsville, MD 20782-7055.

- By fax: 800-827-8112, Attention: FEMA.

- In-person: Visit any Disaster Recovery Center to submit your appeal. Find a center here: fema.gov/DRC.

Even if you were visited by a FEMA assessment team in May or called 2-1-1 to report your home damage, you must still apply to be considered for federal assistance. Start the application process by going online to DisasterAssistance.gov or calling the FEMA Helpline at 800-621-3362. If you use video relay service, captioned telephone service or others, give FEMA your number for that service.

Be sure to apply before the Aug. 31 deadline. For additional information about the disaster recovery operation in Wisconsin visit www.fema.gov/disaster/4923.

Gone from last year's team are Shane Blum, Kole Johnson, Logan Zietlow, Elijah Scheef, Sam Anheuser, Logan Drews, Nolan Wisnefske, Tanner Dent, Emmitt Ehlert and Nick Haring.

Seniors expected to join this year's team include Braylon Mielke, who rushed for 2,068

yards and 26 touchdowns as a junior, as well as Izayah Ledarhaus, James Nolan, Collin Grogan, James Brady and Christian Laatsch.

The Thundercatz will open their season in Marion with a nonconference matchup against Gillett on Aug. 20.

Bowler/Gresham Panthers

The Panthers ended up cancelling their 2025 season after forfeiting games to Menominee Nation, Marion/Tigerton and Newman Catholic and have not fielded a team since 2022.

However, the WIAA website lists seven games scheduled for the Panthers this season, including the season opener Aug. 28 in Keshena against Menominee Nation and the home opener Sept. 11 against Rosholt.

Ted Kietlinski is listed

as the team's coach.

Menominee Nation Eagles

Menominee Nation High School was due to start in the Central Wisconsin Conference this year, but an announcement came recently via press release that the school was ending its football program due to declining participation.

Last year, the Eagles only played two games and was outscored 168-0. After opening the season with a 74-0 loss to Wabeno/Laona in Keshena, the Eagles faced Tri-County two weeks later and fell to the Penguins 94-0.

It was enough for school administrators and coaches to pull the plug on the season after three weeks. The season also included a forfeit win over Bowler/Gresham, which did not field a team last season.

The decision now appears to be permanent, according to the press release.

"Over the past several years, participation has steadily declined, making it increasingly difficult to sustain a safe, competitive, and successful football program," according to the release. "After carefully evaluating student participation, program sustainability, and available resources, we have determined that discontinuing the program is the most responsible decision for the safety of our players."

"We recognize the history and tradition of Eagle football and understand the disappointment this news will bring to our students, families, alumni, and community. However, our responsibility is to make decisions that best serve our students today and into the future."

The new stadium, part of a \$51.23 million referendum approved by voters in November 2024, will also feature an upgraded eight-lane running track circling the field, new grandstands with built-in storage spaces underneath, a dedicated and updated tracking and throwing areas for field events, expanded gathering spaces, updated restrooms, redesigned traffic flow, a new ticket booth and a new concession stand.

Synthetic turf offers a consistently green appearance year-round with no water usage, no need for mowing or fertilizing, and high resistance to heavy foot traffic. It eliminates muddy patches, reduces

chemical pesticide use and provides long-term financial and maintenance savings.

A ribbon cutting for the new stadium will be held at noon Aug. 17.

The Hawks football team will make its debut on the field at 7 p.m. Aug. 28 against Lakeland Union High School in a nonconference game.

The first Bay Conference game will be at 7 p.m. Sept. 4 against Winneconne.

As for boys soccer, the first home game will be at 6:30 p.m. Aug. 25 against Ashwaubenon, also a non-conference game.

The first Bay Conference tilt will be at 6:30 p.m. Sept. 8 against Green Bay West.

There will also be a ribbon cutting for the high school building addition and remodeling project at 3:30 p.m. Sept. 1 with an open house following from 4-7 p.m.

Church secretary covers multitude of bases

Fuhrman keeps track of all details at St. John's in Marion

The secretary at St. John's Lutheran Church in Marion covers multiple roles, including meeting the care concerns of anyone who walks in the door.

"The main point of my job is to serve the Lord – and His people – in any capacity needed," said office manager Sheri Fuhrman.

Always wanting to work at a church, Fuhrman applied for and landed the secretarial position at St. John's in December 2019.

"I feel it's the closest thing that I can do to serve the Lord," said Fuhrman. "For me, that was my focus. Just giving birth to my son, my previous job had me traveling and at any given day, I might be an hour and a half away from home. I wanted to be able to spend time with my son. By the grace of God, this role came up. I interviewed for it, and I was lucky enough to get it."

Duties Fuhrman covers within her office managerial title include keeping minutes from the church council, as well as communicating with all the action teams – community, property, worship, music and education/youth.

"I also check mail, answer phone, answer emails and keep office supplies stocked. I manage all social media accounts, making sure there's information out there on our behalf," she said.

Extra responsibilities Fuhrman handles include maintaining yearly annual reports and typing up weekly bulletins and monthly newsletters. In addition, Fuhrman is in charge of all of the church records.

"I have a comprehensive list of all member baptisms, confirmations, weddings, funerals – the whole scope of life," said Fuhrman.

As of December 2025, the church's records show 316 official active members.

At Fuhrman's disposal are a team of people who also cover a multitude of roles.

"Here at St. John's, we have a maintenance person, a janitor, a groundskeeper – all those people are very helpful. Plus we have a membership that is made up of great volunteers," said Fuhrman. "If we need something, someone just steps up. I'm really blessed here."

There isn't a serving pastor at St. John's

Lutheran Church in Marion. After completing extensive training, the parish appointed Carol Polzin and Denise Pamperin, designating them synod-authorized ministers. Together, they coordinate and handle the needs of the congregation.

The ability they have to relate to the members of the church is humbling to Fuhrman.

"There was a funeral service that Carol did, and she was able to truly project and intuitively understand that from the

beginning of their life to the end, how they were a servant of the Lord," said Fuhrman. "This is something Carol and Denise can both do because they've known area families their whole life. A pastor sometimes is fleeting – serving a church for five years or two or six months. The relationship they have with the members is a beautiful thing."

From time to time, Fuhrman gets phone calls about people trying to find their family.

"Getting to look back at the old records, some of them are in German. Luckily, I took German in high school, so I've been able to apply that knowledge and put it to good use," said Fuhrman.

At one point in her life, Fuhrman needed assistance in an end-of-life event in her own immediate family. A compassionate church secretary had answered her phone after hours, and through her efforts the

Climate change warnings have existed a long time

In the early 1970s, scientists were sounding warnings about climate change which seemed far-fetched. Out of curiosity, I attended an event featuring a man who'd become known as Earth Day senator; Wisconsin's Gaylord Nelson.

I was starstruck. Sen. Nelson was congenial and charismatic, respectfully listening to comments and answering tough questions. I stayed for the meet-and-greet, a life-altering decision.

The next day I was tutoring a student after school when the librarian knocked on my classroom door. She said I had an important phone call. I panicked. Was there some kind of emergency?

Thankfully, no. It was Sen. Nelson's aide. She asked if I would serve on a committee to find ways to introduce environmental studies at the high school level. Me? An English teacher? How could I say no?

The experience proved overwhelming and exciting. Clearly a blue gill swimming with walleyes, I gained confidence as we created a comprehensive curriculum. Early on, we decided to use trial lessons to see if ecology could be successfully incorporated into upper-level science classes.

In those days, Kaukauna High School

was situated on the banks of a filthy and smelly Fox River. Consequently, KHS was chosen to preview a unit on freshwater pollution. I vividly recall the day almost 100 juniors and seniors filed into the multi-purpose room to view a film envisioned as a kick-off attention grabber.

Most of these kids were in my English classes. Many were from rural areas and loved the outdoors. I'd graded hundreds of compositions about fishing and swimming adventures. I especially enjoyed those that described idyllic visits "up north" at Grandma and Grandpa's cottage. (Smile. Jon and I are now in this much-loved group.)

The focus of the film was Lake Erie, a "do not eat the fish" lake. Students reacted with shock and horror at the grainy moving pictures shown on a reel-to-reel movie projector. There was a collective gasp as images of Lake Erie on fire flashed across the screen. It was so polluted that the water was burning.

Outside of school, I brought up the topic in social settings.

The response was usually some version of, "Why should I care? Even if global warming is dangerous, I'll be dead before anything really bad happens."

Well, I cared, and so did my students. When you live close to the land, you become attuned to the rhythms of nature. Growing up on a dairy farm and then living on rural property, you cherish pastoral views of lush green alfalfa and golden cornfields. You marvel at the beauty of a winter terrain peacefully asleep under a waist-deep blanket of pure white snow.

In 1992, I read "Earth in the Balance" by Al Gore. By then, I was living on the mostly undeveloped southeast side of Appleton. Not exactly country, but close enough. The next year we bought property in Townsend, another life-changing decision that has taken us even closer to nature.

When you live full-time in the woods, you learn that human beings are not at the top of the food chain. I always carry bear spray and a whistle if I'm going

out for a walk. I blow it often so the big critters know I'm around. The piercing sound attracts my pet deer, but it must repel bears because I haven't seen one up close and personal yet. Thank goodness.

Question: Have we created a world for a climate that no longer exists? The past decade, and especially this summer, indicate that if we've been waiting for climate change to smack us in the face, it already has.

Consider what happened at the end of July when an EF-3 tornado hit Menasha. The storm badly damaged Jon's former place of employment, the Menasha water plant. It did extensive damage to Gegan School, where my mother once taught. It ravaged the block where my bonus kids grew up.

Yes, there have always been bad weather events. But just in the past six months, we have seen storms, tornadoes, drought, heat waves, flash floods, raging wildfires, earthquakes, and toxic smoke plumes all piled on top of one another. We can debate

the cause, but this is what global warming looks like.

Jon and I are trying. Determined to leave a small carbon footprint, everything we own is energy efficient. We use the gas-guzzling pickup sparingly, opting instead for my hybrid Escape. We reuse, repurpose, recycle.

Last summer, we installed solar panels. Scoffers said we were stupid. We'd never live to recoup our investment. Really? Our WPS electric bill this past year was \$228, the mandatory monthly facilities charge. We anticipate an eight-year payback, and that's at today's prices. Really.

Best of all, the system has a 25-year warranty so future owners will also enjoy clean, inexpensive energy. Now that thought gives me a sunny disposition.

Getting to the bottom of it, Fuhrman was able to connect the right church to the right people; it brought the family much peace.

"It's very important to me," Fuhrman said. "There are wonderful aspects to this job. At the end of the day, we are all here to serve God and everything goes back to glorify Him."

Remembering Coolidge's Wisconsin fishing guide

The United States of America's 250th anniversary prompts historical conversations.

For many, they're about examining the country's Founding Fathers and trailblazers, many of whom are already household names. As a tribal college faculty member who teaches American history, I'm committed to ensuring that Native people are remembered for their contributions to our shared national story.

Being a Wisconsin academic interested in public memory, I believe the 150th anniversary is also worth revisiting for those who call the Badger State their home. In fact, there are interesting parallels between the current occupant of the Oval Office and his 1926 predecessor.

Like President Donald Trump, Calvin Coolidge liked to escape the confines of Washington, D.C., to enjoy recreation during the summer months. Whereas Trump often retreats to the golf course at his Mar-a-Lago Club in Palm Beach, Florida, Coolidge sought five separate "Summer White Houses" while he held the nation's highest office.

They include Plymouth Notch, Vermont, in 1924, Swampscott, Massachusetts, in 1925, and Paul Smiths, New York, in 1926.

Prior to his departure in 1926, Coolidge stated in a mid-June press conference, "I don't go away from Washington for the purpose of avoiding the Washington climate so much as I do for the purpose of getting a change."

I suspect the president's affinity for fishing also contributed to his annual exodus.

In 1927, Coolidge's

love for angling brought him to the Black Hills of South Dakota. That summer not only led to the naming of Grace Coolidge Creek in honor of the first lady, but it also garnered the president's support for the creation of the Mount Rushmore National Memorial.

Yet, it's the summer of 1928 that is likely the most interesting for Wisconsinites and Native historians alike, as Coolidge spent it in Henry Clay Pierce's Cedar Island Lodge along the riverfront of Brule, Wisconsin. In his downtime, the president fished those fruitful waters with Bad River Ojibway tribal member John LaRock as

his guide.

Public records note that LaRock was born in 1873 and that he had received allotments of tribal lands in both 1919 and 1927. LaRock was married with two adopted sons at the time he captained Coolidge's canoe, making the 55-year-old a seasoned, relatable companion to the married president with two sons, who was one year his senior.

Assigned to Coolidge by the state conservation committee, LaRock also "spoke quietly," which likely appealed to the president whose frugality with words led to him being referred to as "Silent Cal."

LaRock emphasized the virtues of his charge's even-keeled demeanor, telling the Associated Press, "Doesn't get excited, not a bit. Good fisherman, President Coolidge."

Wearing "a big cowboy hat and high-heeled boots," Coolidge rode in the front of LaRock's canoe with a second "canoe with three secret service men" joining them on the river.

Using "both worm and fly in his angling," the president "spent many days whipping the waters" to "snare the wily German brown, rainbow and speckled trout." Whether through good fortune or consummate skill, the duo "invariably returned to the lodge with overflowing creels."

LaRock offered to make Coolidge his own canoe for their future expeditions together.

"Soon," LaRock said. "I will have a birch bark canoe ready for the president. He likes the canoe very much and we will use it for the trips when I get it finished."

Perhaps in preparation for the United States' bicentennial, the Wisconsin Historical Society erected a marker titled "Summer White House - 1928" in Brule in 1975. It notes that Coolidge welcomed his successor, Herbert Hoover, to the site on July 16, 1928, making it

the latter's first public appearance after securing the Republican nomination for the presidency. Regrettably, the marker makes no mention of John LaRock.

Just as stories of George Washington's Continental Army's survival at Valley Forge cannot be told without naming the Oneida cook, Polly Cooper, who fed the starving soldiers the white corn she prepared for them, Coolidge's escapades to Wisconsin waters should not be shared without emphasizing the role John LaRock played.

As the Smithsonian undersecretary for museums and culture, Pawnee tribal member Kevin Gover stated, "We get to decide, generation by generation ... what to remember and what to forget."

My fellow Wisconsinites, let's add John LaRock, President Calvin Coolidge and Wisconsin's Summer White House to the stories we share this year. The United States has 250 years' worth of history, and the country is all the richer when it remembers the contributions of Native Americans at every milestone.

Managing powdery mildew on garden, indoor plants

Whether gardening indoors or outdoors, gardeners are likely to encounter powdery mildew on one or more of their plants.

First, a white powdery substance will appear on the surface of leaves, stems and flower petals. As the powdery mildew expands and covers the leaves, it blocks sunlight from reaching the leaves inhibiting photosynthesis. As the disease progresses, it develops structures that enter plant cells to obtain nutrients. It usually is not fatal, but severe infestations can cause plant leaves to yellow, twist and discolor, and the plant may decline.

Several closely related fungi are responsible for the group of diseases called powdery mildew. Different species of powdery mildew fungi attack different plants. If the weather conditions are right and the various fungi are present, gardeners

may find powdery mildew on a variety of plants in their landscape or indoor garden.

Watch for powdery mildew on azaleas, crabapples, dogwoods, lilacs, photinia, roses, coral honeysuckle vines and other trees, shrubs and vines. Check beebalm, dahlias, peonies, phlox, zinnias,

cucumbers, squash and other susceptible plants in gardens. Indoors, especially during the winter, monitor African violets, begonias, ivies, jade and kalanchoes that may develop this disease.

Unlike many fungal diseases, powdery mildew fungi need high humidity, not wet leaves, to develop. Their spores also form in high humidity and are distributed when the humidity is low.

Powdery mildew is more likely to occur on indoor plants growing in low light with poor air circulation and cooler temperatures near 70

degrees. Although the disease is more common in winter, the disease can occur anytime these conditions exist.

Reduce the risk of powdery mildew by keeping plants healthy and avoiding overfertilization. Provide plants with the needed light and other preferred growing conditions. Properly space landscape plants and avoid overcrowding plants, indoors and

out, to provide sufficient light penetration and air circulation.

Water new plantings thoroughly and often enough to keep the roots moist. Gradually reduce the frequency to encourage the plants to develop a robust root system. Continue to water established plants thoroughly as needed during dry weather.

Further decrease the risk of this disease with

a bit of spring thinning on phlox and beebalm. Remove about one-fourth of the phlox and beebalm stems in early spring to allow more air and light to penetrate the plant. This strategy will encourage sturdier stems and discourage disease problems.

Select mildew resistant varieties of these and other plants prone to this disease. Resistant plants are not immune but are

less likely to develop the disease than those that are not.

Practice sanitation by removing infected leaves and plant debris where the fungal spores overwinter. As temperatures rise above 60 degrees, the spores may begin to germinate.

With proper care and sanitation healthy perennials, shrubs and trees, especially those infected late in the growing season, will return the following year. Masking the diseased foliage with a somewhat shorter plant is one way to enjoy the flowers while dealing with the disease. If opting to treat the disease, select the most eco-friendly product, apply it at the first sign of the disease and repeat as directed. As always, read and follow label directions.

Economy performs better under Dems

and grew by 729,000 under Biden. A record of 19 million new business applications were filed under Biden, 70% of which were for small businesses.

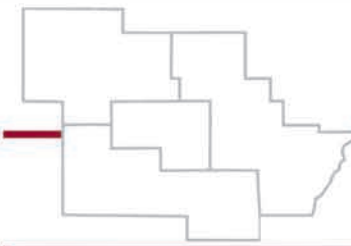

longer accept stray dogs or cats from those that do not contribute, according to the notice. The humane society has set a deadline of Nov. 1 to return contracts.

According to Nowak, municipalities have the statutory responsibility for handling stray animals in their jurisdiction. No formal discussions have taken place with Shawano County about financial support, she said.

“Over the past several years, Shawano County Humane Society has changed dramatically,” Nowak said. “Years ago, the shelter placed approximately 150 animals into homes each year,

and euthanasia rates were significantly higher. Today, our focus is on saving as many healthy and treatable animals as possible. Through expanded medical care, foster programs, behavior support and adoption initiatives, we now find homes for over 1,000 animals annually.”

In total, the humane society found homes for 1,109 animals last year, a mix of stray and surrendered animals. However, during the same year, the humane society only received \$17,335.41 through the state’s statutory apportionment for dog license fees. The rest of the costs have been funded to this point by private

donors, community supporters, businesses and foundations.

“While this transformation has been incredibly positive for the animals and our community, it has also significantly increased the cost of providing care,” Nowak said. “Veterinary treatment, medications, food, staffing, utilities, insurance and other operational expenses have all increased, and we are caring for far more animals than we did in the past.”

The humane society operates at an average cost of about \$57,000 monthly, according to the notice. In 2025, the humane society took in 578 stray dogs and cats, but

only 141 were reclaimed by owners during a five-day hold period. That left the remainder in the care of the humane society, which has to assume responsibility for rehabilitation and medical care.

“These agreements are intended to create a fair and sustainable partnership between the municipalities and the shelter,” Nowak said. “They are not about generating profit; they are about ensuring that stray animals continue to receive quality care while preserving

the long-term ability of the humane society to provide these services.”

The notice reports that the humane society had to shell out \$349,600 to care for stray animals in 2025, coming to about \$800 per stray. Among the expenses were housing and daily care, spaying and neutering, rabies and other core vaccinations, microchipping, any needed medical treatment, emergency veterinary care, adoption preparation and placement, as well as behavioral rehabilitation when needed.

“The proposed agreements were developed after reviewing our actual costs associated with caring for stray animals,” Nowak said. “They are designed to establish a transparent and equitable funding model that reflects the true cost of providing this public service, rather than relying almost entirely on charitable donations to cover expenses that are the responsibility of local governments.”
